1. Description of Plan

The following description of the Active Retirement Community, Inc. d/b/a Jefferson's Ferry Lifecare Retirement Community 403(b) Tax Deferred Investment Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan with 403(b) provisions established effective August 13, 2001, and restated January 1, 2020. The Plan covers all employees of Active Retirement Community, Inc. d/b/a Jefferson's Ferry Lifecare Retirement Community (the Company). There is no age or service requirement for elective deferrals. To be eligible for employer matching and profit sharing contributions, a participant must have attained 18 years of age, completed three months of service and work 1,000 hours during the Plan year. Additionally, the Plan requires a participant to be employed as of year end to be eligible to receive employer contributions. Leased, per diem, independent contractors, members of a collective bargaining unit covered under a collective bargaining agreement, and non-resident aliens are not eligible for purpose of employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees regularly scheduled to perform at least 1,000 hours of service per Plan year are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced target date fund until changed by the participant.

The Company may make matching contributions equal to a percentage of the participant's elective deferrals as determined by the Company, at their sole discretion. The Company may also make discretionary profit sharing

contributions in an amount determined by the Company. For the 2024 Plan year, the Company matched 100 percent of the first 3 percent of base compensation that a participant contributes to the Plan, which totaled \$246,010, net of forfeitures. For the year ended December 31, 2024, the Company also made a profit sharing contribution equal to 3 percent of participants' eligible compensation, which totaled \$351,612, net of forfeitures. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary profit-sharing contributions, if any, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants are 0 percent vested until completion of three years of service at which time they become 100 percent vested. Participants hired prior to January 1, 2013 become 20 percent vested after one year of service, 40 percent after two years of service, and 100 percent after three years of service. Participants also become 100 percent vested upon disability, death or upon attainment of normal retirement age.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, reduced by the highest outstanding note balance of the participant within the previous one-year period. The loans are secured by the balance in the participant's account. The loan interest rate, determined daily, is set at the a rate commensurate with local prevailing rates, as defined. Principal and interest are paid ratably through payroll deductions. The Plan document also allows participants to make direct payments. Terms range up to 5 years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, or for other reasons, a participant may elect

to receive the value of the participant's vested interest in his or her account, as a lump sum, a single sum of a portion of their account, or in substantially equal installments over a fixed period not to exceed the life expectancy of the participant, as provided in the plan document. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed as a lump-sum distribution or rolled over into an Individual Retirement Account if over \$1,000 but less than \$5,000, and participant has not reached normal retirement age. In-service distributions are permitted for participants who are at least 59-1/2 years of age. In addition, the Plan allows for hardship distributions, if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$42,943 and \$33,798, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$42,930, from forfeited nonvested accounts, in accordance with plan provisions.

Recent Regulatory Event

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act of 2022 builds on the SECURE Act of 2019 which revised existing rules around retirement saving. The SECURE 2.0 Act of 2022 contains dozens of new retirement-related provisions with effective dates beginning January 1, 2023 and beyond. SECURE 2.0 is intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers, custodian/trustee and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through August 20, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: The Prudential Principal Preservation Separate Account (PPSA) held by the Plan is a stable value product that invests in a broadly diversified portfolio of fixed income instruments primarily in intermediate-term bonds, private placements, and commercial mortgages. The fund is valued at fair value using the NAV as a readily determinable fair value. The Prudential PPSA has a NAV that is considered published and therefore is classified as level 2. Due to the nature of this account, there are no unfunded commitments or redemption restrictions.

5. Related-Party and Party In Interest Transactions

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Hand Benefits & Trust Company is the custodian of the Plan. Benefit Plans Administrative Services, LLC, d/b/a Benefit Plans Administrators (BPA), an affiliate of Hand Benefits & Trust Company, provides certain recordkeeping services to the Plan pursuant a service agreement with the Company. Hand Benefits & Trust Company and BPA receive revenue from investment fund service providers for services they provide to the funds. This revenue is used to offset certain amounts owed to Hand Benefits & Trust Company and BPA for its administrative services to the Plan. If the revenue received by Hand Benefits & Trust Company and BPA from such investment fund service providers exceeds the amount owed for their services, the excess is remitted to the Plan's trust on a quarterly basis.

The Plan or Plan Sponsor may make a payment to these service providers for administrative expenses not covered by revenue sharing. During 2024, direct payments made by the Plan for service provider fees totaled \$33,350, and are included in administrative expenses. These transactions qualify as exempt party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as exempt party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan administrator believes the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and, therefore, believes the Plan is qualified.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan

has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
