## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Digital Media Solutions 401(k) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Digital Media Solutions 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Opinion

**1. Description of Plan**

The following description of the Digital Media Solutions 401(k) Retirement Plan (the “Plan”) provides only general information. The Plan was originally effective January 1, 2009, and was most recently amended and restated effective January 1, 2022. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Digital Media Solutions, LLC (the “Company”) or any affiliate who has adopted the Plan. Employees who are covered by a collective bargaining agreement, or who are a non-resident alien with no US source income are not eligible to participate in the Plan. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year, participants may contribute up to 100 percent of their pretax annual compensation, as defined in the Plan document, provided that in no event shall a participant elect to contribute more than the maximum allowed by law. Participants may also elect to make contributions to the Plan on an after-tax basis (voluntary contributions). Contributions may also be designated as Roth 401(k) contributions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Plan provides for a safe harbor matching contribution. The employer will contribute a safe harbor matching contribution in an amount equal to: (i) 100% of the employee contributions that are not in excess of 3% of the participant’s compensation, plus (ii) 50% of the amount of the employee contributions that exceed 3% of the participant’s compensation but that do not exceed 5% of the participant’s compensation.

Employees are eligible for elective deferral contributions and voluntary contributions and receive safe harbor matching contributions on the first day of the calendar month, coincident with or next following the date the employee attains age 21, and completes 380 hours of service in a 2-month period. If the service requirement is not met in the first consecutive period of months, an employee is also eligible for the Plan if one year of eligibility service is completed.

The employer may, in its sole discretion, make a discretionary profit sharing contribution to the Plan on the employee’s behalf. The discretionary profit sharing contribution is to be made under a participant group allocation method to employee groups in accordance with the Plan document. To be eligible to receive an allocation, the employee must have completed at least 1,000 hours of service during the Plan Year and be employed by the employer on the last day of the Plan year. Profit sharing contributions are allocated to the profit sharing contribution accounts of each participant eligible to share in such allocations after the end of the Plan year. Such contributions are allocated in an amount designated by the employer to be allocated to each eligible participant. No profit sharing contribution was declared by the Company for the year ended December 31, 2024.

**Participant Accounts**

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, and safe harbor matching contributions as well as allocations of discretionary profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. A participant’s account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts at a maximum amount equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past 12 months, or 50 percent of their vested account balances. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions. Loan terms shall not extend beyond five years from the date of the loan, unless the loan is for the purchase of a participant’s primary residence. A participant may have only one loan outstanding at any given time. Loan fees may be charged against the account of the participant to whom the loan is granted.

**Vesting**

A participant, at all times, is fully (100%) vested in their elective deferrals, voluntary contributions, rollover contributions, in-plan Roth rollovers, qualified non-elective contributions, and safe harbor matching contributions accounts.

Employee interest in the profit sharing contribution account will vest based on years of vesting service in accordance with the following schedule:

Prior to 2016, the Plan had a matching contribution which vested at 20% per year of service starting after two years and fully vested after six years. For vesting service, notwithstanding the above vesting schedule, a participant will become 100% vested in these accounts upon their attainment of normal retirement age (65), or death while an employee.

**Forfeited Accounts**

Forfeitures are generally used to reduce administrative expenses, restore forfeited account balances of rehires eligible for a restoration of forfeitures, or to reduce employer contributions. Total unallocated forfeiture account balances were \$0 and \$10,236 at December 31, 2024 and 2023, respectively. During 2024, forfeitures of \$13,207 were used to offset the safe harbor matching contributions, and forfeitures of \$0 were used to pay administrative expenses.

**Payment of Benefits**

On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant’s vested interest in his or her account. If a distribution is not requested and the balance is between \$1,000 and \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022, “SECURE Act 2.0”), the account balance will be transferred by the Plan administrator to an individual retirement account established on behalf of the participant. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant’s vested account balance shall be distributed in a lump sum. Hardship and in-service distributions are also permitted from participant accounts, based on the terms of the Plan document.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gain and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Discretionary profit sharing contributions from the Company, if any, are recorded in the year in which the related compensation is earned.

**Payments of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Administrative Expenses**

All reasonable administrative expenses, including custodial and third party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

**Subsequent Events**

Management evaluated subsequent events for the Plan through August 26, 2025, the date the financial statements were available to be issued.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by John Hancock Life Insurance Company of New York, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, cash and notes receivable from participants as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, other income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all pooled separate accounts and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024 as shown in the ERISA-required supplemental schedule.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Pooled separate accounts are valued at the net asset value ("NAV") or equivalent based on units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a pooled separate account, the custodian reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. The NAV is based on the market prices of the underlying investments in the accounts at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future returns. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. All investments of the Plan are valued using the net asset value per share practical expedient.

The following table sets forth additional disclosures for the fair value measurement of investments in certain entities that calculate net asset value per share (or its equivalent) as of December 31, 2024 and 2023.

The Plan's pooled separate accounts are invested in a variety of funds designed to mirror the investment strategies of similar registered investment companies (mutual funds), including equity style funds, fixed income style funds, and blended funds. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a pooled separate account, the custodian reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

**5. Related Party and Party-In-Interest Transactions**

Plan investments include pooled separate accounts managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company of New York serves as custodian of the Plan. Therefore, transactions in these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan for custodian services were \$8,219 for the year ended December 31, 2024. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance.

John Hancock Life Insurance Company of New York or its affiliates generate income to the Plan through revenue sharing agreements. More specifically, John Hancock Life Insurance Company of New York or its affiliates may receive revenue from pooled separate accounts service providers for services John Hancock Life Insurance Company of New York or its affiliates provide to the pooled separate accounts. This revenue may be used to offset certain amounts owed to John Hancock Life Insurance Company of New York or its affiliates for administrative services to the Plan. If the revenue received by John Hancock Life Insurance Company of New York or its affiliates from such pooled separate accounts service providers exceeds the amount owed as agreed to by John Hancock Life Insurance Company of New York and the Plan for administrative services, John Hancock Life Insurance Company of New York or its affiliates is to remit the excess to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the years ended December 31, 2024, the related amounts deposited into the Plan and allocated directly to participant accounts was \$7,822. The Plan or Plan Sponsor may make a payment to John Hancock Life Insurance Company of New York or its affiliates for administrative expenses not covered by revenue sharing.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in any employer contributions accounts for which they were not already vested.

**7. Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**8. Tax Status**

Effective January 1, 2022, the Plan was amended and restated by adopting a CCH Incorporated, DBA ftwilliam.com pre-approved plan. The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020, stating that the pre-approved plan document as then designed was in accordance with applicable Internal Revenue Code ("IRC") requirements. Although the Plan has been amended since receiving the opinion letter, management of the

Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
