Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Samsons Manufacturing Company, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of the Samsons Manufacturing Company, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more comprehensive description of the Plan's provisions.

1. *General and Eligibility.* The Plan is a defined-contribution plan covering all bargaining unit employees of Samsons Manufacturing Company, Inc. (the "Sponsor") who have completed one year of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act ("ERISA"), as amended. The Plan's trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.
2. *Contributions.* Eligible employees can contribute an amount up to 100% of their eligible compensation, subject to limitations set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan permits for both pre-tax and Roth contributions. The Plan's sponsor may elect to make a matching contribution equal to a percentage of the amount the participant elects to contribute to the Plan. Sponsor matching contributions are invested in the same manner as the participant's contributions. The Sponsor matched 100% of contributions up to 5% of compensation for the year ended December 31, 2024.
3. *Participant accounts.* Each participant's account is credited with the participant's contributions, an allocation of the Sponsor's matching contribution, an allocation of plan earnings, and charged with an allocation of administrative expenses. Plan earnings and administrative expenses are allocated based on participant earnings, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Vesting.* Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's matching contribution portion of their accounts plus actual earnings thereon is graduated based on years of continuous service. A participant is 100% vested in Sponsor contributions to the Plan and earnings thereon after three years of credited service, death, disability or retirement. The vesting schedule for the Sponsor's matching contributions in the Plan is based on a three-year cliff.
5. *Investment Options.* Participants may direct the investment of the amount in their account into investment options offered by Mid Atlantic Trust Company ("Mid Atlantic"), the Custodian of the Plan. In April 2023, Mid Atlantic rebranded to do business as American Trust Custody ("American Trust"). American Trust offers thirty funds and one common/collective trust.

6. *Payment of benefits.* If the vested portion in the participant's account is more than \$5,000, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period. If the participant's vested benefit in the plan does not exceed \$5,000, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, a participant can withdraw contributions under certain hardship conditions. The Plan does not permit loans to participants. In-service withdrawals are allowed on attainment of age 59 ½.
7. *Forfeitures.* Forfeited balances of terminated participants' nonvested accounts are used to reduce future Sponsor contributions. Forfeiture balances totaled approximately \$4,000 and \$9,000 as of December 31, 2024 and 2023, respectively. The Plan expects to utilize the full balance of the forfeited nonvested accounts in 2025 to offset employer contributions.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 2 - Summary of Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expense

Substantially all expenses related to the administration of the Plan and the management of plan assets are borne by the Sponsor and are not included in the statement of changes in net assets available for benefits. Investment-related expenses are included in net appreciation/depreciation in fair value of investments.

Reclassifications

Certain amounts in the prior period financial statements have been reclassified, where appropriate for comparative purposes, to conform to the current-year presentation.

Subsequent Events

The Plan has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, "Fair Value Measurements and Disclosures" establishes a framework for measuring fair value. The framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The hierarchy consists of three broad levels:

Level 1 - Quoted prices in active markets for identical assets. This level has the highest priority.

Level 2 - Quoted prices for similar assets in active markets, quoted prices for identical or similar assets not traded in active markets and other observable inputs.

Level 3 - Prices or valuations that are unobservable. This level has the lowest priority.

Note 5 - Related Party Transactions and Party in Interest Transactions

Fees incurred by the Plan for investment management services are included in net appreciation/depreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. The Plan paid certain expenses related to the operations and investment activity to various service providers. These transactions are party-in-interest transactions. The plan sponsor pays directly any other fees related to the Plan's operations.

The Sponsor absorbs certain costs of administering the Plan principally consisting of professional fees and limited costs of the Sponsor's personnel involved in administrative matters of the Plan and are excluded from these financial statements.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participants' accounts and distributed in such a manner as the Sponsor may determine.

Note 7- Tax Status

The Internal Revenue Service (“IRS”) has issued an opinion letter dated June 30, 2020, that the form of the plan prototype that the Sponsor has adopted as the Plan is acceptable under section 401 of Internal Revenue Code (“IRC”). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
