INDEPENDENT AUDITOR'S REPORT

To the Fiduciary Committee and participants of the
Cleveland Group, Inc. and Subsidiaries 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Cleveland Group, Inc. and Subsidiaries 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Cleveland Group, Inc. and Subsidiaries 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Cleveland Group, Inc. and its subsidiaries (collectively, the Company). All employees except those employees who are members of a collective bargaining agreement, nonresident aliens, temporary employees, or residents of Puerto Rico are eligible to participate in the Plan. Employees are eligible to enroll in the Plan on their date of hire. Certain part-time employees are eligible to participate in the Plan upon completion of 1,000 hours of service during a Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective January 2, 2025 to allow for the Company to make safe-harbor matching contributions of 100% of participant deferrals for the first 3% of eligible compensation and 50% of participant deferrals for the next 2% of eligible compensation.

Contributions

Each participant may make pre-tax and/or Roth contributions of up to 100% of their eligible compensation, as defined by the Plan, not to exceed to a maximum of \$23,000 in 2024, plus an additional \$7,500 catch-up deferral for participants age 50 and older. All eligible employees are automatically enrolled in the Plan at a rate of 3% unless they specifically opt out or change their contribution rate. The contributions will be invested in the T. Rowe Price Retirement Fund with the target date closest to the year in which the participant turns 65 unless elected otherwise. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

At the discretion of the Board of Directors, the Company may make discretionary matching contributions or discretionary profit sharing contributions to the Plan. In 2024, the Company elected to match 25% of the participant's elective deferrals. The Company did not make any discretionary profit sharing contributions during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings or losses on the investments in their account, and is charged with transaction fees for services received by the participant and certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the

investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are 20% vested in Company contributions after the first two years of credited service, then 20% each year thereafter, and are fully vested after six years of credited service. If employment ends due to retirement on or after the normal retirement age of 65, or because of death or disability, participants will be fully vested in their accounts.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$52,934 and \$39,885, respectively. These accounts may be used to pay Plan expenses, allocated to participant accounts pro-rata based on participant contributions, or used to offset the Company's contribution obligation, as defined in the Plan document. During 2024, no forfeitures were used to pay administrative expenses, allocated to participant accounts, or used to offset the Company's contribution obligation.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear an interest rate equal to the Prime rate plus 1%. During 2024, loans had fixed rates ranging from 4.25% to 9.50% for the term of the loan, not to exceed 5 years or 15 years if used for the purchase of a residence. Principal and interest are paid through payroll deductions or by other means as specified in the participant's loan agreement. During 2024, there were no deemed distributions of loans.

Payment of Benefits

At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may elect to receive a payment of the vested interest in their account in a lump-sum distribution, installment payments, or annuities. The participant's vested account may also be withdrawn for in-service distributions upon reaching age 59½ or for certain hardship situations. If a participant terminated employment and had an account balance less than \$7,000, the participant would automatically receive a lump sum payment equal to the value of their vested account balance. Participants are limited to one hardship withdrawal per calendar year and a minimum amount for all hardship withdrawals of \$1,000.

Administrative Expenses

Transaction fees related to loans and distributions are charged directly to the participant that initiated the transaction. These fees are paid to a service provider, and therefore qualify as party-in-interest transactions. The Plan has an administrative budget account, where the third-party administrator deposits revenue sharing payments into the account on a quarterly basis. The balance may be used to pay for fees and expenses associated with services related to the Plan or to pay vendors. For 2024, the third-party administrator deposited \$35,213 and the Plan used \$0 to pay administrative fees related to the Plan. The account had investment earnings of \$1,346. Deposits to this account are included in net change in fair value of investments on the accompanying statement of changes in net assets available for benefits. Payments from the account are included in administrative expenses when paid. At December 31, 2024 and 2023, the balance in the administrative budget account was \$45,192 and \$8,633, respectively. All other administrative expenses are paid by the Company. The Company does not expect reimbursement from the Plan for these expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company's discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and approved by the Board of Directors. The Company's discretionary profit sharing contributions are payable to the Plan after approval by the Board of Directors. Any unfunded participant or employer discretionary matching contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Distributions to participants are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 4, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company (T. Rowe Price), the Plan's qualified institution.

4. Investments

Plan investments include mutual funds and a stable value fund managed by T. Rowe Price, a service provider for the Plan. Transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, etc. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1) that the Plan has the ability to access.

The Plan invests in a stable value fund held in a common collective trust. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades at the net asset value (NAV) which is based on the contract value of the underlying investments (Level 1).

The stable value fund includes certain redemption restrictions. If the Plan chooses to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

The Plan also invests in a fund held within a common collective trust. Fair value of the common collective trust is determined by prices published daily by the trust manager, which is the NAV of the common collective trust (Level 1). Net asset value is determined by the fair value of the mutual funds, stocks, and other securities in the common collective trust. Participants can trade the common collective trust daily at the published NAV.

5. Income Tax Status

The Plan uses a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA (pre-approved plan) sponsored by T. Rowe Price Retirement Plan Services, Inc. (TRPRS and an affiliate of the qualified institution). The Internal Revenue Service has determined and informed TRPRS by a letter dated August 19, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
