Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the Hannis T. Bourgeois, LLP Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Hannis T. Bourgeois, LLP Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated September 27, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Hannis T. Bourgeois, LLP Profit Sharing Plan and Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General:

The Plan is a defined contribution plan covering substantially all employees of Hannis T. Bourgeois, LLP (“HTB”) who have attained age 21 and completed 30 days of service. Employees who have completed 12 months with 1,000 hours of service are eligible for discretionary matching and profit-sharing employer contributions. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s trustee is Reliance Trust Company (“Reliance”).

Contributions:

Participants may elect to contribute a percentage of their eligible compensation as pre-tax traditional or after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. HTB’s Executive Committee determines the discretionary matching and profit-sharing contributions, if any, each year. During the year ended December 31, 2024, HTB made profit-sharing contributions of 3% of each participant’s compensation. Contributions are subject to certain limitations.

Participant Accounts:

Each participant’s account is credited with the participant’s contribution, HTB’s contribution and allocations of Plan earnings, and charged with withdrawals and allocations of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting:

Participants are 100% vested in the balances of their voluntary contributions plus actual earnings thereon. Vesting in the discretionary matching and profit-sharing employer contributions is based on years of continuous service. A participant is 100% vested after three years of credited service.

Forfeited Accounts:

Forfeitures of participants’ nonvested accounts may be used to pay Plan expenses or reduce HTB’s contributions, or they may be allocated to participants as additional profit-sharing contributions. During the year ended December 31, 2024, forfeitures of \$750 were used to pay Plan expenses, and forfeitures of \$13,458 were used to reduce HTB’s contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$26,245 and \$14,484, respectively. The forfeiture balance as of December 31, 2024, includes uncashed distributions of \$23,349 which management intends to distribute during plan year 2025.

Payment of Benefits:

Distributions to the participants or beneficiaries take place upon the employee's separation of service, retirement, disability, or death, or upon attainment of age 59½. Distributions equal to the value of the participant's vested interest in his or her account will be made in a lump-sum amount, in installment payments, or rolled over into another qualified retirement plan. A participant may request a distribution from his/her rollover contribution account at any time. A participant may also request a distribution from his/her elective deferral account in case of hardship as detailed in the Plan provisions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions:

Contributions from Plan participants and the contributions from the employer are recorded in the year in which the employees contributions are withheld from compensation.

Excess Contributions Payable:

Amounts payable for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction in contributions. Excess contributions are refunded the following year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Administrative expenses are paid by the Plan or HTB as provided in the Plan document. Substantially all administrative expenses are paid from the fees deducted from investment earnings by the investment manager. If the fees deducted from investment earnings exceed the Plan's administrative expenses, the excess amount is allocated to participants and is recorded as other income.

Subsequent Events:

The Plan has evaluated subsequent events through August 25, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, defines fair value, establishes a framework for measuring fair value, and requires disclosures about fair value measurements. The guidance establishes a fair value hierarchy about the assumptions used to measure fair value and clarifies assumptions about risk and the effect of a restriction on the sale or use of an asset.

ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. Three levels of inputs may be used to measure fair value:

Level 1: Quoted prices (unadjusted) or identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, and other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect a plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)

The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for financial instruments measured at fair value:

Mutual funds: Valued at the quoted net asset value ("NAV") of shares held by the Plan at year-end.

Pooled separate account: Valued at the NAV as determined by the investment manager. The NAV is used as a practical expedient to estimate fair value. Participant transactions may occur daily at the reported NAV, with no advance notice requirements.

The pooled separate account is not categorized within the fair value hierarchy.

The following tables present the financial instruments carried at fair value as of December 31, 2024 and 2023:

NOTE 4 - INCOME TAX STATUS

The Plan uses a pre-approved plan document provided by CCH Incorporated, DBA ftwilliam.com. CCH Incorporated, DBA ftwilliam.com received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The Plan itself has not received a determination letter from the IRS. The pre-approved plan document has been amended since receiving the opinion letter; however, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, HTB has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are held in a pooled separate account managed by Transamerica Life Insurance Company (“Transamerica”). Transamerica Retirement Solutions Corporation, an affiliate of Transamerica, is the recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest transactions. The fair value of investments managed by Transamerica at December 31, 2024 and 2023, totaled \$507,927 and \$1,989,561, respectively.

NOTE 7 - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
