### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements*

We have performed an audit of the accompanying financial statements of TOGETHERWORK 401(K) PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of TOGETHERWORK 401(K) PLAN'S 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### *Opinion on the 2024 Financial Statements*

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above relates to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the 2024 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of TOGETHERWORK 401(K) PLAN and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the 2024 Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about TOGETHERWORK 401(K) PLAN'S ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Togetherwork 401(k) Plan is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan, sponsored by Togetherwork Operations, LLC and its subsidiaries (collectively, the "Plan Sponsor"), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was originally adopted on January 1, 1999 and has been amended and restated since that date. The Plan was restated effective January 1, 2021 to reflect the amendments in 2020 and implement a safe harbor employer matching contribution. The Plan was amended effective August 1, 2023 to allow participant loans.

On June 6, 2023, the Plan Sponsor acquired the assets of 2Book, Inc. ("2Book"). In connection with the acquisition, the Plan Sponsor became the employer of 2Book employees, who were covered under the 2Book 401(k) Plan until its termination on the date of acquisition. As of August 11, 2023, eligible 2Book employees have the option to enroll into the Plan.

On October 25, 2024, the Plan was amended to include all pre-acquisition service with a division of a company that is acquired by Togetherwork Holdings, LLC or one of its subsidiaries will be counted for eligibility purposes, but only if Employee was actively employed by the acquired company on the date of acquisition.

The 401(k) Committee has responsibility for the administration of the Plan. Fred Maglione, CEO of Omega Financial, Inc., as trustee, had responsibility for the management, operation and administration of the Trust through March 1, 2023, at which date Damon E. Schramm, In-House General Counsel, became the trustee of the Plan. Voya Retirement Insurance and Annuity Company ("VRIAC"), as a qualified institution, is the Plan's custodian and recordkeeper. Retirement Benefit Solutions, LLC ("RBS") is the third-party administrator of the Plan. Fees are charged by the third-party administrator and custodian/recordkeeper for services rendered.

The Plan covers all eligible employees of the Plan Sponsor who have completed three months of service and are age twenty-one or older except for the following ineligible classes of employees: (a) employees whose employment is governed by a collective bargaining agreement in which retirement benefits were the subject of good faith bargaining; (b) anyone who is a leased employee; (c) employees who are non-resident aliens who received no income from services performed in the United States; and (d) employees who are hired on a temporary basis.

*Contributions*

Participants may elect to contribute up to 100% of their eligible compensation subject to limitations established by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollover). Participants direct the investment of their contribution into various investment options offered by the Plan.

The Plan also allows the Plan Sponsor to make safe harbor matching contributions, matching contributions, non-elective contributions which are discretionary in timing and amount, and qualified non-elective contributions. During the years ended December 31, 2024 and 2023 the Plan Sponsor made a safe harbor matching contribution equal to 100% of the participants' salary deferrals up to 4% of compensation. There were no other employer contributions during the years ended December 31, 2024 and 2023.

*Participant Accounts*

Each participant's account is credited with the participant's deferral contributions, rollovers, the Plan Sponsor's matching contributions, and a proportionate interest in the investment earnings or losses of the funds which the contributions are invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balance, or specific participant transactions, as defined. Participants may direct employee contributions to any of the Plan's investment alternatives and may transfer among investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are vested immediately in their contributions, the Plan Sponsor's safe harbor contributions, qualified non-elective contributions, and their rollover contributions plus actual earnings thereon. With the exception of participant accounts that were transferred into the Plan from Protech Associates, Inc. 401(k) Retirement Savings Plan and the Accepted 401(k) Plan as a result of 2022 plan mergers, vesting in the employer matching and non-elective contributions is based on years of service with 100% vesting occurring after six years of credited service.

For participants whose balances include prior employer discretionary matching and profit sharing contributions originating from the Protech Associates, Inc. 401(k) Retirement Savings Plan and the Accepted 401(k) Plan prior to plan mergers, vesting follows a schedule that differs from above in accordance with prior plan provisions. Refer to the related plan document for further details.

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,218 and \$41,853, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. In 2024 and 2023, administrative expenses were reduced by \$76,324 and \$32,225, respectively, from forfeited nonvested accounts.

*Notes Receivable From Participants*

Until August 1, 2023, the Plan did not provide for participant loans; however, balances of notes receivable from participants ("Notes") have previously been transferred into the Plan from merged plans under the existing terms of the Notes. Beginning August 1, 2023, Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates of 4.00% to 10.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent Notes may be reclassified as distributions based upon the terms of the related Plan Document.

*Payment of Benefits*

On termination of service, death, disability, or retirement, the participant or their beneficiary may elect to receive a lump-sum or partial distribution of the participant's vested interest in his or her account. Participants may request a withdrawal of a portion of their employee contribution account balance if they can demonstrate financial hardship as defined by the Plan.

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes realized and unrealized changes in fair value of investments bought, sold, and held during the year.

*Benefit Payments*

Benefit payments are recorded when paid.

*Plan Expenses*

The Plan's administrative expenses are paid by either the Plan or the Plan Sponsor as provided by the Plan document, except for certain account activity charges which are paid from the accounts of the participants that incurred the charge. Investment management fees and 12B-1 distribution fees are paid by the Plan in the form of reductions of net investment income earned by Plan participants.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Separate account assets:* Participant contributions are held in a separate account, which purchases shares of mutual funds. Earnings of the underlying funds are factored into the unit value of the separate account assets. The value of a share of a separate account asset is equal to the net assets of the underlying fund divided by the number of shares outstanding. The fair value of the separate account is measured using the net asset value per share as a practical expedient, which is derived principally from observable market data.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan has a benefit-responsive group annuity contract with Voya Retirement Insurance and Annuity Company ("VRIAC"). The Voya Fixed Account is a fixed interest option available under the investment contract. The Voya Fixed Account is an obligation of VRIAC's general account which supports all VRIAC's insurance and annuity commitments. All guarantees are based on the financial strength and claims-paying ability of VRIAC. The Voya Fixed Account guarantees principal and a guaranteed minimum interest rate for the life of the contract.

Because the group annuity contract is fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with VRIAC, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. There are no unfunded commitments. The contract value, which approximated fair value of the investment contract at December 31, 2024 and 2023, was \$1,852,643 and \$1,913,820, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan's management believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

In addition, certain events allow the issuer to terminate the contract with the plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5 - RELATED-PARTY TRANSACTIONS

Plan investments are managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the custodian as defined by the plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the plan for investment management services are included in net investment income.

Voya provides select administrative services to the Plan pursuant to service agreements between the Plan Sponsor and Voya. A portion of Voya's fee is paid from certain investment fund revenue. The Plan shares in this revenue when the revenue exceeds the amount due to Voya under the service agreements. The revenue received by the Plan under this arrangement is used to reduce the expenses of administering the Plan or allocated to participant accounts. The Plan or Plan Sponsor may make payments to Voya for administrative expenses not covered by the revenue sharing amounts. The Plan received approximately \$28,724 and \$22,900 during December 31, 2024 and 2023, respectively. A portion of the revenue was used to pay Plan expenses. The balance remaining in the account as of December 31, 2024 and 2023 was \$15,909 and \$20,270, respectively. The balance is included in investments in the accompanying Statements of Net Assets Available for Benefits.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

NOTE 7 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

All investment information and transactions included in those assets in the accompanying financial statements and supplemental schedule at December 31, 2024 and 2023 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the Plan's custodian.

NOTE 8 - TAX STATUS

The Plan has adopted a preapproved Profit Sharing Plan with CODA and the Internal Revenue Service has determined on June 30, 2020, that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
