Report of Independent Auditors

To the Administrator of Willkie Farr & Gallagher LLP Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Willkie Farr & Gallagher LLP Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the years then ended, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.



Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

As discussed in Note 2 to the financial statements, the financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

(Modified Cash Basis)

December 31, 2024 and 2023

1. Description of the Plan

The following description of the Willkie Farr & Gallagher LLP Retirement Savings Plan (the “Plan”), sponsored by Willkie Farr & Gallagher LLP (the “Firm”), provides only general information. Refer to the Plan document for the complete provisions of the Plan.

General

The Plan is a tax-deferred savings plan which is intended to comply with the provisions of Section 401(a) and other applicable provisions of the Internal Revenue Code of 1986, as amended (the “IRC”).

The trustee of the Plan was Fidelity Management Trust Company (“Fidelity” or the “Trustee”) for the years ended December 31, 2024 and 2023. The Trustee is responsible for all recordkeeping and investment services with respect to the Plan. The Firm’s Chief Operating Officer serves as the Plan Administrator.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is a “participant directed plan” as described in Section 404(c) of ERISA, under which participants are responsible for directing the investment of their accounts among the investment options offered under the Plan.

Investment Options

Participants are responsible for investing their account among the Plan’s available investment options. In addition to the standard investment options offered, the Plan offers a self-directed brokerage feature, referred to as BrokerageLink, which allows participants to invest part or all of their account in a wide range of public mutual and money market funds other than those offered as standard investment options under the Plan.

Participation

All partners and employees of the Firm (except non-U.S. citizens employed in an overseas office who receive no U.S. compensation; employees who are U.S. citizens hired in, and working primarily for, an overseas office; income partners whose principal job responsibilities are performed on a regular basis outside of the U.S., and National Partners) who have completed one month of credited service are eligible to make salary deferral 401(k) contributions to the Plan (“Employee Contributions”).

All partners, included counsel and certain employees of the Firm (except associates; non-U.S. citizens employed in an overseas office who receive no U.S. compensation; employees who are U.S. citizens hired in, and working primarily for, an overseas office; income partners whose principal job responsibilities are performed on a regular basis outside of the U.S., and National Partners) who have completed one year of credited service may be eligible to receive an annual year-end contribution made by the Firm (“Firm Contributions”).

Payment of Benefits

Benefits provided by the Plan are paid by the Trustee from the net assets available for benefits. The benefit to which a participant is entitled is the benefit that can be provided by the contributions and income (or loss) allocated to such participant’s account. Upon termination (for any reason) or death, the participant (or beneficiary in the event of the participant’s death) may elect to receive a lump-sum amount equal to the value of the funds in his or her account. A participant or spousal beneficiary may choose to receive installment distributions to satisfy the minimum distribution requirements if required to receive such distributions.

Vesting

All Employee Contributions and earnings thereon are fully and immediately vested. All Firm Contributions are subject to a vesting requirement of three years of credited service.

Forfeitures

At the discretion of the Plan Administrator, forfeitures may be utilized to: (i) restore the accounts of reemployed participants, (ii) restore the accounts of missing participants, (iii) fund Firm Contributions, (iv) fund corrective contributions relating to operational Plan defects, if any, or (v) pay Plan administrative expenses. In 2024 and 2023, forfeitures were \$96,188 and \$70,088, respectively.

Contributions

Each participant may elect to have tax-deferred savings and/or Roth 401(k) contributions deducted for each pay period of up to 50% of earnings, to a maximum allowable amount as determined by Section 402(g) of the IRC. Contribution limits were \$23,000 and \$22,500 in 2024 and 2023, respectively. Participants who were at least 50 years old at December 31, 2024 and 2023, and who contributed the maximum amount of elective deferrals for the year were eligible to make an additional contribution of \$7,500 in 2024 and 2023. Employee Contributions received by the Plan are credited to the individual participant's account.

The Plan has an auto-enrollment contribution rate of 6%. Participants receive 90 days' notice prior to the commencement of auto-enrollment contributions and may opt out of auto-enrollment prior to commencing contributions.

The Plan provides for all participants who are eligible for Firm Contributions and who have completed one or more years of credited service, other than partners, included counsel and designated officers of the Firm, to receive a Firm Contribution equal to 7.5% of annual earnings up to the Social Security taxable wage base (the "Wage Base") of \$168,600 and \$160,200 in 2024 and 2023, respectively, and 11% of any earnings in excess of the Wage Base, subject to maximum earnings of \$345,000 and \$330,000 in 2024 and 2023, respectively. The Plan provides for a minimum annual contribution of \$3,000 for each staff employee who is entitled to a contribution for such year.

The Plan provides that the Firm's annual contribution for 2024 and 2023 for all participants eligible for Firm Contributions and who are partners, included counsel and designated officers of the Firm with one or more years of credited service, shall be such amount as is determined by the Firm subject to the applicable limits of the Plan and the IRC. The contribution limits for each partner and certain designated officers were \$46,000 and \$43,500 in 2024 and 2023, respectively. The annual contribution for each counsel included in the Plan was \$10,000 in 2024 and 2023.

Firm Contributions are allocated to the individual participants' accounts as of December 31 of each year.

The Fidelity Freedom Index Funds are the default fund with respect to all contributions for which no investment election has been made, as determined by the Plan Administrator.

Rollover Contributions

Participants may elect to roll over funds invested in other qualified plans with the consent of the Plan Administrator. Benefit payments of \$1,746,838 from the Willkie Farr & Gallagher LLP Partner Pension Plan were rolled into the Plan during 2023.

Notes Receivable From Participants

Participants who are actively employed by the Firm may be eligible to borrow from their Plan accounts. The maximum amount of a loan is the lesser of \$50,000 or 50% of the vested account balance (excluding the Defined Contribution Account). The minimum amount of any loan is \$1,000. A participant may have two loans outstanding at any time, but only one such loan may qualify as a primary residence loan. The minimum loan period is one year and the maximum is five years. However, if the loan is for the purchase of the participant's primary residence, the maximum period is ten years.

Loans are repaid through payroll deductions. Prepayment of the entire unpaid amount at any time is allowed. If employment is terminated, participants have the option of paying off the loan or continuing loan payments on a monthly basis in order to avoid defaulting on the loan.

The interest rate charged on loans is determined by the Firm's Benefits/Investment Committee, and is commensurate with the prevailing interest rate charged by institutions in the business of lending money. The interest rate on loans is the prime rate plus 1% for the years ended December 31, 2024 and 2023. Loans are collateralized by participant account balances.

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based on the terms of the Plan document.

Plan Termination

While the Firm intends to continue the Plan, it reserves the right to terminate it at any time for any reason. In the event there is a discontinuance of the Plan, all Plan accounts will be fully vested and the assets of the Plan, after payment of any expenses properly chargeable against the Plan, will be distributed to the participants as prescribed by the Plan in accordance with ERISA and related regulations.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's policy is to prepare its financial statements on a modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. The modified cash basis of accounting followed by the Plan records all transactions based on cash receipts and disbursements, except for investments, notes receivable from participants, investment activity and transfers between plans.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the current economic environment, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' individual account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

Use of Estimates

The preparation of the Plan's financial statements in conformity with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The most significant estimates include the fair value of investments.

Investments

Accounting Standards Codification Topic 820 ("ASC 820"), *Fair Value Measurements and Disclosure*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used:

- Mutual funds are valued at the net asset value ("NAV") of shares held by the Plan at year end, based on the daily closing price as reported by the funds.
- The stable value common collective trust (Fidelity Managed Income Portfolio II) is valued on the basis of the relative interest of each participating investor in the fair value of the underlying assets. The underlying assets are valued based on the NAV as provided by the Trustee. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not

used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The Plan's stable value common collective trust contains fully benefit responsive investment contracts ("FBRICs") which are valued at contract value. As the Plan's investment in FBRICs is indirect through a common collective trust, the contract value of the indirect investment is understood to be the fair value of the investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Audit and certain other professional service fees related to maintaining the Plan are paid by the Firm. Participants are charged a quarterly record keeping fee of \$15 which is deducted from their accounts. Such fee may be offset by any revenue credits generated by the Plan's investment options, which are allocated on a pro-rata basis to the accounts of those participants who invest in those investment options based on the ratio of each participant's average daily balance in such option during the applicable calendar quarter to the total average daily balances of all participants in such option during the quarter. Other administrative fees such as loan maintenance and processing fees are deducted from the individual participant's account balance when paid.

3. Tax Status of the Plan

The Internal Revenue Service ("IRS") has determined and informed the Firm by a letter dated October 27, 2015, that the Plan and the related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021 for which the statute of limitations has passed.

4. Investments and Investment Income

Investment income includes interest, dividends and net realized and unrealized appreciation or depreciation in the fair value of investments. Purchases and sales of securities are recorded on a trade date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded when earned.

The Plan presents in the Statements of Changes in Net Assets Available for Benefits the net appreciation in the fair value of its investments that consists of the realized gains (losses) and the unrealized appreciation on those investments.

5. Certification by the Trustee

In accordance with 29 CFR 2520.103-5 and 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Trustee has certified that the following information per the Statements of Net Assets Available for Benefits, as of December 31, 2024 and 2023, and the Statements of Changes in Net Assets Available for Benefits for the years then ended is complete and accurate: investments, at fair value; notes receivable from participants; investment income from interest and dividends and net appreciation in fair value of investments; and interest income on notes receivable from participants; which has been used to prepare the Plan's financial statements and notes. In addition, the information on the supplemental Schedule of Assets (Held at End of Year) has been certified by the Trustee.

6. Related Party and Party-In-Interest Transactions

Certain investments represent shares in mutual funds, a common collective trust, and a self-directed brokerage account (Fidelity BrokerageLink) administered by the Trustee, as defined by the Plan, and therefore qualify as party-in-interest transactions.
