Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Central Specialties, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Central Specialties, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Central Specialties, Inc. Retirement Savings Plan Notes to Financial Statements

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Central Specialties, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan, under section 401(k) of the Internal Revenue Code (IRC), covering all full-time employees of Central Specialties, Inc. (the "Company") who have two months (four months prior to July 1, 2023) of service that are not covered by a collective bargaining agreement, a leased employee, or nonresident alien. Plan entry dates are the first day of the month (quarterly prior to July 1, 2023) upon meeting the eligibility requirement. The Investment Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investments performance.

Employees working on a public construction project that is subject to the Davis-Bacon Act, or a similar statute, shall be entitled to immediately participate in the Plan without regard to the service hour requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 2, 2023, the Plan was amended to adopt the CARES Act provisions.

Contributions

Participants, after meeting eligibility requirements, may contribute a percentage of their compensation, as determined by law to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. At the discretion of the Plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and certain IRAs (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company's matching contributions are discretionary and for 2024 and 2023, the Company made discretionary matching contributions equal to 50% of the elective contributions made by the participants up to \$500 in matching funds. The Company may also contribute a nonelective or profit sharing contribution in an amount to be determined by the Company. Participants with the exception of the following events; death, disability, or termination of service on or after normal retirement age, must complete 1,000 hours of service during the Plan year to be eligible for employer matching and profit sharing contributions. The Company made matching and profit sharing contributions during 2024 and 2023 totaling \$288,516 and \$232,351, respectively.

The Company will make a Qualified Nonelective Contribution ("QNEC") to the Plan for "prevailing wage contributions" on behalf of each participant who performs services subject to the Service Contract Act, Davis-Bacon Act, or similar federal, state, or municipal prevailing wage statute that requires the Company to pay its employees working on that project at wage rates not less than those determined to be prevailing wage rates in the geographical area where that project is located, as in effect for the particular contract under which a prevailing wage employee is performing services after deducting the cost of providing health and welfare and/or fringe benefits, including any differential payments.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in all contributions plus or minus actual earnings or losses thereon.

Payment of Benefits

Participants may receive distributions from the Plan upon death, retirement, termination of service, hardship, or in certain "in-service" situations. A participant may elect to receive a lump sum amount, equal to the vested value of their account, partial withdrawals, or installments. Participants may leave their account under the Plan if their vested account is more than \$7,000. Participants are allowed to withdraw rollover contributions at any time. Participants, who are still employed with the Company, may obtain hardship distributions from all accounts. The Plan allows for in-plan Roth rollovers.

Notes Receivable from Participants

Participants are not allowed to borrow against the value of their accounts.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reflected at fair value in the accompanying financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants valued as of the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the trustee and investment advisor.

Purchases and sales of securities are recorded on a trade date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation represents the Plan's gains or losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Contributions

Contributions from Plan participants and the matching and profit sharing contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Funding Policy

The Company is required to remit the Davis-Bacon contributions to the Plan throughout the year. The Company remits matching and profit sharing contributions on an annual basis, generally by March following the end of each Plan year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in administrative expenses and net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 28, 2025, the date which the financial statements were available to be issued.

During 2025, in connection with the Plan changing their third party administrator (TPA) to Benefit Plans Administrative Services LLC (BPAS), the Company has adopted BPAS's pre-approved plan document. BPAS has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC.

NOTE 3 - CERTIFICATIONS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to non-interest bearing cash and investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered investment companies: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

NOTE 5 - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

NOTE 7 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain fees were paid by the Plan to Cetera Investment Services, LLC, Impact Retirement Advisors, LLC, and CPI Qualified Plan Consultants, Inc. during 2024 and 2023. These transactions qualify as party in interest transactions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
