Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We were engaged to perform audits of the financial statements of Greater Chicago Food Depository Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

As described in Note 3, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements. The Plan has not maintained sufficient accounting records and supporting documents relating to these annuity and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficiently to determine the extent to which the financial statements may have been affected by these conditions.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Our responsibility is to conduct the audits of Greater Chicago Food Depository Retirement Savings Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

Supplemental Schedules Required by ERISA

The supplemental schedules of assets held at end of year as of December 31, 2024 and delinquent participant contributions for the year ended December 31, 2024 are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

Notes to Financial Statements

December 31, 2024 and 2023

Note 1 - Plan Description

The following description of Greater Chicago Food Depository Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Greater Chicago Food Depository (the "Company"), except for nonresident aliens, students, and nonbenefiting employees, who have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective March 1, 2023, employees are eligible to participate in salary deferrals upon date of hire and at age 18. Participants are eligible for employer matching contributions after completing 90 days of service and at age 18.

Contributions

The Company may make a discretionary employer matching contribution on behalf of each participant equal to a percentage of the participant's compensation, as defined by the Plan. Effective March 1, 2023, the discretionary contribution percentage was 3 percent. Effective March 2, 2023, the Plan also provides for employer matching contributions of 100 percent of the participant's contribution up to 4 percent. Contributions were made pretax and are subject to Internal Revenue Code limits. Effective January 1, 2024, employer contributions are calculated and made on a per payroll basis. In order to receive the full match, participants must contribute at least 4 percent each pay cycle.

Effective March 1, 2023, the Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to limitations established by the Internal Revenue Code. The Plan also allows participants to contribute compensation on an after-tax basis. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2024 and remitted related lost earnings to the Plan in 2024.

Participant Accounts

Each participant's account is credited with the Company's contributions and allocation of plan earnings (or losses) and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan once fully vested.

Vesting

Through February 28, 2023, the Company's discretionary contributions, if any, vested according to the following schedule:

Note 1 - Plan Description (Continued)

Effective March 1, 2023, participants vest in employer match and employer discretionary contributions made by the Company beginning at 50 percent after one year of continuous service and become fully vested after two years of continuous service. Participants are immediately 100 percent vested in employee contributions, rollover contributions, and any income or loss thereon.

Plan Loans

Effective March 1, 2014, the Plan was amended to no longer provide for loans. Prior to March 1, 2014, participants could borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balances, whichever was less, from The Variable Annuity Life Insurance Company (VALIC), a custodian of the Plan, using invested funds as collateral for the loan. VALIC transferred an amount equal to the original principal of the loan to the loan collateral account and amounts equal to the first quarter of interest due and potential surrender charges to the loan escrow account. The loan collateral account and the loan escrow account were invested in the VALIC Fixed Account Plus investment option. The participant account is not reduced; collateral is released to the participant-directed investments as loan payments are made. Loans bear interest at market rates. The amounts of these remaining outstanding loans, all of which are in default, are \$47,410 and \$31,353 at December 31, 2024 and 2023, respectively. These loans are not included as assets in the accompanying financial statements.

Participant Notes Receivable

Effective March 1, 2023, participant loans are allowed under the Plan. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. These participant loans are assets of the Plan and are included on the schedule of assets held at the end of year in the amount of \$112,751 and \$12,904 as of December 31, 2024 and 2023, respectively.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant (or the participant's spouse or designated beneficiary in the case of death) may receive 100 percent of the vested value of the participant's account in the form of a rollover, life annuity, joint and survivor annuity, or some other form of annuity. Active participants may also begin taking penalty-free distributions from their vested accounts upon reaching the age of 59½. Effective March 1, 2023, participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are returned back to the Plan and may be used by the Company to offset part of its future contributions to the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$81,138 and \$26,833, respectively. The Company used approximately \$11,200 for the year ended December 31, 2024 to reduce the employer contributions due to the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by The Variable Annuity Life Insurance Company and VALIC Trust Company Inc. or their affiliates. VALIC and VALIC Trust Company Inc. are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated insurance contract is valued at contract value. Contract value represents investments at cost plus accrued interest income, less amounts withdrawn to pay benefits. See Note 8 for additional information.

The variable separate accounts are valued at net asset value (NAV) per share (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. The interest-bearing cash is valued at fair value based on its outstanding balances. Mutual funds are valued at quoted prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains and losses on investments include gains and losses on investments bought and sold, as well as held, during the year.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

All administrative expenses are paid by the Plan to the extent not paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 5, 2025, which is the date the financial statements were available to be issued.

Note 3 - Excluded Investments

The Plan has excluded from investments in the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023 and the statement of changes in net assets available for benefits for the year ended December 31, 2024 certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Note 4 - Certified Information

The Variable Annuity Life Insurance Company and VALIC Trust Company Inc. (collectively, the "Custodians") hold certain of the Plan's investments and execute related investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians.

The Plan has excluded certain assets from the statement of net assets available for benefits at December 31, 2024 and 2023 (see Note 3).

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS. The Plan has not individually sought its own determination letter.

Note 7 - Plan Termination

While the Plan is intended to be permanent, it may be terminated at the discretion of the Company, subject to provisions of ERISA. Upon termination, all amounts credited to the participants' accounts will become 100 percent vested, and the Custodians may commence distribution to each participant.

Note 8 - Investment Contracts

The Plan has two benefit-responsive investment contracts with VALIC. VALIC maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

For the VALIC Fixed Account Plus contract, interest is credited on contract balances using a pool rate approach. Under this methodology, interest rates are set at the beginning of each month, and all new purchase payments received and deposited during that month will earn that month's interest rate for the remainder of the calendar year. After the calendar year, these amounts are consolidated into pool bands with amounts deposited during the earlier periods, and these bands will earn interest at the rate declared each January 1; this consolidated current rate is the pool rate. When establishing interest crediting rates for this product, VALIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. The minimum crediting rate varies by participant and depends on the date the participant established his or her account. For the VALIC Short Term Fixed Account, interest is credited periodically, but not less than annually, at interest rates that apply separately to amounts accumulated in separate time periods. The minimum crediting rate under these contracts is 1.00 percent. The VALIC Short Term Fixed Account investment contract is no longer held as of December 31, 2023. Effective February 28, 2023, contributions can no longer be made to these investments.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contracts are fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.
