INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of R. L. Morgan Company Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - Description of the Plan

The following summary description of the R. L. Morgan Company Profit Sharing Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General - R. L. Morgan Company d/b/a Gill-Roy's Hardware (the Company) maintains a defined contribution plan covering substantially all employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligibility commences each January 1 or July 1 following twelve months of service, provided the employee has attained the age of 21 and earned 1,000 hours of service credit. Participants must be employed at year end to receive employer discretionary contributions.

Contributions - Participants may elect to contribute up to 100% of their pre-tax earnings to the Plan. Participants' contributions are subject to annual maximums in accordance with the Internal Revenue Code. Participants may also contribute amounts as after-tax Roth contributions. Participants designate how their contribution will be invested in the investment funds selected by the Plan Administrator

The Company may contribute a discretionary profit sharing amount determined by the Company's Board of Directors. These amounts are allocated to the participants' accounts based on a pro rata share of eligible compensation reduced to comply with top-heavy requirements and integrated for Social Security. The Employer may also make a matching contribution, which is capped at 5% of eligible compensation as defined in the plan document. The total employer contribution was \$40,000 and \$135,000 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts - Each participant's account is credited with the participant's contribution, the employer's discretionary matching or profit sharing contribution, if applicable, and Plan earnings. Allocations are based upon provisions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Upon enrollment in the Plan, a participant may direct employee and employer contributions in one percent increments in any of the 18 investment options. The options consist of professionally managed mutual funds and vary in their respective strategies, risks and goals.

Vesting - Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service.

Participants' Withdrawals - Upon a participant's retirement date or upon a participant's death or total and permanent disability, all amounts credited to his or her account shall become fully vested. Distributions are payable upon the retirement, death, disability, or termination of employment in the form of a lump-sum equal to the vested balance of the participant's account. Additionally, upon attainment of age 59½, the participant is allowed to withdraw funds from the Plan.

Distribution of the vested portion of a participant's account shall be made upon termination of employment. The vested portion of the account is payable to the participant as a lump-sum amount. If the vested portion of the account is \$1,000 or less, it is distributed directly to the participant. For accounts with vested balances greater than \$1,000 and up to a total of \$5,000, the Administrator has the option of rolling the balance into an IRA without the participant's consent. If the vested portion of the participant's account exceeds \$5,000, a distribution before normal retirement age can only be made with the participant's consent.

Participants may request that all or a portion of their account be distributed in the case of severe hardship, as defined in the Plan document. The Company must approve any such hardship withdrawals.

Forfeitures - The value of forfeited non-vested accounts totaled \$2,471 at December 31, 2024 and \$272 at December 31, 2023. Forfeitures can be used to pay for expenses of the Plan or reduce Employer contributions. The Plan used forfeitures to pay for plan expenses in the amount of \$5,241 in 2024 and \$5,507 in 2023.

SECURE Act and CARES Act - The Plan has implemented certain provisions of the SECURE Act, which was effective January 1, 2020, and the CARES Act, which was signed into law in March 2020. The Plan was amended on October 7, 2022 to adopt the CARES Act provisions. The Plan has until December 31, 2026 to adopt amendments for the SECURE Act provisions.

Basis of Accounting - The financial statements were prepared on the accrual basis of accounting.

NOTE 2 - Significant Accounting Policies

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at current fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Funding Policies - The Company deposits contributions based on voluntary withholdings from the paychecks of eligible participants along with the Company's matching contributions.

Administrative Expenses - The Plan's administrative expenses are paid in part by earnings of the Plan. Additional administrative expenses are paid by the sponsor of the Plan. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - Management has evaluated events and transactions through August 19, 2025, the date the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.

NOTE 3 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels which are described below. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented above are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Level 1 Fair Value Measurements

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

Level 2 Fair Value Measurements

Level 2 inputs consist of quoted prices for similar assets in active and inactive markets and other observable corroborated market data. Level 2 inputs are only used when Level 1 inputs are not available. This includes, but not limited to, quoted prices for similar assets or liabilities in markets that are not active. There are no Level 2 assets.

Level 3 Fair Value Measurements

NOTE 4 - Investments Measured Using the Net Asset Value per Share Practical Expedient

The Plan's investments include the Morley Stable Value Fund, a collective trust sponsored by Principal Global Investors Trust Company with a net asset value of \$27,868 at December 31, 2024 and \$24,691 at December 31, 2023. There are no participant redemption restrictions for the investment.

NOTE 6 - Information Certified by Custodian

The financial statements, accompanying notes and supplemental schedule were prepared in part from information certified by Matrix Trust Company, the custodian of the Plan, as of and for the years ended December 31, 2024 and 2023, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The information certified includes: cash, investments and investment income.

NOTE 7 - Related Party and Party-in-Interest Transactions

Matrix Trust Company is the custodian as defined by the Plan, and Sentinel Benefits & Financial Group provides recordkeeping services to the plan. Therefore, they are considered parties-in-interest. The Company sponsors the Plan and is considered a party-in-interest. The administrative expenses paid by the Plan include plan administration and investment advisory fees, these service providers, along with service providers paid on behalf of the Plan, are all considered parties-in-interest. The Company's owners, who are both participants and Trustees of the Plan are considered related parties.

NOTE 8 - Plan Termination

Although it has not expressed any intent to do so, the Company shall have the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to the participants' accounts will be 100% vested.

NOTE 9 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated November 30, 2020. The plan has not individually sought its own determination letter.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has concluded that as of December 31, 2024 there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 10- Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
