As a result, Wallace Welch & Willingham Inc. 401(k) Retirement Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Wallace Welch & Willingham Inc. 401(k) Retirement Plan 's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Notes to the Financial Statements

1. Plan Description

The following description of the Wallace Welch & Willingham Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering all full-time employees of Wallace, Welch & Willingham Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The original effective date of the Plan was July 1, 1996.
- b) *Eligibility and Contributions* – All eligible employees who have completed 30 days of service and are not part of a collective bargaining agreement, may participate in the Plan. Each year, participants may elect to make pre-tax or post-tax (Roth) contributions to the Plan up to 75% of compensation, as defined in the Plan document. Participants may modify their contribution percentage at any time. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect to participate a different amount. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. Automatic contributions increase annually by 1% per year up to 10% of compensation.

Participants may also contribute amounts representing distributions from other qualified plans ("rollover contributions"). Catch-up contributions, as defined in the Internal Revenue Code ("IRC"), are permissible for eligible participants who are at least age 50 or will attain age 50 before the end of the calendar year. All participant contributions during a Plan year are subject to maximum dollar limitations established by the IRC. For the year ended November 19, 2024, the total maximum allowable tax-deferred contribution to the Plan under the IRC from employee sources was \$23,000, plus catch-up contributions of \$7,500 for eligible employees.

- c) *Company Contributions* – The Company contributes 100% of the first 3% of compensation that a participant contributes to the Plan and 50% of any additional contributions over 3% of compensation, with a maximum Company match of \$2,500 for each participant. The Company made \$253,289 of matching contributions in 2024. Additional profit sharing amounts may be contributed at the option of the Company's. No such additional contributions

were made in 2024.

- d) *Participants Accounts* – A separate individual account is established for each participant in the Plan. Each participant’s account is credited with the participant’s contribution, any Company matching contribution and allocations of investment earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account
- e) *Vesting* – Participants’ contributions and rollover contributions plus actual earnings thereon are 100% vested at all times. Effective July 30, 2024, the Plan was terminated and all Company contributions are considered 100% vested. Prior to Plan termination, participants vest in Company contributions based upon the following schedule:

- f) *Investment Options* – Upon enrollment in the Plan, a participant is required to direct their contributions plus actual earnings thereon to be invested in any of the investment options offered by the Plan. Participants have the ability to modify their investment options daily.
- g) *Payment of Benefits* – Upon termination of service due to death, disability or retirement, a participant becomes 100% vested and may receive an amount equal to the value of the participant’s vested interest in his or her account as a lump-sum amount. Participants may also withdraw funds from their account when they reach the age of 59½, in the event of financial hardship, or after 5 years as an active participant. Benefits are recorded as deductions from net assets available for benefits when paid.

- h) *Notes receivable from Participants* –Participants may borrow for any purpose, up to lesser of 50% of the participant’s vested account balance or \$50,000. Loans are repayable over a period of up to five years. Loans are secured by the participant’s account balance and evidenced by a promissory note. Interest rates on outstanding loans are stated at a rate commensurate with local prevailing rates, as determined by the Plan administrator. All loans, principal plus interest, are repaid through participant payroll deductions.
- i) *Forfeited accounts* –Forfeitures are redistributed among participants after a five year severance period. During the severance period, if the terminated participant is re-employed by the Corporation, the dollar value at the date of re-employment shall be restored to the participant’s account. As of November 19, 2024 and December 31, 2023, unallocated forfeited accounts were \$0 and \$63,273, respectively. During 2024, forfeitures of \$85,003 were allocated to participant accounts and \$8,632 were used to pay plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting for period ending November 19, 2024 and on the accrual basis of accounting for the year ending December 31, 2023, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent through September 10, 2025, which is the date the financial statements were available to be issued.

4. Information Prepared and Certified by the Trustee

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information certified by Principal Life Insurance Company to the related information included in the financial statements.

5. Fair Value Measurements

Accounting principles generally accepted in the United States of America require disclosure about how fair value is determined and establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for the investments measured at fair value. There have been no changes in the methodologies used at November 19, 2024 and December 31, 2023.

Mutual funds – Mutual funds are valued at the daily closing price as reported by the fund. All of the mutual funds are funds with quoted daily prices that are directly observable in the marketplace by market participants and are classified as Level 1 investments in the fair value hierarchy.

Pooled separate accounts (“PSAs”) – PSA’s are privately managed through investment companies and are not publicly quoted. PSAs are comprised, primarily, of shares of registered investment companies held through sub-accounts of Principal Life Insurance Company. The PSAs are valued using net asset value (“NAV”) as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets held through sub-accounts of a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. The Plan has concluded that the NAVs reported by the investment companies approximate the fair value of the investments. There are currently no redemption restrictions or unfunded commitments on these investments.

Collective investment trust funds – The Principal Stable Value Fund, held in a common collective trust fund, invests in conventional and synthetic guaranteed investment contracts (“GICs”) issued by life insurance companies, banks and other financial institutions with excess cash invested in cash equivalents. These investments are valued at their net asset values (“NAV”) per share as of the close of business on the valuation date as a practical expedient for the estimated fair value. The NAV is quoted on a private market that is not active; however, the unit price is based on the value of the underlying investment assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV for the Stable Value Fund is based on the contract value of fully benefit-responsive contracts, conventional and synthetic GICs, which represents invested principal plus accrued interest thereon. The Stable Value Fund seeks to provide preservation of capital and relatively stable returns regardless of the volatility of the financial markets.

The Principal Stable Value Fund is valued at the NAV of the units held by the Plan. NAV would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Other investments held in collective trusts are valued at the NAV per share of the individual collective trust included in each respective fund, which is based on the fair value of the underlying net assets. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the

fund that are traded in an active market, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There are no significant redemption restrictions or unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

7. Related Party Transactions

The Plan hold units in various pooled separate accounts and a stable value fund managed by an affiliate of Principal Life Insurance Company (Principal), the Plan trustee and recordkeeper. These transactions qualify as allowable party-in-interest transactions under the provisions of ERISA.

Fees for contract administration services paid by the Plan to Principal qualify as party-in-interest transactions and totaled \$57,128 for the period ended November 19, 2024.

Notes receivable from participants are considered party-in-interest transactions.

8. Plan Termination

Due to a company acquisition, the company merged into a subsidiary of IMA, Inc. effective July 29, 2024. As part of the merger, the governing body terminated the Plan effective July 30, 2024. All Plan assets were distributed as of November 19, 2024.

9. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Prototype Non-standardized Profit Sharing Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan

Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and accordingly is exempt from taxation.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both November 19, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
