Independent Auditors' Report

To the Plan Administrator of
Neighborly Care Network Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Neighborly Care Network Retirement Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of the Plan

The following brief description of the Neighborly Care Network Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

(a) General

The Plan is a tax deferred annuity plan covering all eligible employees of Neighborly Care Network, Inc. (the “Company”, “Plan Administrator” and “Plan Sponsor”) and was originally adopted July 1, 2001. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective June 1, 2020, the Plan adopted the amended and restated OneAmerica Financial Partners, Inc. 403(b) Volume Submitter Plan, which is operated by OneAmerica, who represents American United Life Insurance Company (“AUL”), the plan custodian. As part of this plan amendment, the Plan name was formally changed to Neighborly Care Network Retirement Plan.

(b) Administration

The Plan is administered by the Company, which serves without compensation. The Plan Administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

(c) Contributions

For the year ended December 31, 2024, participants may contribute up to \$23,000 of pre-tax annual compensation subject to certain Internal Revenue Code (“IRC”) limitations. Employees are able to make elective deferral contributions into the Plan the day in which they become an employee. Once eligible, participants may also contribute amounts representing distributions from other qualified retirement plans, 403(b) tax sheltered annuity plans, government 457(b) plans and traditional individual retirement accounts. Employees must complete one year of service with the Company and have reached 18 years of age before the employee is eligible to receive contributions made by the Company. The Company may, at its discretion, make the following contributions to the Plan:

- Discretionary matching contributions equal to a percentage of the participant’s elective contributions, including catch up contributions.
- Discretionary nonelective contributions equal to a percentage of eligible compensation.

For the year ended December 31, 2024, the Company’s Board of Directors approved nonelective contributions of 5% of all eligible employees’ eligible compensation during the year.

(1) **Description of the Plan - Continued**

(d) **Catch-Up Contributions for Employees Aged 50 or Older**

For the year ended December 31, 2024, if a participant is eligible to make contributions and turns 50 before the end of the calendar year, the participant may contribute an additional \$7,500 into the Plan as a pre-tax contribution subject to certain IRC limitations.

(e) **Participant Accounts**

Each participant's account is credited with the participant's contributions, related Company matching or discretionary contributions, and plan earnings (losses) and charged with an allocation of administrative expenses, if not paid by the Company. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(f) **Vesting Requirements**

Participants are immediately fully vested in their voluntary contributions, including catchup contributions, rollover contributions from other plans, employer contributions, and earnings thereon under the 403(b) option of the Plan.

(g) **Investment Options**

Upon enrollment in the Plan, participants may direct 100% of their allocation of contributions with American United Life Insurance Company (AUL). Within AUL, participants may select between a number of investment options, including several mutual funds and a guaranteed investment contract.

(h) **Notes Receivable from Participants**

Participants may borrow from their individual accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator at the time the loan is approved. Principal and interest is collected ratably through payroll deductions. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence.

(i) **Benefits Paid to Participants**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or installments, equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, distribution of the value of the participant's vested interest in his or her account will begin as soon as possible after the participant's request. Withdrawals prior to attaining age 59 ½ are not permitted, except in the event of retirement, disability, or as a hardship distribution. Upon proof, to the satisfaction of the Plan Administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½.

(1) Description of the Plan - Continued

(j) Forfeitures

The Plan has no forfeitures, as both employee and employer contributions to the Plan are immediately vested.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

(b) Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully-benefit responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Risks and Uncertainties

Investment securities, in general, are subject to various risks, such as interest rate, credit and overall market volatility. Due to the levels of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(e) Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

(f) Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

(g) Administration Expenses

Plan administration expenses are paid out of plan assets, unless otherwise stated.

(3) Information Prepared and Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, the plan custodian, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Mutual funds, at fair value
- Fully benefit-responsive investment contract, at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest income on fully benefit-responsive investment contract
- Interest on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Fair Value Measurements

The Plan applies ASC 820, *Fair Value Measurement*, which establishes a framework for measuring fair value and expands disclosures about fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs that may be used to measure fair value are as follows:

Level 1: Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2: Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date.

(4) Fair Value Measurements - Continued

Level 3: Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for instruments measured at fair value:

Mutual Funds: These investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

The method described above may produce a fair value determination that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Investment Contract with Insurance Companies

The Plan invests in a group annuity contract with AUL. AUL maintains the contributions in the Stable Value Account. Funds allocated to the Stable Value Account are placed in a general account where they are invested in accordance with AUL's general account investment policy. AUL's general account assets are predominately fixed-income investments (bonds, mortgages and private placements). Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this guaranteed investment contract. The contract value of the AUL investment contract at December 31, 2024 and 2023 was \$192,209 and \$222,877 respectively.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is reset annually, each January 1 for the following year. The crediting interest rate was 1% for the year ended December 31, 2024.

Certain events limit the Plan's ability to transact at contract value with AUL. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (d) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring. In addition, the guaranteed investment contract does not permit AUL to terminate the agreement prior to the scheduled maturity date.

(6) Related Party Transactions and Party-in-Interest Transactions

Certain plan investments are held and managed by AUL, which qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services of AUL, as well as participant loan fees, amounted to \$10,176 for the year ended December 31, 2024.

Notes receivable from participants are also considered to be party-in-interest transactions.

(7) Tax Status

The Plan adopted a volume submitter 403(b) plan, which obtained a favorable opinion letter dated November 22, 2017. The Plan is required to operate in conformity with the Internal Revenue Code to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator and the Plan's management believe that the Plan is being operated in compliance with the Internal Revenue Code, and as such, no provision for income taxes has been included in the accompanying financial statements.

(7) **Tax Status - Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) **Plan Termination**

The Company believes that the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. Distribution of participant account balances will occur as soon as administratively feasible upon termination of the Plan.

(9) **Subsequent Events**

The Plan's management has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 9, 2025, the date the financial statements were available to be issued.
