### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the **Unwin Company 401(k) Plan and Trust** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Basis for Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

***General***

The Unwin Company 401(k) Plan and Trust (the “Plan”) was formed January 1, 2018. The Plan is a defined contribution plan covering all employees who have met certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and is administered by the Unwin Company (the “Organization”). The Plan’s assets are held by Nationwide Trust Company, the custodian of the Plan (the “Custodian”).

***Eligibility***

All employees who have attained the age of 18 are eligible to participate in the Plan as soon as it is administratively practicable after their date of employment. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

***Contributions***

Participants can contribute up to 100 percent of eligible compensation through pre-tax deferrals. However, contributions may not exceed limitations established under section 402(g) of the Internal Revenue Code of 1986 (“IRC”), as amended. The Plan permits catch-up elective deferrals for participants over 50 years of age subject to IRC limitations. Participants may also make rollover contributions to the Plan from other qualified plans.

The Organization, in its sole discretion, may make discretionary matching and profit-sharing contributions to the Plan in accordance with the Plan Document. The Organization did make a discretionary matching contribution for the 2024 Plan year. The Organization did not make a discretionary profit-sharing contribution for the 2024 Plan year.

***Investments***

Participants direct the investments of their contributions and the Organization contributions into the investment options offered by the Plan.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions and an allocation of the Organization’s contributions, earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

***Vesting***

Participants are immediately vested in their contributions, Organization matching and discretionary contributions, rollover contributions, and any actual earnings thereon.

***Payment of Benefits***

The full value of a participant’s account becomes payable upon retirement, disability or death. Upon termination of employment for any other reason, a participant’s account becomes payable. All benefits will be paid as a lump-sum distribution. In addition, the Plan includes a provision for participants to make withdrawals from their account under certain “hardship” circumstances.

***Amounts allocated to participants withdrawn from the Plan***

There are no amounts allocated, but not yet paid, to participants withdrawn from the Plan as of December 31, 2024 and 2023.

***Administrative Expenses***

Currently, the Organization pays the administrative expenses of the Plan with the exception of the expenses charged for participant-directed transactions, such as loan processing fees, distribution fees, and participant set-up fees. The Plan may also pay certain investment management fees, where these expenses are allocated to participant's accounts based on the participant's current fair value. These expenses are reflected in the accompanying statement of changes in net assets available for benefits as administrative expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Presentation***

The accompanying financial statements of the Plan have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions and investment income are recognized when received, and disbursements are recognized when made.

***Use of Estimates***

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Income Recognition***

Purchases and sales of securities are recorded on a settlement-date basis. Dividends are recorded when received. Net appreciation or depreciation, if applicable, includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

ASC No. 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC No. 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Unobservable inputs for which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual funds***

Valued based on quoted prices in an active market (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

***Nationwide Financial Fixed Select Contract***

The Nationwide Financial Fixed Select Contract is reported at contract value. Contract value represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate shown on the contract specifications. The interest-crediting rate is declared on a quarterly basis. The Fixed Account is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on Nationwide's ability to meet its financial obligations from general assets. The Fixed Contract is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. While transactions involving the purchases/sales of individual contracts are not observable in a public marketplace, Nationwide has represented that contract value approximates fair value.

Based upon the characteristics of this contract, this Fixed Contract meets the definition of a fully benefit-responsive investment contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 - INCOME TAX STATUS**

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designated, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself, however, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The Plan accounting guidance requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, and the years then ended, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 9 - PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares or units of investments managed by the Custodian. As Nationwide Trust Company is the Custodian of the Plan, the related investment transactions qualify as party-in-interest transactions.

As the individuals are participants in the Plan, these participant transactions qualify as party-in-interest transactions.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan has evaluated events and transactions for potential recognition or disclosure through September 10, 2025, the date the financial statements were available to be issued.
