Our opinion is not modified with respect to this matter. In accordance with accounting principles generally accepted in the United States of America, the Plan has used the liquidation basis of accounting in presenting the 2024 financial statements.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following brief description of the Molecular Templates, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information. The Plan is a defined contribution 401(k) plan covering substantially all employees of Molecular Templates, Inc. (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and qualifies under Section 401(a) of the Internal Revenue Code (the “IRC”). The trustee and recordkeeper of the Plan is Ascensus Trust Company (“Ascensus”). Effective, October 9, 2024, the Plan was terminated subject to the provisions of ERISA. The participants were notified of the plan termination and were 100% vested in their accounts and distributions are being made as soon as administratively practicable after the Plan termination. Effective October 11, 2024, the Company ceased operations and was dissolved.

### **SECURE 2.0**

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (“SECURE 2.0”) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until December 31, 2026 to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

### **Eligibility**

Employees are eligible to participate in the Plan on the first day of the month following the attainment of age twenty-one and the completion of one month of service.

### **Contributions**

Participants may contribute a percentage of their eligible compensation on a pre-tax and after-tax (“Roth”) basis not to exceed the annual limit established by the IRC. A participant’s pre-tax and Roth deferrals will be separately accounted for, as will gains and losses attributable to each. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

## Molecular Templates, Inc. 401(k) Plan

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

The Company may make discretionary employer matching contributions although none were made in 2024. The Company may make qualified nonelective contributions for a Plan year that shall be allocated in the manner prescribed by the Company to correct any operational or demographic failure pursuant to any correction program or policy established by the Internal Revenue Service (“IRS”) or the Department of Labor. For the plan year 2024, the Company declared a profit sharing contribution that was allocated proportionately to the participants and funded fully with the forfeiture accounts subsequent to the plan year end. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### **Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution, the Company’s contribution and Plan earnings and losses, and is charged with withdrawals and applicable administrative expenses. Plan earnings are allocated based on the participant’s share of the net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions is on a three year graded schedule.

#### **Payment of Benefits**

Vested benefits are paid to participants upon death, disability, retirement or termination of employment by either arranging for a rollover to another plan or lump sum payment. Hardship withdrawals are available. For terminated participants’ account balances that are less than \$1,000, the plan administrator may distribute the entire amount in a lump sum without the participant’s consent. For participants with balances from \$1,000 to \$5,000 the plan administrator can process automatic IRA rollovers. If the participant’s vested portion is greater than \$5,000, the participant may elect to maintain the vested portion in the Plan.

#### **1. Description of the Plan (continued)**

##### **Forfeitures**

Forfeitures by participants of unvested Company contributions are used to reduce future employer contributions, pay administrative expenses or allocated to participants. During 2024, forfeitures in the amount of \$29,500 were used to pay Plan administrative expenses and \$31,497 were allocated to participants. As of December 31, 2024, and 2023, there was \$66,658 and \$85,573 of unallocated forfeitures, respectively.

##### **Administrative Expenses**

The Company may pay certain administrative and operating expenses of the Plan at no obligation to the Plan.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared used the liquidation basis of accounting. Benefits are recorded when paid.

##### **Contributions**

Contributions from the employer and the participants are due to the Plan in the period the contributions are earned or deducted from the paycheck.

##### **Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Accounting Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and the accompanying notes and schedule. Accordingly, actual results could differ from these estimates.

##### **Valuation of Investments and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 5 for further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **3. Investments**

All investment information disclosed in the accompanying financial statements, notes and schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, the trustee of the Plan.

#### **4. Party-in-Interest Transactions**

Plan investments are managed by Ascensus. Transactions such as these qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules.

#### **5. Fair Value Measurements**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access

Level 2—Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan's investments in shares of mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Collective investment trusts are valued at fair value of the underlying investments and then adjusted by the issuer to contract value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Income Tax Status**

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the plan is qualified under Section 401(a) of the IRC, and therefore, the related trust is tax exempt. The plan administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Subsequent to receiving the IRS opinion letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

**7. Subsequent Events**

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.
