### 1. Description of Plan

The following description of Andwell Health Partners, formerly known as Androscoggin Home Care and Hospice Tax Sheltered Annuity Plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Androscoggin Home Health Services, Inc. d/b/a Andwell Health Partners (the Association). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Eligibility

The Plan is immediately available to all employees for the purpose of elective deferral and rollover contributions. For purposes of contributions other than elective deferral and rollover contributions, an employee is an active participant on the first day of the month following the completion of one year of eligibility service. Eligibility service is calculated as the period of time beginning on an employee's employment commencement date and ending on the employee's severance date. A participant is eligible to participate in discretionary matching contributions if the participant was an active participant at any time during the Plan year. A participant is eligible to participate in discretionary profit-sharing contributions if the participant was an active participant on the last day of the Plan year and has at least 1,000 hours of service during the Plan year.

#### Contributions

Participants are automatically enrolled to defer 4% of gross compensation. Participants are given a reasonable period to affirmatively elect a different percentage or elect to not make elective deferral contributions to the Plan. A participant may also elect to designate all or a portion of the elective deferral contributions as Roth elective deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also elect to make special Section 403(b) catch-up contributions. The maximum amount that a participant may contribute is limited by provisions of the Internal Revenue Code (the Code).

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, frequently known as rollover contributions.

The Association may make a discretionary matching contribution on behalf of each eligible participant at the option of the Association's Board of Directors. The Association's Board of Directors voted to match 50% of the first 4% of employee elective deferrals for the year ended December 31, 2024.

The Association may also make a discretionary profit-sharing contribution on behalf of each eligible participant in an amount equal to a percentage of each eligible participant's compensation at the option of the Association's Board of Directors. The Association's Board of Directors voted to not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contribution or withdrawal and allocations of the Association's contribution and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a guaranteed investment contract and various mutual funds.

**Vesting**

Participants are immediately vested in their elected deferral contributions and actual earnings thereon. Participants earn vesting in the Association's contributions based on years of service. A participant's vested interest in their account derived from employer contributions and investment earnings shall be based on the following:

Participants are 100% vested in their account derived from employer contributions and investment earnings upon attaining early retirement age (age 55), death, or becoming permanently and totally disabled.

**Forfeitures**

Participants who terminate their employment prior to becoming 100% vested forfeit their nonvested account balances. These benefits plus interest accumulated thereon are left in the Plan to offset the employer's contributions with any remainder used to pay administrative expenses. During 2024, \$41,789 was utilized to reduce the employer's contributions and \$563 was used to reduce administrative expenses. The remaining balance of forfeited nonvested accounts was \$0 and \$4,078 as of December 31, 2024 and 2023, respectfully.

### **Notes Receivable from Participants**

Participants may borrow up to \$50,000, subject to certain limitations and vested account balance, as set forth in the Plan document.

### **Payments of Benefits**

Participants shall become eligible to withdraw their vested account balances upon retirement (normal retirement age is 65), death, disability or termination of employment. In-service benefit payments may be taken upon reaching age 59½ or as a result of financial hardship. Participants may receive their benefit payments in a single lump sum, installment, or annuity.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions.

### **Administrative Expenses**

Substantially all administrative expenses are paid by the Plan.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Subsequent Events**

Management has considered transactions or events occurring through August 25, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Investment Contract with Insurance Company**

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

### **4. Income Tax Status**

The Plan has adopted the Principal Life Insurance Company Volume Submitter 403(b) Plan (the Volume Submitter Plan), which received a favorable advisory letter dated March 31, 2017, from the Internal Revenue Service stating that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

### **5. Information Prepared and Certified by Custodian**

The investments and notes receivable from participants, related transactions including net appreciation in fair value of investments, and interest and dividend income amounts were obtained by management and agreed to or derived from the information certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a member of Principal Financial Group, the custodian, as complete and accurate. This information is included in the following:

### 6. Parties-in-Interest

The Association provides certain accounting and administrative services for which no fees are charged. The employees that provide these services are also participants of the Plan.

Principal manages the investment contract and certain investment funds. Principal is the third-party administrator and an affiliate of the custodian of those investments and, therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the Plan for the investment management services amounted to \$124,956 for the year ended December 31, 2024.

The Plan also paid indirect fees for investment advisory and audit services to Valmark Advisers and Berry Dunn McNeil & Parker, LLC of \$38,976 and \$16,000 for the year ended December 31, 2024, respectively.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

### 8. Risks and Uncertainties

The Plan invests in various investment options. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The mutual funds are valued using market quotations. This method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

We have audited the financial statements of Andwell Health Partners (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit) for the year ended December 31, 2024, and have issued our report thereon dated August 25, 2025. Professional standards require that we communicate to you the following information related to our audit.

## **PART I – REQUIRED COMMUNICATIONS**

### **Our Responsibility under U.S. Generally Accepted Auditing Standards**

As stated in our engagement letter dated March 31, 2025, our responsibility, as described by professional standards, is to conduct our audit in accordance with U.S. generally accepted auditing standards except that, as permitted by Regulation 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA and as elected by management, we did not perform any auditing procedures with respect to asset information prepared and certified to by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a member of Principal Financial Group, the custodian, in accordance with DOL Regulation 2520.103-5, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Significant Risks**

In our engagement letter, we identified the risks we expected would meet the definition of “significant risks” pursuant to U.S. generally accepted auditing standards, which are risks toward the upper end of the risk spectrum based on their likelihood and potential magnitude. Through conclusion of our audit of the financial statements, we have not identified any additional significant risks.

## **Significant Audit Matters**

### ***Qualitative Aspects of Accounting Practices***

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimates affecting the financial statements was the fair value of investments as disclosed in Note 9 to the financial statements.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements was the disclosure of the information prepared and certified by the custodian as disclosed in Note 5 to the financial statements.

The financial statement disclosures are neutral, consistent and clear.

### ***Form 5500 Procedures***

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### ***Difficulties Encountered in Performing the Audit***

We encountered no significant difficulties in dealing with management in performing and completing our audit.

### ***Corrected and Uncorrected Misstatements***

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. We did not identify any known or likely misstatements during our audit.

### ***Disagreements with Management***

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

**Management Representations**

We have requested certain representations from management that are included in the management representation letter dated as of the date of this letter.

**Management Consultations with Other Independent Accountants**

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditor’s opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

**Other Audit Findings or Issues**

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditor. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.
