Opinion

We have audited the accompanying financial statements of International Brotherhood of Electrical Workers, Local 812, Health and Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, the statements of benefit obligations and related changes in benefit obligations for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

NOTE A – DESCRIPTION OF PLAN

The following description of the International Brotherhood of Electrical Workers, (IBEW) Local 812, Health and Welfare Fund (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established June 1, 1963 under a collective bargaining agreement between various employers and IBEW Local No. 812 to provide health and welfare benefits to eligible members. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of a Union employer who have been actively employed and the Plan has received \$5,616 of contributions on behalf of the employee within any three-month period are initially eligible to participate in the Plan. Continued eligibility is contingent upon the receipt of \$1,872 in contributions during a work month. The benefit month is two months after the work month. Contributions in excess of \$1,800 are credited to a Dollar Bank to provide extended coverage. If an employee does not earn the minimum required contribution in a month, the Dollar Bank or self-contributions may be used to continue benefits.

Benefits

The Plan provides health benefits of the following types: medical, prescription drug, a health reimbursement account, dental, vision, life and accidental and dismemberment insurance, and disability benefits. The Plan is insured for medical, prescription drug, dental, life and accidental death and dismemberment benefits for active participants and benefits. The Plan is self-insured for the health reimbursement account for covered participants, retiree prescription drug benefits, and disability benefits provided to active employees.

Postretirement benefits

A retired participant to age 65 may maintain eligibility by using their Dollar Bank or making self-contributions provided the covered participant was eligible for benefits under the Plan as of the effective date of the pension benefit. Dependents of participants who die while they are active employees or retired participants to age 65 may maintain eligibility until the participant’s Dollar Bank is exhausted or by making self-contributions until the date on which the dependent no longer meets the Plan’s definition of a dependent, the date the spouse remarries or the date the spouse or dependent becomes covered by another group benefit plan.

Contributions

The Plan is being funded by contributions from employers who have signed the collective bargaining agreement, and in some cases, by covered employees. Employers contribute monthly based on a fixed hourly contribution rate. Self-contributions by covered employees may be made for every dollar short of the required eligibility contribution. Employer contributions reported in the financial statements include amounts related to hours worked by eligible active participant employees through December 31.

The collective bargaining agreement requires contributions for each hour worked by a member as follows:

June 1, 2024 to December 31, 2024	\$13.00
June 1, 2023 to May 31, 2024	\$12.50
June 1, 2022 to May 31, 2023	\$12.00

NOTE A – DESCRIPTION OF PLAN (continued)

Plan Termination

Although it has not expressed any intention to do so, the Trustees have the right under the Plan to modify, suspend, or terminate the Plan for any reason at any time, subject to the provisions of ERISA. In the event of Plan termination, the rights of participants to benefits are limited to claims incurred and due up to the date of termination.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Employer and reciprocal receivables as of December 31 are accrued based on analysis of subsequent employer and reciprocal reports and remittances.

Post Retirement Benefit Obligations

There is no provision for post retirement benefit obligations because retired participants who choose to continue health coverage under the plan pay their entire health insurance premium.

Dollar Bank

If an employee works more hours than required to cover program costs, the excess will be credited to that employee's account. This "dollar bank" will be drawn upon during periods in which the employee has not worked the required number of hours to satisfy his or her program costs. Currently, there is no dollar limit placed upon accumulation in an employee's account.

Administrative Expenses

Generally all administrative and recordkeeping fees are paid in whole by the Plan.

NOTES TO FINANCIAL STATEMENTS

NOTE C – FAIR VALUE MEASUREMENTS

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 fair value inputs are based on inputs other than quoted prices within Level 1 that are observable for the asset, either directly or indirectly. Observable inputs include quoted market prices in active markets for similar assets, quoted prices in markets that are not active for identical or similar assets and other market observable inputs such as interest rate, credit spread and foreign currency exchange rates observable in the marketplace or derived from market transactions.

Level 3 fair values are based on at least one significant unobservable input for the asset. Level 3 securities contain unobservable market inputs and as a result considerable judgment may be used in determining the fair values.

Certain investments are measured at fair value using the net asset value (NAV) per share, or its equivalent, as a practical expedient. These investments include commingled funds which may include money market funds, common collective trusts and pooled separate accounts which are typically valued using the NAV provided by the administrator of the fund. The Plan assets include money market funds. In accordance with accounting guidance, these investments have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted market prices on the last business day of the Plan year.

Government obligations: Valued using pricing models using observable inputs for similar securities.

Money markets: As a practical expedient, valued at the NAV of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D – TAX STATUS

The Internal Revenue Service has determined that the Plan is "qualified" and exempt from federal income tax under section 501(c)(9) of the Internal Revenue Code. Accordingly, no provision for income taxes has been made in these financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE E – RISKS AND UNCERTAINTIES

The Plan provides various investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE F – CONCENTRATION OF RISK

The Plan maintains deposits in a financial institution that at times exceed amounts covered by insurance provided by the U.S. Federal Deposit Insurance Corporation. The Plan believes that there is no significant risk with respect to these deposits.

For the year ended December 31, 2024, the Plan received 45% of its contributions from three employers. For the year ended December 31, 2023, the Plan received 31% of its contributions from two employers. Loss of employment to Union members at these employers would result in a significant reduction in contributions to the Plan.

NOTE G – PARTY-IN-INTEREST AND RELATED PARTIES

Certain parties provide services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. These services are parties-in-interest transactions.

NOTE H – RECIPROCITY

The Plan has entered into reciprocity agreements with most International Brotherhood of Electrical Workers local unions in the United States. Individuals meeting the requirements of the reciprocity agreement can request to have contributions to the Plan sent to another local union fund, or to direct other local union funds to send contributions to the Plan.
