### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Reynolds Services, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### NOTE A - DESCRIPTION OF PLAN

The following description of the Reynolds Services, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of Reynolds Services, Inc. (The Company). Eligibility to participate in the Plan requires the full-time employee to be 21 years of age and have one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year participants may contribute up to the maximum allowed by law of pre-tax or post-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a non-elective "Safe Harbor Contribution" for each Plan year to the account of each eligible participant in an amount equal to 3% of each participant's compensation. Also, the Company may make profit-sharing and/or discretionary contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company made discretionary profit-sharing contributions of \$232,872 and \$215,724, respectively.

#### Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the allocation of the Company's matching contribution and profit-sharing contribution, the participant's share of the Plan income, and forfeitures of terminated participant's non-vested accounts as well as an allocation of the total administrative expense. Allocations are based on participant earnings or account balances.

#### Vesting

Participants are immediately vested in both their voluntary contributions and the Company's safe harbor contributions plus actual earnings thereon. Graduated vesting in the employer's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 100% vested after 6 years of credited service.

#### Participant Loans

The Plan does not permit participant loans.

### **NOTE A - DESCRIPTION OF PLAN (Continued)**

#### Payment of Benefits

On termination of service due to death, disability, retirement or other reason, or upon attainment of age 59½, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

#### Investment Options

Participants may direct investment of their account into a range of investment options under the terms of the Plan. Participants can change the investment of their funds on a daily basis. The Plan currently offers various registered investment company funds and a common/collective trust as investment options.

#### Forfeited Accounts

For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,718 and \$7,790 respectively. These accounts will be used to reduce future employer contributions of the Plan made after the forfeiture is determined.

### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### Basis of Accounting

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America (GAAP) and have been consistently applied in the preparation of the financial statements.

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Quoted market prices are used to value investments. See Note D for further discussion of fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Administrative Expenses

All expenses of maintaining the Plan are paid by the Plan and allocated among all active participants.

Reclassifications

Certain reclassifications have been made to the prior year financial statements in order for them to be in conformity with the current year presentation.

Date of Management's Review

Subsequent events have been evaluated through August 21, 2025 which is the date the financial statements were available to be issued.

**NOTE C - CONTRIBUTIONS RECEIVABLE**

Contributions receivable totaled \$509,604 and \$453,369 at December 31, 2024 and 2023, respectively, and were made up entirely of amounts due from the employer.

**NOTE D - INVESTMENTS**

Unaudited Information Certified by the Trustee

The December 31, 2024 and 2023 Statement of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the years then ended and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$18,270,080 and \$16,300,707 for the years ended December 31, 2024 and 2023, respectively, and related net investment income of \$2,229,999 and \$2,396,644 for the year ended December 31, 2024 and 2023, respectively.

Investments

The Plan's investments were held in custodial accounts maintained by Ascensus, LLC for the years ended December 31, 2024 and 2023. During the current period being reported on, the investments were managed by various investment management companies under guidelines established by the Fund's board of trustees.

### NOTE E - FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under FASB ASC Topic 820 are described as follows:

#### Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities in active markets.

#### Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are delivered principally from or corroborated by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable measurements.

The following is a description of the valuation methodologies used for assets measured at fair value. The methodology as described below for the common/collective trust was changed from the methodology used in prior years.

Common/Collective Trust is valued at the net asset value of the underlying investments held by the fund less its liabilities.

Registered Investment Company Funds are valued at the quoted closing price reported in the active markets in which are traded.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

In the event of a Plan termination, participants will become 100% vested in their employer contributions.

### NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities which are, by nature, exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE H - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. No liability (or asset) has been recognized by the Plan for uncertain tax positions.

Although the Plan is subject to routine audits by taxing jurisdictions, currently, there are no audits for any tax periods in progress. The plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

**NOTE I - PARTY-IN-INTEREST TRANSACTIONS AND RELATED PARTY**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. As such, parties-in-interest for the Plan were M2B Retirement Consulting, LLC providing third party administration and broker services and the Plan custodian, Ascensus, LLC, providing recordkeeping and other custodial services.

Fees paid by the Plan for the investment management services were \$47,504 and \$43,001 for the years ended December 31, 2024 and 2023, respectively.

Fees paid by the Plan for record keeping and administrative services were \$5,350 and \$4,265 for the years ended December 31, 2024 and 2023, respectively.

**NOTE J – ERISA DISCLAIMER**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

1. Investments as shown in the Statements of Net Assets Available for benefits as of December 31, 2024 and 2023.
