To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan of Carnegie Learning, Inc. (Company) and was established on January 1, 1999. The Plan is subject to the provisions of ERISA.

The plan document was amended effective February 1, 2023. Significant changes to plan provisions are discussed throughout these financial statements.

On December 29, 2022, the SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Plan management is evaluating the impact of SECURE 2.0 Act and only mandatory changes to plan provisions have been made. The plan document is required to be amended in regard to the requirements of SECURE 2.0 Act by December 31, 2026.

Eligibility: The Plan covers substantially all employees of the Company. Non-resident aliens, residents of Puerto Rico or other U.S. possessions and interns and co-op students are excluded from participating. Part-time employees (as defined) are not eligible for the Company's discretionary matching contribution. Certain service for employees of entities acquired by the Company in a previous year is recognized for eligibility purposes, as defined in the plan document.

Employees are eligible to participate if age twenty-one or older and may enter the Plan on the first day of the month coinciding with or next following the date the age requirement is met. One year of service (as defined) is required to be eligible for the Company's discretionary matching and non-elective contributions. A participant must be employed on the last day of the plan year to be eligible for the non-elective contribution; however, this requirement will be waived in the event of death, disability, or attainment of normal retirement age.

Contributions: Each year, participants may elect to contribute from 1% up to 75% of their eligible compensation (as defined), up to the maximum allowable contribution under the Internal Revenue Code (IRC). These contributions may be made as pre-tax or after-tax Roth deferral contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company provides for the following contributions to the Plan:

A discretionary matching contribution as determined by the Company. For 2024, the Company chose to contribute on a pay period basis, 50% of the first 4% of a participant's salary deferrals (including catch-up contributions). The Company's discretionary matching contribution for 2024 totaled \$616,176, net of forfeitures.

A discretionary non-elective contribution as determined by the Company and allocated based on the permitted disparity allocation provisions. No discretionary non-elective contribution was made for 2024.

The Company may also make Qualified Nonelective Contributions (QNECs), as defined in the Plan. For 2024, the Company's QNEC totaled \$831.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Participant Accounts: Each participant's account is credited with the participant's contributions and the Company contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and Company contributions into various investments offered by the Plan, which include registered investment companies (mutual funds), a collective trust fund and self-directed personal choice accounts. The self-directed Personal Choice Retirement Accounts are offered through TD Ameritrade, Inc. and currently invest in a bank sweep account with Charles Schwab & Co., Inc. For those participants who do not make an investment selection, their contributions and the related Company contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in their contributions and QNECs plus earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service. Regardless of the vesting schedule, participants will become fully vested upon death or disability. The Plan provides for certain vesting provisions for employees of entities acquired by the Company in a previous year, as defined in the plan document.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, bear interest at a rate of prime plus 1% and can only exceed a repayment period of five years for the purchase of a principal residence. Only one note may be outstanding at a time. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Benefit payments may be in the form of lump sums or installments and are payable upon termination of employment, death, disability or normal retirement at age 65. The Plan shall make automatic distributions of vested account balances that are less than \$5,000 in accordance with plan provisions. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals and in-service withdrawals at age 59 ½ are also permitted, subject to provisions defined in the plan document.

Forfeitures: Forfeitures of the Company contribution portion of participants' accounts (due to participants' termination prior to full vesting) may be used to pay administrative expenses or reduce the Company's discretionary matching contribution. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,520 and \$10,671, respectively. During 2024, forfeitures of \$84,758 were used to offset the Company's discretionary matching contribution.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Unit Values: Individual participant accounts for the collective trust fund are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the fund, but do have an interest therein represented by units valued daily. The fund earns investment income which is automatically reinvested in additional units. Generally, contributions to and withdrawals from the fund are converted to units by dividing total net assets by the total number of participants' units outstanding on the valuation date. (see Note 3), and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

Contributions: Contributions from plan participants and Company discretionary matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment, as they are paid through revenue sharing. Fees for investment advisory services, recordkeeping services and fees related to the administration of participant notes receivable and distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Collective Trust Fund - MetLife Series 25053: Valued daily at the NAV as provided by its trustee based on the fair value of the underlying assets held by the fund less its liabilities.

The collective trust fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement. The collective trust has no withdrawal restrictions for participant-initiated or plan sponsor withdrawals. There are no unfunded commitments.

NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company, LLC, a qualified institution and the Plan's trustee.

NOTE 5 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed John Hancock Retirement Plan Services LLC (JHRPS), by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

JHRPS provides certain recordkeeping and administrative services to the Plan pursuant to the Service Agreement between the Plan and JHRPS. Pursuant to the Service Agreement, JHRPS receives asset based required revenue compensation which is withdrawn quarterly from the Plan's assets. In addition, participants pay administrative fees and transactional fees relative to notes receivable and distributions. The Plan or Company may make payments to JHRPS for administrative expenses not covered by required revenue. Fees paid by the Plan to JHRPS totaled \$56,393 for 2024.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS - CONTINUED

Kestra Investment Services, LLC (Kestra) provides certain investment management services pursuant to the Retirement Plan Consulting Agreement (RPC Agreement) between Kestra and the Company. The RPC Agreement provides for a quarterly fee based on a percentage of the market value of plan assets. Fees paid by the Plan to Kestra totaled \$67,879 for 2024.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their Company contributions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 46% and 45%, respectively, of net assets available for benefits is invested in the BlackRock LifePath Index Retirement Funds; however, by their nature, these funds are a diversified mix of equities and fixed income that rebalance over time.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.
