Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NRP Investments LLC 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

1. Description of the Plan

The following description of the NRP Investments LLC 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering substantially all employees of NRP Investments LLC (the Company or the Plan Sponsor). Employees who have completed six months of service may participate in the Plan. Entry dates for the Plan are the first day of the first, fourth, seventh, and tenth month of the Plan year. There is no automatic enrollment feature under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan are Empower Trust Company, LLC (the Trustee). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses related to custodian services are paid by the Plan, while accounting fees are paid by the Company.

Effective January 1, 2022, the Plan was restated with no changes to the structure of the Plan.

Contributions

Participants may elect to contribute up to the lesser of 100% of their pretax annual compensation, as defined in the Plan, or the legal limitation for the applicable year. Participants who have attained age 50 before the close of the Plan year may also make catch-up contributions to the Plan, up to limits prescribed. Catch-up contributions are not matched by the Company. Participants may also contribute amounts representing distributions from other certain qualified plans.

The Company will make a safe harbor matching contribution equal to 100% of a participant's elective deferrals that do not exceed 3% of compensation (as defined), plus 50% of a participant's elective deferrals between 3% and 5% of compensation (as defined). Additional profit-sharing contributions may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations. There were no discretionary profit-sharing contributions made during 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, rollover contributions, and an allocation of the Plan's earnings, net of administrative fees, as defined by the Plan document. Allocations of earnings are based on participant account balances. Optional amounts contributed to the Plan by the Company are allocated to participant

accounts based on compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions are invested at the election of the participants in funds maintained by the Plan's custodians. Participants may elect to have contributions allocated between funds.

Vesting

Participants are immediately vested in their contributions, rollover contributions, and safe harbor contributions and actual earnings or losses thereon. Participants vest in employer discretionary matching and profit-sharing contributions ratably over a six-year period with 20% being vested upon two years of service, 20% for each year of service thereafter, and full vesting after the sixth year of service.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the vested portion of his or her account. In accordance with the Plan document, if a participant's vested balance, including rollovers, does not exceed \$5,000, they may elect to receive a single lump-sum payment or to roll over the distribution to another retirement plan. If the vested balances are less than \$1,000 and the participant does not elect to receive or to roll over the distribution, the Plan will automatically roll over the distribution to an IRA. The Plan complies with applicable sections of the Internal Revenue Code (IRC) regarding mandatory cash-out distributions.

Financial Hardship Withdrawals

Financial hardship withdrawals of participants' voluntary deferral contributions are permitted in specialized circumstances of immediate and heavy financial need. These withdrawals may be subject to a 10% penalty.

Forfeiture Accounts

If, upon termination of employment, a participant is not 100% vested in his or her account balance, the non-vested portion will become a "forfeiture" upon the date that the participant receives the distribution of their vested account balance. Forfeitures of terminated participants' nonvested accounts are applied to reduce future Company contributions or to pay for Plan expenses. For the years ended December 31, 2024 and 2023, forfeitures used to reduce Company contributions or pay for Plan expenses were \$7,424 and \$65,590, respectively. At December 31, 2024 and 2023, the balance of unused forfeitures was \$44,034 and \$14,432, respectively.

Notes Receivable from Participants

Loans are permitted to be made to active participants. The loans are secured by the participant's vested interest in the Plan and must be for a minimum of \$1,000 up to the lesser of ½ of the participant's vested account balance or \$50,000. The loan repayment period may not be less than one year and may not exceed five years unless the loan is used to purchase a participant's principal residence. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1% (4.25% to 9.50% as of December 31, 2024 and 2023), which are commensurate with reasonable rates as determined by the Plan administrator. A participant may

only have one outstanding loan at any time. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by its investment advisors. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefit Distributions

Benefit distributions are recorded when paid to participants.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Company has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued and has determined that there were no subsequent events that have occurred through that date that have not already been reflected in the financial statements and/or disclosed in the notes.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3 - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies (Mutual Funds) - These are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts - The Plan's investments in common/collective trusts held by the Plan are valued using net asset value (NAV) as a practical expedient, as reported by the custodian, based on the underlying investments. The common/collective trusts held by the Plan provide for daily redemptions by the Plan at the reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There were no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Accordingly, Empower Trust Company, LLC, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Tax Status

The Plan uses a pre-approved plan document through Great-West Trust Company, LLC (Great-West or Empower Retirement LLC). Empower Retirement LLC received an Internal Revenue Service (IRS) opinion letter dated November 14, 2022, which states that the pre-approved plan document is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Empower Trust Company, LLC, the Trustee of the Plan, and these transactions qualify as exempt party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. Additional transactions that qualify as party-in-interest transactions consist of notes receivable from participants and administrative expenses paid to Empower Trust Company, LLC.

The Plan made direct payments to the Trustee for the years ended December 31, 2024 and 2023, in the amounts of \$99,816 and \$115,626, respectively. Fees incurred by the Plan for investment management services are included in net appreciation in the fair value of investments.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Prohibited Transactions

During the year ended December 31, 2022, the Company inadvertently failed to segregate and remit, in a timely manner, payments of participant contributions and loan repayments totaling \$27,898, from its assets within the required time period as specified by the DOL Reg. 2510.3012. Failure to segregate and remit contributions within the time period as specified by the Company's policy is a prohibited transaction according to the provision of ERISA and the IRC. Lost earnings associated with the late remittances will be paid by the Plan Sponsor during the year ended December 31, 2025.
