INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Tellepsen Corporation 401(k) & Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tellepsen Corporation 401(k) & Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024 and schedule H, line 4a - schedule of delinquent participant contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Tellepsen Corporation 401(k) & Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established January 1, 1980 for the benefit of the employees of Tellepsen Corporation and subsidiaries (“Tellepsen Corporation”). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective June 1, 2023, Tellepsen Industrial, LLC (“Industrial”), a subsidiary of Tellepsen Corporation, was sold and was no longer a related employer. Employees of Industrial continued to participate in the Plan until January 1, 2024. The Plan was amended June 1, 2023 to add Industrial as a nonrelated participating employer and change the Plan to a multiple-employer plan.

Effective January 1, 2024, Industrial a participating employer through December 31, 2023 transferred out of the Plan. Approximately \$3,602,000 in net assets were transferred out of the Plan and the Plan reverted back to a single-employer plan.

The Plan covers all employees of the Tellepsen Corporation, except union employees, nonresident aliens, leased employees, and employees of affiliated employers that have not adopted the Plan. Employees are eligible to participate in the Plan on the first day of employment and attainment of age 18. The entry dates into the Plan are the first day of hire.

Contributions

The Plan has the following contribution options:

Participant Salary Deferral Contributions - Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan as a percentage of their annual eligible compensation, but not more than the limit established by the Internal Revenue Service (IRS). A participant may modify the amount of salary deferral at any time. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Participant Rollover Contributions - The Plan, at the discretion of the plan administrator, allows for participants in a former employer’s qualified plan to contribute to this Plan through a direct rollover.

Employer Discretionary Matching Contributions - The Company may make a discretionary matching contribution. If the Company makes a discretionary matching contribution, the discretionary matching contribution will not apply as to elective deferrals exceeding 6% of the participant’s eligible compensation. The Company elected not to provide for a discretionary matching contribution in 2024.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Employer Discretionary Nonelective Contributions - The Company may, at its discretion, contribute a discretionary nonelective contribution in an amount to be determined by the Company. The Company elected not to provide for a discretionary nonelective contribution in 2024.

Employer Safe Harbor Matching Contributions - Each year, the Company will make a safe harbor matching contribution equal to 100% of each participant's contribution up to 4% of the participant's eligible compensation.

Employer Safe Harbor Nonelective Contributions - The Company may, at its discretion, contribute a safe harbor nonelective contribution in an amount to be determined by the Company. The Company elected not to provide for a safe harbor nonelective contribution in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions. Employer contributions are allocated to the participant's account as defined by the Plan. Each participant's account is participant directed as to investment options. Participants may change investment options at any time. Earnings and losses, including administrative expenses, from investments are allocated specifically to the participant's account. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting/Forfeitures

For vesting purposes, a participant must be credited with at least 1,000 hours during the plan year to qualify as one year of service and count toward vesting. Participants are at all times fully vested in their participant salary deferral contributions accounts, participant rollover contributions accounts, employer safe harbor matching contributions accounts, employer safe harbor nonelective contributions accounts, and the appreciation or depreciation thereon.

Employer discretionary matching contributions and employer discretionary nonelective contributions and the appreciation or depreciation thereon vest as follows:

A participant shall be immediately vested upon death, retirement, or termination of employment due to total and permanent disability. Normal retirement age under the Plan is the latter of the date a participant attains their 65th birthday or the 5th anniversary of the first day of the plan year in which participation in the Plan commenced.

Forfeitures are to be used to reduce employer contributions or pay Plan administrative expenses. At December 31, 2024 and 2023, the forfeitures balance amounted to \$2,348 and \$3,840, respectively. No forfeitures were used to pay Plan administrative expenses in 2024. Forfeitures of \$1,534, were used to reduce employer contributions in 2024.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Note receivable transactions are treated as a transfer to (from) the investment fund from (to) the loans to the participant's account. Notes receivable terms may not exceed five years unless used to acquire the participant's principal residence. The notes receivable are secured by the vested balance in the participant's account and bear interest at a reasonable rate. Principal and interest are paid through payroll deductions. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's account or installments over a period of not more than the participant's assumed life expectancy as determined at the time of distribution. For termination of service due to other reasons, a participant may request the value of the vested interest in the participant's account as a lump-sum distribution. The Plan also allows for hardship distributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the employer safe harbor matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

The Plan has adopted a nonstandardized prototype plan, which obtained its latest opinion letter dated November 14, 2022 in which the IRS stated that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments measured using the NAV practical expedient are described below:

Common/Collective Trust Fund: The fund invests primarily in benefit-responsive investment contracts with insurance companies, banks, and other financial institutions to achieve a stable rate of return. The NAV of the fund is used as a practical expedient to estimate fair value and is determined by the trustee of the fund. NAV represents contributions made to the fund, plus earnings, less withdrawals and administrative expenses. The fund provides for daily redemption by the Plan at reported NAV with no advance notice requirement. The Plan has no unfunded commitments and no contractual obligations to further invest in the fund.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 4 - INFORMATION CERTIFIED

Certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the trustee as permitted by 29 CFR 2520 - 103.8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds managed by affiliates of JPMorgan Invest Holdings LLC (JP Morgan). JP Morgan is the recordkeeper of the Plan and, therefore, qualifies as a party-in-interest as defined under ERISA guidelines. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - DELINQUENT CONTRIBUTIONS

During 2024, there were unintentional delays by the Company in submitting participant contributions to the Plan in the amount of \$250. The Company compensated the affected participants for lost earnings on these delinquent contributions in 2024.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.
