NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1 – Description of Plan

The following description of UNITE HERE HEALTH Staff 401(k) Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description (SPD) for a more complete description of the Plan's provisions.

*General*

The plan is a single employer defined contribution plan of UNITE HERE HEALTH (Fund). The Plan, financed by contributions of the participants, the employer and by the net earnings of the investments of the Plan, covers employees of the Fund and Neighborhood Health Center (NHC), a subsidiary of the Fund, who have completed two months of service. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Participants may elect to contribute an amount that does not exceed the lesser of 60% of their eligible compensation or the applicable Internal Revenue Code dollar limit. The Fund contributes a match of \$0.50 on the dollar, up to a maximum of \$300 per UHH participant per year. NHC contributes a 100% match up to 3% of NHC participants compensation plus 50% of deferrals between 3%-5%.

*Participant Accounts*

Each participant's account is credited with the participant's contribution, the Fund's contribution, and plan earnings (losses) and may be charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

*Vesting*

Participants are immediately vested in their contribution plus actual earnings thereon. Vesting in the remainder of their account balance is based on years of credited service. Participants are 100% vested in their entire account balance after three years of service. Upon separation from service, the non-vested portion of a participant's account will be applied to offset fees. The amount of forfeitures used during the year ended December 31, 2024 and 2023 was \$6,766 and \$9,995, respectively. The forfeiture balance was \$6,020 and \$3,618 at December 31, 2024 and 2023, respectively.

*Investment Options*

Upon enrollment in the Plan, a participant may have their account balances invested in any of the Fund approved investment options with Fidelity Investments. Participants can change investments at any time subject to each mutual fund's prospectus and frequency of trading rules. Deferral contribution changes can only be made monthly. Listed below are the investment options that exceed 5% or more of the Plan's net assets at December 31, 2024 and 2023:

Fidelity Contra Fund K6 - Funds are invested primarily in common stocks of companies whose value is not fully recognized by the public.

Fidelity Mid Cap Index Fund – seeks to provide investment results that correspond to the total return of stocks of mid-capitalization United States companies.

Fidelity 500 Index Fund – Funds are invested to provide a return which corresponds to that of the S&P 500 index. The Fund invests at least 80% of its assets in common stocks included in the Index.

*Investment Options (Continued)*

Vanguard Target Retirement 2025 Fund – Funds are invested in Vanguard mutual funds according to an asset allocation strategy designed for investors planning to retire and leave the workforce in or within a few years of 2025.

Vanguard Target Retirement 2030 Fund – Funds are invested in Vanguard mutual funds according to an asset allocation strategy designed for investors planning to retire and leave the workforce in or within a few years of 2030.

Vanguard Target Retirement 2035 Fund – Funds are invested in Vanguard mutual funds according to an asset allocation strategy designed for investors planning to retire and leave the workforce in or within a few years of 2035.

Vanguard Target Retirement 2040 Fund – Funds are invested in Vanguard mutual funds according to an asset allocation strategy designed for investors planning to retire and leave the workforce in or within a few years of 2040.

Vanguard Target Retirement 2045 Fund – Funds are invested in Vanguard mutual funds according to an asset allocation strategy designed for investors planning to retire and leave the workforce in or within a few years of 2045.

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 (reduced by the highest outstanding loan balance in a participant's account during the prior 12 month period). Loans must be repaid on at least a quarterly basis over a 5 year period which may be increased up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing interest rates charged by commercial banks under similar circumstances. Interest is recorded when received.

*Payment of Benefits*

In accordance with specific provisions of the Plan agreement, a participant, upon termination of service, may elect to receive either a lump sum amount equal to the value of his or her account, or roll-over to another qualified plan of an IRA.

## Note 2 – Summary of Significant Accounting Policies

*Basis of Accounting*

The Plan prepares its financial statements on the modified cash basis of accounting. Revenue, except for the appreciation (depreciation) in fair value of investments recognized at the end of the period, is recognized when received rather than when earned and expenses are recognized when paid rather than when incurred.

*Date of Management's Review*

Subsequent events were evaluated through August 27, 2025, which is the date these financial statements were issued. All subsequent events requiring recognition as of August 27, 2025 have been incorporated into these financial statements.

## Note 2 – Summary of Significant Accounting Policies (Continued)

*Use of Estimates*

The preparation of financial statements requires the Plan Trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income and dividend income is recorded when received. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

## Note 3 – Investments

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan trustee, Fidelity Management Trust Company, has certified that the following data for 2024 and 2023 included in the accompanying financial statements is complete and accurate.

The following table presents the fair value of investments by type at December 31, 2024 and 2023.

## Note 4 – Fair Value Measurements

The Plan's investments are reported at fair value in accordance with the provisions of the accounting standard in effect, "Fair Value Measurements" with respect to fair value measurements of financial assets and liabilities. The accounting standard establishes a framework for measuring fair value by creating a hierarchy for observable independent market inputs and unobservable market assumptions and expands disclosures about fair value measurements. Considerable judgment may be required in interpreting market data used to develop the estimates of fair value. Accordingly, the estimates presented herein are not necessarily indicative of the amounts that could be realized in a current market exchange. The use of different market assumptions and/or estimation methodologies may have a material effect on the estimated fair value.

The three levels of fair value hierarchy under the current accounting standard, and its applicability to the Plans portfolio investments, are described below:

Level 1 – Unadjusted quoted market prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 – Quoted prices for similar assets or liabilities, or inputs that are observable, either directly or indirectly, for substantially the full term through corroboration with observable market data. Level 2 includes investments valued at quoted prices adjusted for legal or contractual restrictions to the security.

Level 3 – Pricing inputs are unobservable for the asset or liability, that is, inputs that reflect the reporting entity's own assumption about the assumptions market participants would use in pricing the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** These investments are based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. These investments are classified as Level 1.

**Money Market:** These investments are valued at cost and classified as Level 1.

## Note 5 – Related Party Transactions

Participants pay for Plan administration expenses and certain investment fees which have been reduced by the balance in the forfeiture account. The Fund, the Plan's sponsor, pays for investment consulting expenses. The Fund paid \$12,500, for the years ended December 31, 2024 and 2023, respectively.

## Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Fund has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

## Note 7 – Tax Status and Uncertain Tax Positions

The Plan has obtained its determination letter in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC) under Section 401(a). The Plan's management believes that the plan is designed and is currently being operated in compliance with the applicable requirements of IRC.

Accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan's management has concluded that there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by the Internal Revenue Service; however there are currently no audits for any tax periods in progress.

## Note 8 – Risks and Uncertainties
