**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Tech-Etch, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). 

**Note 1 - Description of Plan**

The following description of the Tech-Etch, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all eligible employees of Tech-Etch, Inc. (the "Company"). To be eligible to enter the Plan, employees must meet minimum Employee Retirement Income Security Act of 1974 (ERISA) provision requirements. For employees to qualify for Company match and profit-sharing contributions, they must have completed one year of service and have attained 18 years of age.

**Contributions** - Participants may contribute a minimum of 1 percent and a maximum of 99 percent of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers units of participation in common/collective trusts and investments in various mutual funds provided by T. Rowe Price Trust Company. The Company contributes 100% percent of each participant's salary reduction contributions up to 2% of each participant's eligible wages. Additional qualified nonelective and profit sharing amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of A) the Company's contribution and B) Plan earnings (losses). Allocations are based on participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their salary reduction contributions, qualified nonelective contributions and rollover contributions received from other plans that are permitted by the administrator plus actual earnings thereon. Vesting in the Company profit sharing and 401(k) matching contributions plus actual earnings thereon is based on years of continuous service. A participant becomes fully vested after 5 years of service.

A participant can also become fully vested in the employer's profit sharing and 401(k) matching contributions to their account, if the participant becomes disabled, retires at or after age 59½, or dies, regardless of the participant's years of service at that time.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes must be repaid over a period no longer than 5 years, unless the note is used to acquire a participant's principal residence, in which case, the term may not exceed 15 years. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 8.75% to 9.50%, which are commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

**Note 1 - Description of Plan (continued)**

**Payment of Benefits** - Upon termination of service due to death, disability, or retirement, a participant may choose to have their vested account with a value of more than \$5,000 paid under any of the optional forms available under the Plan. If the account value is \$5,000 or less, the account will be paid in a single sum. For termination of service due to other reasons, a participant may elect to receive the value of the vested interest in his/her account with a value of more than \$5,000 paid under any of the optional forms available under the Plan.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Forfeited Accounts** - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$49,253 and \$8,615, respectively. These accounts will be used to reduce future employer contributions. Also, for the year ended December 31, 2024, employer contributions were reduced by \$720 from forfeited non-vested accounts.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting whereby revenues are recognized when earned and expenses are recognized when incurred.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of Estimates** - The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment Valuation and Income Recognition** - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair market value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefits are recorded when paid.

**Corrective Distributions** - Amounts were paid to participants for contributions in excess of amounts allowed by the IRS.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Unrecognized Tax Benefits** - The Company's income tax filings are subject to audit by various taxing authorities. The Company believes its tax positions will be sustained upon examination by taxing authorities. There are no uncertain tax positions for the years ended December 31, 2024 and 2023.

**Date of Management's Review of Subsequent Events** - Subsequent events have been evaluated through August 29, 2025, the date the financial statements were available to be issued.

**Note 3 - Fair Value of Investments**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common/collective trusts are valued using the net asset value as a practical expedient which represents the price at which the Fund is able to initiate a transaction. These investments are excluded from the fair value hierarchy.

**Note 5 - Fully Benefit-Responsive Investment Contract**

The Plan entered into a benefit-responsive investment contract in the T. Rowe Price Stable Value Common Trust Fund. The Fund's investment objective is to preserve principal while providing a competitive current rate of return. The Fund will be invested and reinvested primarily in guaranteed investment contracts ("GICs"), money market funds, money market instruments, repurchase agreements, private placements, bank investment contracts and synthetic GICs.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 amounted to \$3,163,435 and \$5,018,848, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The investment contract does not permit the common/collective trust to terminate the agreement prior to the scheduled maturity date.

**Note 6 - Related Party Transactions**

All of the following party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Transactions with Trustees

Certain Plan investments are shares of mutual funds managed by either T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Notes Receivable from Participants

Notes receivable from participants are party-in-interest transactions.

The Company and its officers

Certain officers of the Company provide services for the Plan. The Company also pays certain administrative expenses of the Plan.

**Note 8 - Tax Status**

The Volume Submitter Plan Administrator has informed the Company that the Internal Revenue Service has determined by a letter dated August, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan may have been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
