We have performed audits of the financial statements of Innovize / Excel 401(k) Savings Plan formerly known as Innovize 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - DESCRIPTION OF PLAN

The following description of the Innovize / Excel 401(k) Savings Plan formerly known as Innovize 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a profit sharing plan that provides for employee contributions under Section 401(k) of the Internal Revenue Code. The Plan covers substantially all full-time employees of Innovize, LLC and Xcel Scientific Inc (collectively, the "Company"). Its provisions are governed by the Internal Revenue Code and the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2024, the Plan was amended to change its name from the Innovize 401(k) Savings Plan to Innovize / Excel 401(k) Savings Plan.

Plan Merger: Effective January 1, 2024, the Plan was amended to allow employees of Xcel Scientific Inc, a wholly owned subsidiary of the plan sponsor, to begin participating in the Plan. Effective January 1, 2024, the assets of the Xcel Scientific Inc Plan were merged into the Plan. The merger resulted in the transfer of \$402,023 in plan assets into the Plan.

Eligibility: Full-time employees become participants in the Plan and eligible for employer contributions after the employee completes one month of service and are age 21 or older. Employees must complete at least 501 hours of service during the Plan Year and be employed on the last day of the Plan Year to be eligible for employer discretionary profit sharing contributions.

Contributions: Employees participating in the Plan can make deferred contributions under the 401(k) program of up to the maximum allowed by the Internal Revenue Service. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. The automatic deduction is increased 1% annually starting the first day of the second plan year, up to a 10% maximum, unless the Participant declines the automatic increase or elects a higher or lower deduction. The increase will be applied to Participants in the second Plan year subsequent to the Plan year in which the initial deferral was withheld.

The Plan qualifies as a Safe Harbor Plan which entails a basic contribution formula matching 100% of the first 4% of participant contributions. The Company may make additional discretionary matching contributions. During the year ended December 31, 2024, the Company made safe harbor contributions of \$697,774 and no additional discretionary contributions.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the applicable Company's discretionary tiered matching contribution, (b) the applicable Company's discretionary profit sharing contribution and (c) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant (beneficiary) is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. For employer discretionary matching and profit sharing contributions, employees vest 20% for each year of service becoming fully vested after five years. Beginning September 1, 2023, participants became 100% vested in their accounts in the Plan attributable to matching contributions.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$1,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum or in installment payments over a 10-year period. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Forfeitures: The nonvested portion of the employer contributions of terminated participants are used to offset Plan expenses. There were \$6,318 and \$2,849 available forfeitures to offset future Plan expenses as of December 31, 2024 and 2023, respectively. There were no forfeitures used to offset Plan expenses during the year ended December 31, 2024.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Notes Receivable from Participants: The Plan provides that participants can borrow funds against their account balances. The amount of a participant loan is limited to 50% of the participant's vested account balance up to a maximum of \$50,000. The minimum amount of the loan is \$1,000. The interest rate is the prevailing rate charged by lenders for a loan of a similar type. These loans must be repaid over a term not to exceed five years.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 9, 2025, which was the date that the financial statements were available to be issued.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value as further discussed in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Risks and Uncertainties: The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company as of December 31, 2024 and for the period from January 1, 2024 to December 31, 2024 and Minnesota Life Insurance Company as of December 31, 2023, the custodians of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds fully benefit-responsive investment contracts that are reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

Traditional Guaranteed Investment Contract: The Plan holds a fully benefit-responsive investment contract of \$2,142,115 and \$2,973,050, with Minnesota Life Insurance Company (“MLIC”; Issuer) at December 31, 2024 and 2023, respectively. MLIC maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated based upon contract provisions, and with a base of 1%. MLIC’s general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan’s investment contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan’s loss of its qualified status, Plan termination, or material and adverse changes to the provisions of the Plan. Currently, management believes that the occurrence of an event that would cause the Issuer to terminate the contract is not probable.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Investment management, investment advising, recordkeeping and custodial fees paid by the Plan to StanCorp Financial Group, The Standard Insurance Company and Creative Planning LLC qualify as party-in-interest transactions. The Plan holds units of pooled separate accounts managed by Minnesota Life Insurance Company (“MLIC”) and a traditional guaranteed investment contract with MLIC. MLIC is a service provider to the Plan and, therefore, these transactions and the Plan’s payment of the fee to MLIC qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
