#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Embark Behavioral Health 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

## Notes to Financial Statements

---

### 1. Description of the Plan

The following description of the Embark Behavioral Health 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document, adoption agreement, and summary plan description for a complete description of the Plan's provisions.

#### **General**

The Plan was created on April 15, 2006 and is a defined contribution plan covering all eligible employees of Change Academy at Lake of the Ozarks, LLC (the Company or Employer), who are not covered by another plan. To be eligible to participate in the Plan, employees must complete two months of service and be 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Contributions to the Plan include: (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, (iii) discretionary profit-sharing contributions made by the Company; and (iv) participant rollovers from other plans. Participants may elect to contribute a percentage of their eligible compensation, as defined by the Plan document, to the Plan each year, subject to the limitations of the Internal Revenue Code (IRC). Regular 401(k) contributions are excluded from the participant's taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. Roth 401(k) contributions are not excluded from the participant's taxable income for federal income tax purposes, but withdrawals of contributions and earnings thereon at retirement are tax free. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

The Employer may make discretionary matching contributions to the Plan for the benefit of each eligible participant each year. For the year ended December 31, 2024, the Employer provided participants a matching contribution equal to 50% of each participant's contribution amount that did not exceed 4% of the participant's eligible compensation.

Participants may also contribute to the Plan amounts representing distributions from other qualified defined benefit or defined contribution plans.

#### **Participant Accounts**

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investment of their account balance into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant with less than 3 years of service as of January 1, 2020, becomes vested based on years of credited service, as follows:

**Notes Receivable from Participants**

Notes receivable from participants are not allowed under the Plan.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

**Forfeitures**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. The Plan document permits the use of forfeitures to either reduce future Employer contributions or pay Plan administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,225 and \$11,266, respectively. During 2024, amounts forfeited totaled \$55,594, amounts used to reduce employer contributions was \$54,262, \$0 was used to pay fees, and the forfeiture account had realized earnings of \$627.

**Administrative Expenses**

Plan administrative expenses may be charged directly to the Plan (either allocated to the participants or using forfeiture funds) or paid by the Employer. During the year ended December 31, 2024, the Plan paid \$132,305 of administrative expenses. Certain administrative expenses are paid by the Company. Investment related expenses are included in net appreciation (depreciation) in the fair value of investments. The Plan Sponsor also provides services to the Plan without remuneration.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

---

### ***Risks and Uncertainties***

The Plan provides for investments in securities that are exposed to various risks, such as interest rate, currency exchange rate, credit, and the overall fluctuation in the market. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Investment Valuation and Income Recognition***

The Plan's investments in mutual funds are valued at fair value based on daily quoted net asset value (NAV) closing prices as reported by the mutual fund on stock exchanges.

The Plan's investments in common/collective investment trusts are stated at fair value based on NAV per share. NAV serves as the practical expedient to estimate the fair value of the Plan's common/collective investment trusts as it represents the value at which the plan transacts with the trusts. NAV is based upon the quoted redemption value of underlying assets in the common/collective investment trusts on the last day of the Plan year.

The guaranteed investment contract is fully benefit-responsive and is recorded at contract value, which is calculated as contributions, plus earnings, less participant withdrawals and administrative expenses.

Net appreciation (depreciation) of investments includes realized and unrealized gains or losses on investments and is recognized in income currently. Amounts invested may earn interest and dividends, which in turn are reinvested. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### ***Payment of Benefits***

Benefits are recorded when paid by the Plan.

### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding decrease to participant contributions.

### ***Subsequent Events***

The Plan Sponsor has evaluated events and transactions occurring subsequent to December 31, 2024 through September 2, 2025, which is the date the financial statements were available to be issued.

## **3. Fair Value Measurement**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Financial Accounting Standards Board established a framework for measuring fair value in the form of a fair value hierarchy, which prioritizes inputs into valuation techniques used to measure fair value into three broad levels. This hierarchy requires assets to be classified by level in their entirety based upon the lowest level of input that was significant to the fair value measurement. The three levels of the fair value hierarchy are as follows:

- Level 1 Quoted prices (unadjusted) in active markets that are accessible at the measurement date for assets or liabilities.
- Level 2 Observable inputs other than Level 1 including quoted prices for similar assets or liabilities, quoted prices in less active markets, or other observable inputs that can be corroborated by observable market data.
- Level 3 Unobservable inputs supported by little or no market activity for financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

#### 4. Fully Benefit-Responsive Guaranteed Investment Contract

##### **Standard Stable Asset Fund**

The Plan has a fully benefit-responsive guaranteed investment contract (GIC) with Standard Retirement Services Inc., an affiliate of The Standard Insurance Company, and collectively or individually referred to as (The Standard). The Standard maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Accordingly, the GIC is considered a traditional investment contract. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Since the GIC is fully benefit-responsive, it is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Certain events might limit the ability of the Plan to transact at contract value with the issuer of the contract. Such events include participant-initiated withdrawals or transfer requests directly or indirectly arising out of corporate acts such as spin-offs, divestitures, corporate relocations, layoffs, retirement incentive programs, partial or total Plan terminations, or the liberalization of Plan withdrawal or transfer rules. Management has concluded that no events are probable of occurring that would limit the ability of the Plan to transact at contract value with the contract issuer.

If the Plan Sponsor terminates the contract, the Standard will pay out the value of that Plan's interest in the contract, subject to a surrender charge. Termination of the Plan's interest is made pursuant to the Plan Sponsor's request. The contract with the Standard terminates on the date when 1) no guaranteed investment balances have been established that are accepting deposits and 2) there are no guaranteed investment balances with a value greater than zero under the contract. Provisions relating to annuities in the course of payment will continue to govern payment of such annuities until the final payment under each such annuity is made.

---

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include 1) the contract owner's failure to abide by state or federal law, 2) failure to render performance necessary to comply with the terms of the contract, 3) failure to maintain assets of at least \$25,000, 4) plan disqualification, and 5) failure to adopt the plan in a reasonable period of time.

#### **5. Exempt Party-In-Interest Transactions**

Certain Plan investments are managed by The Standard, one of the trustees of the Plan. These transactions qualify as exempt party-in-interest transactions.

#### **6. Federal Income Tax Status**

The Plan uses a prototype plan document sponsored by The Standard. The Standard received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2014, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan Administrator has analyzed the tax positions of the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits in tax jurisdictions for tax years for which the applicable statutes of limitations have not expired; however, there are currently no audits for any tax periods in progress.

#### **7. Information Certified by the Trustees**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under that election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Charles Schwab Trust Bank and Standard Insurance Company, the trustees of the Plan, except for comparing such information certified by the trustees to information included in the Plan's financial statements and supplemental schedule:

- All investment assets held by the Plan
- The recording of transactions related to all investment assets including related earnings (losses), capital gain distributions, and interest and dividends.
