### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed audits of the accompanying financial statements of Hill Wallack Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### A. DESCRIPTION OF PLAN

The following brief description of the Hill Wallack Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

##### **General**

The Plan is a defined contribution plan covering all eligible employees of Hill Wallack, LLP (the "Company"). The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Empower Annuity Insurance Company of America (the "Trustee") is the Plan's trustee. The inception date of the Plan was January 1, 1997.

The Plan was amended and restated effective May 15, 2024, to increase the maximum automatic deferral provision to 10%.

##### **Contributions**

Each year, participants are able to contribute up to 100% of eligible compensation, as defined in the Plan, subject to certain limitations under the Internal Revenue Code ("IRC"). The Plan allows for automatic enrollment. Unless an employee is excluded from participating, or elects to not participate, the Company will withhold 3% of the employee's compensation each payroll period. Contributions can be made as pre-tax contributions or as Roth contributions. Catch-up contributions and rollover contributions are also permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a variety of mutual funds and a guaranteed investment contract as investment options for the participants.

The Company, at its discretion, may make discretionary matching contributions based on employee contributions. The Company did not make any such contribution for the year ended December 31, 2024. The Company, at its discretion, may also make discretionary nonelective contributions. There were no discretionary nonelective contributions for the year ended December 31, 2024.

Effective January 1, 2020, the Plan was amended to institute an automatic deferral provision. Under the terms of this provision, participants will be enrolled in the Plan using a deferral rate of 3% unless otherwise elected or declined. The deferral percentage will automatically increase by 1% per year up to a maximum deferral percentage of 6%. Effective May 15, 2024, the Plan was amended to increase the maximum deferral percentage for the automatic deferral provision to 10%.

##### **Participants' Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching and nonelective contributions, and Plan earnings (losses) and is charged with an allocation of investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### A. DESCRIPTION OF PLAN (CONTINUED)

#### **Vesting**

Participants are immediately vested in their own contributions, all rollovers and transfers from qualified plans and actual earnings or losses therein. Participants become vested in employer contributions based on a graded-vesting schedule, with participants becoming fully vested after six years. In addition, participants become fully vested in their accounts upon reaching normal retirement age (as defined in the Plan) prior to termination of employment or in the event of death or permanent disability.

#### **Notes Receivable from Participants**

Participants are allowed to borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of (i) 50% of their vested account balance, or (ii) \$50,000 less the highest outstanding balance during the previous 12-month period minus the loan balance on the date a new loan is made. The notes receivable are secured by the balance in the participant's account. Interest is charged at a rate of the prime rate plus 1% at the time of borrowing. Terms range from 1-5 years for personal borrowings or up to fifteen years for the purchase of a primary residence. Participants are permitted to have a maximum of three loans outstanding at a time. The interest rate on the notes receivable from participants ranged from 4.25% to 9.50% for both years ended December 31, 2024 and 2023.

#### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant is to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, subject to Internal Revenue Service ("IRS") regulations, a participant is to receive the value of the vested interest in his or her account as a lump-sum distribution or have the balance deposited directly into another qualified retirement account.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9 and \$3. Forfeited non-vested accounts are available to reduce future employer contributions or pay Plan expenses. For the year ended December 31, 2024, no amounts were used to pay Plan expenses.

#### **Administrative Expenses**

Expenses related to the administration of the Plan are primarily paid by the Company. Investment related expenses are paid via a revenue sharing arrangement with the Trustee.

### B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### **B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

##### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

##### **Revenue Sharing Agreement**

The Plan is party to a revenue sharing agreement which provides for a revenue account for the Plan to pay for certain administrative expenses from Plan assets. The account is funded by revenue generated by certain Plan funds. The agreement provides that excess amounts in the Plan revenue account at the end of each Plan year may be applied towards allowable administrative expenses or allocated at the direction of the Plan's investment committee. For the year ended December 31, 2024, revenue received under the agreement totaled \$21,851.

##### **Subsequent Events**

Management has evaluated subsequent events for potential recognition and disclosure that occurred through August 18, 2025, the date the financial statements were available to be issued. The information contained in Note A was determined by management to require disclosure.

#### **C. CERTIFIED INVESTMENT INFORMATION**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss), net and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### D. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures to Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• Quoted prices for similar assets or liabilities in active markets;</li><li>• Quoted prices for identical or similar assets or liabilities in less active markets;</li><li>• Inputs other than quoted prices that are observable for the asset or liability; and</li><li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* valued at the net asset value ("NAV") of shares held by the Plan at year end. The NAV is calculated as of the close of the New York Stock Exchange ("NYSE") each day the NYSE is open.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Changes in Fair Value Levels

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### E. GUARANTEED INVESTMENT CONTRACT

In 2010, the Plan entered into a fully benefit responsive investment contract with Empower Annuity Insurance Company of America ("Empower"). Empower maintains the contributions in a general account, and the account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because the contract is fully benefit responsive, contract value is the relevant measurement, and the contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include 1) amendments to the Plan documents (including partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example; divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not likely to occur.

The contract does not permit Empower to terminate the agreement prior to the scheduled maturity date.

#### **F. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities in general are exposed to various risks such as those involving interest rates, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **G. RELATED PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are units in a guaranteed investment contract managed by Empower. Empower holds the assets of the Plan through an agreement; therefore, these transactions qualify as party-in-interest transactions. Fees paid to Empower and its related companies by the Plan for administrative services amounted to \$21,214 during the year ended December 31, 2024.

Newport Capital Group, LLC is the Plan's investment advisor; therefore, transactions between Newport Capital Group, LLC and the Plan qualify as party-in-interest transactions. Fees paid to Newport Capital Group, LLC amounted to \$122,778 during the year ended December 31, 2024.

#### **H. TAX STATUS**

The IRS has determined and informed the Plan by letters dated March 31, 2014 and June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **I. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company reserves the right to terminate the Plan, in whole or in part, at any time, subject to the provisions of ERISA. In the event that such termination occurs, all amounts credited to participant accounts will become 100% vested and the Trustee, in accordance with the Plan document, will distribute the net assets of the Plan in a uniform and non-discretionary manner.
