Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SPHERE Institute/Acumen LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the SPHERE Institute/Acumen LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan that was established on January 1, 2000 to provide retirement benefits to eligible employees of The SPHERE Institute and a related employer, Acumen, LLC (collectively, the "Company"). The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

B. Administration and Expenses

The Company appointed an Administrative Committee (the "Committee") to manage the operation and administration of the Plan. Fidelity Management Trust Company ("Fidelity") serves as trustee and record keeper.

Certain investment fund management fees and operating expenses are charged directly to the investment funds and are thereby factored into each investment fund as a reduction in investment return. Certain fees including withdrawal and participant loan administration fees are charged directly to participants. Other costs of administering the Plan may be paid from the Plan or paid by the Company at the discretion of the Committee.

C. Eligibility

Substantially all employees of the Company who have attained age 21 are eligible to make elective deferrals and receive employer profit sharing contributions under provisions of the Plan. There is no service requirement. Leased employees, interns and employees covered by a collective bargaining agreement are specifically excluded. Entry date is immediate upon meeting age and eligibility requirements.

D. Participant Contributions

The Plan allows participants to defer up to 100% of their eligible compensation in pre-tax and/or Roth after-tax contributions subject to applicable Code limits. Participants age 50 or older may make additional catch-up contributions subject to applicable Code limits. Newly hired eligible employees who have not made an affirmative election to defer compensation to the Plan, including an election not to defer compensation to the Plan are auto-enrolled at a pre-tax deferral rate of 5% of eligible compensation immediately upon date of hire. Participants may also make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with participant directions.

E. Employer Contributions

The Plan provides for employer discretionary non-elective contributions on behalf of eligible participants. Employer contributions are 50% of the employee's deferral rate up to a 2.5% maximum.

F. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, employer non-elective contributions and the participant's share of Plan earnings or losses and expenses. Participant accounts are invested based on participant directions.

The contributions of participants who decline to make an investment election are invested in the Fidelity Freedom Fund appropriate for the individual's age and projected date of retirement.

G. Vesting and Forfeitures

Participants vest in their accounts attributable to Company contributions under a schedule set forth in the Plan that provides for 33% vesting on completion of two years of service, 67% vesting on completion of three years of service and 100% vesting on completion of four or more years of service. Forfeitures of terminated participants' non-vested accounts may be allocated as additional Company contributions or used to pay Plan administrative expenses. During 2024, approximately \$251,000 of forfeitures were used to reduce Company contributions and approximately \$50,000 were used to reduce Plan expenses. The balance of available forfeitures was approximately \$102,000 and \$71,000 at December 31, 2024 and 2023, respectively.

H. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability or electing early retirement at age 55, a participant or beneficiary may maintain his or her account in the Plan or receive benefits in a lump sum payment equal to the value of the vested participant's account balance. Participants are also allowed to receive in-service withdrawals if the participant has attained age 59½. Hardship withdrawals are permitted from participant accounts attributable to elective pre-tax and Roth contributions, under limited circumstances subject to approval of the plan administrator.

I. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's account and bears a fixed rate of interest based on prevailing interest rates charged by persons in the business of lending money for loans made under similar circumstances. A loan must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with maturities through August 2034.

Notes are measured at their unpaid principal balance plus accrued interest. Delinquent notes receivable are recorded as a distribution based on the terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Company adopted a volume submitter plan that has received an opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Company believes that the Plan is operated in accordance with, and qualifies under, applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 5 - RELATED PARTY TRANSACTIONS

Plan investments are managed by affiliates of the trustee. Purchases and sales of these funds and payment of direct and indirect administrative and investment management fees to Plan service

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust, the trustee of the Plan.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

The following description of the SPHERE Institute/Acumen LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Forfeitures of terminated participants' non-vested accounts may be allocated as additional Company contributions or used to pay Plan administrative expenses. During 2024, approximately \$251,000 of forfeitures were used to reduce Company contributions and approximately \$50,000 were used to reduce Plan expenses. The balance of available forfeitures was approximately \$102,000 and \$71,000 at December 31, 2024 and 2023, respectively.

H. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability or electing early retirement at age 55, a participant or beneficiary may maintain his or her account in the Plan or receive benefits in a lump sum payment equal to the value of the vested participant's account balance. Participants are also allowed to receive in-service withdrawals if the participant has attained age 59½. Hardship withdrawals are permitted from participant accounts attributable to elective pre-tax and Roth contributions, under limited circumstances subject to approval of the plan administrator.

I. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's account and bears a fixed rate of interest based on prevailing interest rates charged by persons in the business of lending money for loans made under similar circumstances. A loan must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with maturities through August 2034.

Notes are measured at their unpaid principal balance plus accrued interest. Delinquent notes receivable are recorded as a distribution based on the terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Company adopted a volume submitter plan that has received an opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Company believes that the Plan is operated in accordance with, and qualifies under, applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 5 - RELATED PARTY TRANSACTIONS

Plan investments are managed by affiliates of the trustee. Purchases and sales of these funds and payment of direct and indirect administrative and investment management fees to Plan service

providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust, the trustee of the Plan.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.
