Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Innophos, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of the Plan

The following description of the Innophos, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution plan established for eligible employees of Innophos, Inc. (the Company, Plan Sponsor or Innophos). The Plan was established August 14, 2004 with rollover contributions from Rhodia Inc. Savings Plus Plan made by Company employees. The Plan is Subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Benefits Committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

All employees of Innophos are eligible to participate in the Plan except for interns, students, temporary employees, leased employees, employees covered by a pension or retirement plan maintained by the Company outside of the United States, or employees who are members of a collective bargaining unit whom coverage under the Plan has not been extended.

Contributions

Contributions are made to the Plan by participants through payroll deductions and by the Company on behalf of participants. Participants are automatically enrolled in the Plan at 5% of their base compensation and can subsequently alter their contributions to contribute from 1% to 60% of their base compensation on a before-tax or Roth basis. Effective August 1, 2024, the Plan reinstated the employee after-tax contribution with no safe harbor match. Unless otherwise elected, the automatic deferral will increase 1% per year up to a maximum of 8% of base compensation. Before-tax and Roth contributions, combined may not exceed the Internal Revenue Service (IRS) limits. Participants age 50 and over are eligible to contribute additional pre-tax contributions (catch-up contributions), subject to IRS limitations. Participants can elect an amount to be contributed from each paycheck as their catch-up contribution. This amount will be in addition to the Pre-Tax, Roth and Post-Tax contribution percentages that participants have elected. The Plan also permits rollover contributions.

Participants receive a monthly employer safe harbor matching contribution equal to 100% of the participants' before tax, Roth and after-tax contributions up to 5% of their base compensation. The Company does not match catch-up contributions.

The Company may also make a discretionary contribution, which may be allocated as a uniform percentage of plan compensation or as a uniform dollar amount. The discretionary contribution made for the plan years ended December 31, 2024 and 2023 was \$1,065,124 and \$1,032,314, respectively, which is recorded as a receivable on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company contributions, as well as allocations of the Plan's earnings. Participants are charged with an allocation of administrative expenses, if not paid by the Company. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's monthly safe harbor matching contributions plus actual earnings thereon. Participants become 100% vested in their discretionary retirement contributions when they complete three years of service or reach age 65 while actively being employed by the Company. Participants can also become 100% vested in the additional retirement contributions either upon termination of employment due to death or disability.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator at the inception of the loan. Interest rates range from 4.25% to 9.50% at December 31, 2024. Principal and interest is paid ratably through payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may receive lump-sum, or installment distributions equal to the value of the participant's vested interest in their account. In addition, the Plan allows for hardship distributions if certain criteria are met. If a participant's account balance is in excess of \$1,000 but does not exceed \$5,000, and the participant does not elect to have such distribution paid, the participant's account will automatically be paid in the form of a lump sum. Effective July 1, 2024, the Plan implemented the mandatory provisions of Secure Act 2.0. Additionally, the maximum for automatic lump sum payment of benefits increased from \$5,000 to \$7,000 and mandatory distributions increased from \$1,000 to \$5,000.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$153,744 and \$118,772, respectively. These amounts can be used to pay plan expenses or reduce future Company contributions. For the year ended December 31, 2024, the Company used \$87,888 in forfeitures to reduce Company contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through August 5, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at net asset value: Consisting of common-collective trusts, valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Insurance contract: The guaranteed annuity contract consists of the Massachusetts Mutual Life Insurance Company (MassMutual), an affiliated entity of Empower Retirement, Separate Account Guaranteed Interest Contract (SAGIC Account). The contract of the SAGIC Account is fully benefit-responsive and is excluded from the fair value hierarchy table. The SAGIC Account is reported at contract value, which approximates fair value, based on MassMutual's ability to pay the guaranteed claims in accordance with the terms of the contract. See Note 4.

4. Group Annuity Contract With Insurance Company

The Plan holds a separate account guaranteed interest contract. The contract met the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the value of the fully benefit-responsive investment contract held by the Plan as of December 31, 2024 and 2023:

The contract issuer is contractually obligated to repay the principal and interest at a guaranteed interest minimum rate of interest between 1% and 3% to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

5. Administration of Plan Assets

The Plan's assets are administered under a contract with Empower Annuity Insurance Company of America and Empower Trust Company, LLC (trustees of Plan). The trustees invest funds received from contributions, investment sales, interest and dividend income and make distribution payments to participants.

6. Related-Party and Party in Interest Transactions

Certain plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Trustees, and therefore, these transactions qualify as party in interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Trustees receive revenue from investment fund service providers for services the Trustees provide to the funds. This revenue is used to offset certain amounts owed to the Trustees for their administrative services to the Plan. If the revenue received by the Trustees from such investment fund service providers exceeds the amount owed for its services, the Trustees remit the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to the Trustees for administrative expenses not covered by revenue sharing.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

8. Tax Status

The IRS has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$84,000,335 and \$79,973,917, respectively that were concentrated in three funds.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

11. Information Certified by Trustees

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.
