Independent Auditor's Report

To the Plan Administrator and Trustees of the Aras Corporation 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Aras Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements

As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Aras Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by ARAS Corporation (the “Company or Plan Sponsor”) for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan’s investment assets are currently invested in various pooled separate accounts and fixed accounts offered by the Voya Retirement Insurance and Annuity Company, the Custodian of the Plan (“Voya” or the “Custodian”). FuturePlan by Ascensus is the Plan's third-party administrator.

Eligibility

To become eligible for participation, an employee must be at least age 21 and must have completed one month of service. The employee will become a participant in the Plan on the first day of the calendar month following the date in which they become eligible.

Participant Contributions

Participants may elect to, but shall not be required to, contribute to the Plan. They may contribute up to 70% of compensation, as defined in the Plan. Participants may also elect to make Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may change their elective deferral amounts throughout the year. Participants may also change their investment options throughout the year.

An active participant may, at the discretion of the Plan Administrator, contribute to the Plan distributions from other qualified plans or individual retirement accounts, if the contributions satisfy the tax law requirements for a qualified rollover.

Employer Contributions

The Company may make a discretionary matching contribution to the Plan.

The Company may also make a discretionary profit sharing contribution to the Plan for any eligible employee that is employed on the last day of the Plan year and has completed 500 hours of service within the Plan year.

No employer contributions were made to the Plan for 2024.

Vesting

A participant will have a fully vested interest in that portion of their account attributable to salary deferral contributions, rollover contributions and related investment earnings.

Participants vest in the employer discretionary matching contributions and profit sharing contributions as follows:

Forfeitures

Forfeitures are created when participants terminate employment before becoming fully vested. Forfeitures are used to pay any administrative expenses and to reduce the Company's matching contributions. As of December 31, 2024 and 2023, there was no balance of forfeitures available to pay plan expenses or offset employer contributions to the Plan.

Investment Options

Participants may direct the investment of their deferrals, and any employer matching and profit sharing contributions, to any investment funds offered by the Plan. Earnings in these funds and/or market gains or losses are reflected in their changing unit values or returns.

Notes Receivable from Participants

Loans may not be in an amount less than \$1,000, as determined by the Plan Administrator, or greater than \$50,000 reduced by the participant's highest outstanding loan balance in the prior twelve month period and limited to 50% of a participant's vested interest in the Plan. Loans are secured by up to 50% of the participant's vested interest in the Plan. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Loans are generally required to be repaid not less than quarterly within five years of the date the loan is made, unless such loan is to acquire a principal residence in which case the term may be extended. A participant is not allowed to have more than one loan outstanding at any time.

Distributions

On termination of service due to death, disability, dismissal, voluntary termination, or retirement, a participant may elect to receive an amount equal to the current value of the participant's vested interest in their account. Distributions under the Plan shall be paid as lump sum payments.

A participant who has reached age 59½ will be entitled to withdraw 100% of their vested account balance. Distributions can also be made as in-service hardship withdrawals, as defined.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting and are in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in pooled separate accounts are reported at fair value. The Company determines the Plan's valuation policies utilizing information provided by investment advisors and Voya. See Note 4 for further discussion of investment valuation.

The Plan's investment in the guaranteed interest account, which is a fully benefit-responsive investment contract, is reported at contract value based on information reported by Voya. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment security transactions (purchases and sales) are recognized on the trade date (the date the order to buy or sell is executed). Interest income is recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments includes both realized and unrealized gains and losses. Gains and losses on the sale of investments are calculated using the average cost method.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participation loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain costs of the Plan were paid by the Company for the year ended December 31, 2024. Administrative fees, if any, are charged to participants for recordkeeping and information management or participant loan processing that are deducted from their asset balances. Investment related expenses are included in net appreciation of fair value of investments.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Voya, a qualified institution.

Voya also certified the information included in the Schedule of Assets (Held at End of Year).

4. INVESTMENT VALUATION

Fair Value Hierarchy

Accounting principles have established a hierarchal framework which prioritizes and ranks the level of market price observability used in measuring investments at fair value. Market price observability is impacted by a number of factors, including the type of investment and the characteristics specific to the investment. Investments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments held by the Plan are measured using inputs from one of the three levels of the fair value hierarchy. Inputs are broadly defined as assumptions market participants would use in pricing an asset or liability. The three levels of the fair value hierarchy are as follows:

Level 1 – Valuation is based on quoted prices in active markets for identical assets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets.

Level 2 – Valuation is based on observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.

Level 3 – Valuation is based on unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets. Level 3 assets include financial instruments whose value is determined using unobservable inputs to pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

In certain cases, inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the investment.

Valuation Methodologies

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: Valued based upon the units of such pooled separate accounts held by the Plan at year end multiplied by the respective unit value. As of December 31, 2024 and 2023, pooled separate accounts held by Voya are valued at their "accumulation unit value" (AUV). These are valued daily as the number of accumulation units held multiplied by the AUV. The AUV is determined daily based on the net asset value of shares of the underlying fund, the fund's dividends and the contract's separate account charges. Investments in the pooled separate accounts are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient and in accordance with Financial Accounting Standards Board ("FASB") ASC 820-10 have not been classified in the fair value hierarchy.

Guaranteed Interest Account

The Plan has entered into a fully benefit-responsive investment contract with Voya which maintains the contributions in a separate account. The traditional investment contract is reflected in the financial statements at contract value as reported to the Plan by Voya.

Since the guaranteed investment contract meets the fully benefit-responsive investment contract criteria, contract value is the relevant measure. This is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus credited interest, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a methodology agreed upon with the issuer, but it may not be less than one percent. Such interest rates are reviewed on a monthly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the contract issuer. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement except under certain circumstances outlined in the contract.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments include pooled separate accounts and fixed accounts managed by the Custodian. Therefore, these transactions qualify as party-in-interest transactions. Fees paid for investment management services are included as a reduction of the return earned on these investments. Notes receivable from participants also qualify as party-in-interest transactions.

6. TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan in which the Internal Revenue Service (“IRS”) determined, as stated in a letter dated June 30, 2020, was acceptable under the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan qualifies as a tax-exempt entity. Accordingly, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor (“DOL”). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan Administrator believes the Plan is no longer subject to examinations for years prior to December 31, 2021.

7. RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts which shall not thereafter be subject to forfeiture.
