

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Penny Newman Grain Company, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has been restated for final Cycle 3 regulations effective June 1, 2021. The Plan's purpose is to provide employees of Penny Newman Grain Company, Inc., and its participating affiliates and locations (collectively, the Company), the opportunity to accumulate funds for their retirement. The Trustees are responsible for the oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

The Plan covers all employees of the Company, except members of a collective bargaining unit where retirement benefits were the subject of good faith bargaining, and if the collective bargaining agreement does not provide for participation in this Plan, and non-resident aliens with no U.S. source income.

An employee of the Company becomes eligible to participate in the Plan after completing one year of service with the Company and after attaining age twenty-one. Employees may elect to participate in the Plan on the first day of December, or the date six months thereafter, following completion of all eligibility requirements.

Employee contributions

Participants may contribute a percentage of their annual compensation to the Plan through salary deferrals up to the maximum dollar amount determined by the Internal Revenue Service (IRS) each year. If the participant is age 50 or older, the participant may elect to defer additional amounts as defined by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer contributions

Upon fulfillment of the eligibility requirements, participant accounts will accrue a safe harbor match of 100% of employee deferrals up to 4% of eligible compensation. The safe harbor match is allocated to participant accounts that have received deferrals during the year. During the years ended November 30, 2024 and 2023, the Company made safe harbor match contributions of \$559,198 and \$533,589, respectively.

Each year the Company may determine a discretionary amount to contribute to the Plan. Contributions will be allocated to participants in proportion to each participant's compensation for the plan year to total compensation for all participants for that year. For the years ended November 30, 2024 and 2023, the Company did not make a discretionary contribution.

Contributions are subject to certain IRS limitations.

NOTE 1 – DESCRIPTION OF PLAN (continued)

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are allowed to direct their contributions and the related employer discretionary and matching contributions by the Company into any of the various investment options offered by the Plan.

Vesting

Participant contributions, safe harbor match and actual earnings thereon are immediately 100% vested. Discretionary contributions by the Company vest on a pro rata basis over six years. In the event of death, disability or normal retirement age, a participant's interest in employer discretionary contributions becomes fully vested.

Notes receivable from participants

Participants in the Plan may borrow a minimum amount of \$1,000 and a maximum of 50% of their vested balance up to \$50,000. Loan terms range from one to five years, unless the loan is being used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear a reasonable interest rate which is defined by the Loan Policy as the prime rate plus one percent. Principal and interest is paid ratably through payroll deductions. Notes receivable were \$478,698 and \$416,403, as of November 30, 2024 and 2023, respectively.

Payment of benefits

Upon retirement, death, disability or termination of service due to other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. A partial or installment distribution may be permitted if needed to satisfy the required minimum distribution rules.

A participant who has attained age 59-1/2 and who has not separated from service may obtain an in-service distribution of their vested benefits.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are included in administrative expenses when incurred. As of November 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses, other than advisory expenses, are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Subsequent events

Plan management has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts invest in mutual funds, domestic equity securities, or fixed maturity securities. More than one source may be used to generate unit prices. The market price of the fund and the unitized pricing model are both used.

NOTE 6 – TAX STATUS

The Plan obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 – ALLOCATION OF ASSETS

Net assets available in the amount of \$268,321 and \$245,836, for the years ended November 30, 2024 and 2023, respectively, have been allocated to the accounts of employees who have separated service with the Company. At November 30, 2024 and 2023, the accounts did not include nonvested amounts to be forfeited in later years.

NOTE 8 – RELATED PARTY TRANSACTIONS

The plan assets were managed by John Hancock Life Insurance Company (USA). John Hancock management services include recordkeeping and investment services related to contributions received, plan earnings and distributions. Thiesen Dueker provides investment advisory services. The services to the Plan qualify as party-in-interest transactions.

John Hancock investment advisory expenses totaled \$58,800 and \$50,484, for the years ended November 30, 2024 and 2023, respectively. John Hancock contract administration fees totaled \$39,023 and \$33,446, for the years ended November 30, 2024 and 2023, respectively. Direct compensation paid to John Hancock for services totaled \$908 and \$708, for the years ended November 30, 2024 and 2023, respectively. Third-party administrative services and compensation reported by John Hancock related to the Plan totaled \$13,991 and \$12,155, for the years ended November 30, 2024 and 2023, respectively.

Administrative functions are jointly performed by employees of the Company and the third-party administrator. No employee receives compensation from the Plan. The independent auditor's fees are paid directly by the Company.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
