Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tennsco Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control–related matters that we identified during the audit.

Note 1. Description of Plan

The following description of the Tennsco Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees excluding employees covered under a collective bargaining agreement with Tennsco Corporation (the Employer). Employees are eligible to participate after completing one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC). Participants are eligible to participate on the earliest semi-annual entry date after completing one year of service.

Contributions

A participant can elect to defer annually up to the amount allowed under the current IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Employer shall make matching contributions based on the sum of 100% of the first 6% of salary deferral contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Employer's contribution and Plan earnings and charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contribution plus actual earnings thereon. Vesting in the Employer's matching contribution plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after the first year, 40% vested after the second year, 60% vested after the third year, 80% vested after the fourth year and 100% vested after the fifth year.

Payment of Benefits

Benefit distributions equal to participant account balances are payable to participants or their beneficiaries upon retirement, death, disability, or termination of employment. Participants who remain in the active employment of the Employer beyond normal retirement age must begin receiving benefits by April 1, following the calendar year the participant reaches age 70 1/2. Retirement benefits are payable in the form of a lump sum or a qualified joint and survivor annuity; death benefits are payable in the form of a qualified pre-retirement survivor annuity for a participant with a spouse or as a single lump sum payment to the participant's beneficiary.

Other Distributions

In the event of financial hardship, participants may request a distribution from the Plan to the extent required to satisfy the immediate and heavy financial need of the participant. A description of the criteria to receive a hardship distribution is set forth in the Plan's provisions. Hardship withdrawals are permitted from all vested amounts, including earnings.

Note 1. **Description of Plan**

Forfeited Accounts

Forfeited, nonvested account balances may first be used to reduce Plan expenses and then used to reduce future employer contributions. In 2024, employer contributions were reduced by forfeitures in the amount of \$719.

Note 2. **Summary of Significant Accounting Policies**

Basis of Accounting

The Plan's financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment-related expenses are included in net change in fair value of investments. Member requested services are paid by the participant requesting services.

Note 3. **Certification**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedule was obtained by the Plan Administrator and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (Principal), the custodian of the Plan.

- Investments at fair value
- Investments at contract value
- Net change in fair value of investments
- Interest income

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan's investments in pooled separate accounts are units of an insurance company's pooled accounts valued at the net asset value (NAV) of units of the accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

A majority of the pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled account is named. Certain other pooled separate accounts are target date funds which seek capital appreciation and current income consistent with asset allocations that become more conservative over time to the specified target retirement date.

Note 6. Investments at Contract Value

The Plan investments in various guaranteed investment accounts with Principal Life Insurance Company totaling \$2,981,080 and \$2,991,097 at December 31, 2024 and 2023, respectively. Principal maintains contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The rate credited is the rate in effect on the day when each deposit is directed into the account.

These accounts meet the fully benefit-responsive contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Principal. No events are probable of occurring that would limit the Plan's ability to transact at contract value with Principal or Plan participants.

Note 7. Transfers

Periodically an employee transfers to or from the Plan and the Tennsco Hourly Retirement Savings Plan, a defined contribution plan sponsored by the Employer for collective bargaining employees, due to a change in position. During the year ended December 31, 2024 there were transfers of \$188,928 to the Plan and \$38,196 from the Plan.

Note 8. Related Party and Party-in-interest Transactions

Certain plan investments are managed by Principal. Principal is also the custodian and recordkeeper of the Plan and was paid administrative expenses for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net change in fair value of investments because they are paid through revenue sharing rather than a direct payment.

Note 9. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan under the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 10. Tax Status

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal. Principal received its last opinion letter on June 30, 2020, from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC. The Plan has not applied for a separate determination letter.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

Note 11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 12. Reconciliation with Form 5500

In accordance with US GAAP, investments in guaranteed investment contracts are recorded at contract value. However, the Form 5500 reflects these investments at fair value and includes an adjustment from contract value to fair value as other income on the Form 5500. At December 31, 2024, the fair value of the guaranteed investment contracts was \$2,930,965 and the contract value was \$2,981,080. At December 31, 2023, the fair value of the guaranteed investment contracts was \$2,911,580 and the contract value was \$2,991,097.
