Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of Fund for the city of New York Pension and Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date the financial statements are issued or available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 PLAN DESCRIPTION

The Fund for the city of New York Pension and Profit Sharing Plan (Plan) (Plan) is administered by Fund for the City of New York (Company or Plan Administrator). The following brief description of the Plan is provided for general information purposes only. More complete information is provided in the Plan document that is available from the Company.

General

The Plan is a defined contribution plan covering all eligible employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees, excluding union employees, leased employees, and nonresident aliens, are eligible to participate in the Plan upon completing six consecutive months of employment with at least 500 hours of service.

Contributions

Participants may elect to make pre-tax contributions to the Plan through payroll deductions of up to the maximum amount allowed by law. The Plan also allows participants to transfer funds from other eligible retirement plans into the Plan. Participants who have attained age 50 before the end of the Plan Year are eligible to make catch-up contributions in accordance with, and subject to, Internal Revenue Code (IRC) statutory limits.

The Company will make a matching contribution equal to 10% of compensation provided the participant's elective deferrals equal or exceed 5% of the participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution; (b) Plan earnings; (c) and charged with an allocation of expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become 100% vested in their employer contributions after two years have elapsed from the date of their employment and provided that there are at least 1,000 hours of service in each Plan year.

Forfeitures

Forfeitures resulting from the nonvested portions of participants' accounts who terminate prior to being fully vested are used to reduce employer contributions. At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$4 and \$1, respectively. For the years ended December 31, 2024 and 2023, \$112,424 and \$90,835 were used to reduce employer contributions, respectively.

Investment Options

Upon enrollment in the Plan, participants may direct their employee and Company contributions by percentages into any of the investment options available. Participants can elect to have their contributions deposited into, or account balances transferred to, the TIAA Real Estate Fund, CREF, or the TIAA Traditional Annuity. Participants may change their investment options at their discretion.

Plan Loans

A participant may borrow directly from Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Funds (CREF) an amount not to exceed \$50,000 or a certain percentage of their balance in the TIAA Traditional Annuity. The repayments are made directly to TIAA and CREF. The loans are secured by amounts that will vary depending on the amount of investment that the participant has in the fully allocated contracts. The interest rate is variable and can increase or decrease once per year. Adequate security is required and a portion of the participant's account is reserved, or held as collateral, to cover 110% of the outstanding loan in case of default. The collateral is held in the TIAA Traditional Annuity account as either part of a Group Supplemental Retirement Annuity contract or as a separate Retirement Loan contract. As of December 31, 2024, and 2023, the total outstanding Plan loans collateralized by individual participant accounts were \$135,386 and \$187,379, respectively, of which \$100,987 and \$95,741, respectively, were in default.

Notes Receivable from Participants

Participants may borrow up to a maximum amount equal to the lesser of \$50,000 reduced by the highest outstanding balance of loans from the Plan during the one-year period before a new loan or 50% of their vested account balance. The minimum loan amount allowed is \$1,000. Each loan is secured by the vested balance in the participant's account and bears a commercially reasonable rate of interest. Only three loans per participant can be outstanding at a time. Loans have a maximum term of not more than five years unless the loan is used to acquire the borrower's principal residence. Principal and interest payments must be made through after-tax payroll deductions or by another payment method in accordance with procedures provided by the Plan Administrator.

Benefit Payments

On termination of service, as defined in the Plan, a participant is entitled to receive the vested percentage of their account balance as a lump-sum distribution. Participants with vested balances over \$1,000 may elect to leave their vested balance in the Plan or they may elect a lump sum or other form of payment. For vested balances under \$1,000, if no other form of payment is elected, the vested balance is automatically distributed to the participant. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as April 1 following the calendar year of attaining the age of 72. If participants are still employed by the age of 72, the mandatory distribution date generally is April 1 following the termination date of employment. When a participant dies, the entire amount in the participant's account is distributed to the participant's beneficiary(ies). The normal retirement age is 65, upon which participants become fully vested in all accounts.

In-Service Withdrawals

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account and are subject to income tax withholding. Also, in the event a participant suffers financial hardship, as defined in the Plan Document, the participant may withdraw all or a part of the vested portion of their pretax deferral and Roth accounts. Hardship withdrawals are subject to approval by the Plan Administrator and also subject to income tax withholding and penalties. Participant rollover withdrawals may be made at any time.

Purchase of Annuity Contracts

Participants may elect to enter an annuity contract with TIAA. The annuity contract provides for a guaranteed stream of income for participants over a period of 10 years.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with the accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses and Participant Transaction Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of Plan loans, investment fees, and certain Plan administration fees not covered by the Company are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Company has evaluated its subsequent events and transactions occurring after December 31, 2024 through July 29, 2025, the date that the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE PLAN CUSTODIANS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by TIAA and CREF, the Custodians of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Variable Annuity Contracts – CREF accounts: Valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost. Each account determines its unit value each day. (Level 1 input)

Variable Annuity Contracts – Access annuities: Values are calculated daily and are available on the TIAA website, TIAA.org. The underlying investments are generally valued using market quotations obtained from independent pricing services. (Level 2 input)

Fixed Annuity Contract – The contract is valued based on the accumulated cash contributions plus interest credited to the Plan's contracts, less withdrawals. The contract value approximates a discounted cash flow value. (Level 3 input)

Pooled Separate Accounts – Valued principally using external appraisal, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account (REA) sometimes holds securities as well. These are generally priced using quoted prices in active markets or values obtained from independent pricing sources. Unit values are calculated each day and are posted at TIAA.org. (Level 1 input)

The preceding method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions, as of the termination date. Any unallocated assets of the Plan shall be allocated to participants' accounts and distributed in such a manner as the Plan Document describes.

NOTE 8 TAX STATUS

The Internal Revenue Service (IRS) has determined, and informed the Plan Sponsor by a letter dated October 7, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any periods in progress.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
