Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of G and E Healthcare Services, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of August 21, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 to August 21, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 21, 2024 and December 31, 2023, and for the period January 1, 2024 to August 21, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter

As discussed in Note 1 to the financial statements, as a result of the Plan becoming a Participating Employer in The CONNECTME 401(k) Plan, total plan assets of \$2,883,831 were transferred from the Plan into The CONNECTME 401(k) Plan on August 21, 2024.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. NOTE 1 - DESCRIPTION OF PLAN

G and E Healthcare Services, LLC 401(k) Plan (the Plan) elected to become a Participating Employer in The CONNECTME 401(k) Plan, a multiple employer plan. As a result, the Plan changed its recordkeepers from John Hancock Life Insurance Company U.S.A. (John Hancock) to Transamerica Retirement Solutions LLC (Transamerica). Due to the change in service providers, G and E Healthcare Services LLC dba Astoria Nursing and Rehab Center (the Company) instituted a blackout period from August 21, 2024 through September 20, 2024. During this period, payroll deductions continued to be withheld; however, participants were not able to change their investment allocation, obtain a loan, or withdraw money from the Plan until the end of the blackout period. On August 21, 2024, Plan assets amounting to \$2,883,831 were transferred from John Hancock to Transamerica and invested at the end of the blackout period in investment options provided by Transamerica (default options or investment options requested by the participants).

General

The Plan was a defined contribution plan established effective January 1, 2022. The Plan covered substantially all employees of the Company and its Affiliated Companies. Affiliated Companies were defined as members of a controlled group of companies or other entities that were under common control. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC), and was amended at various dates through August 21, 2024 to comply with applicable laws and regulations.

Plan Administration

The Company was the plan administrator and was responsible for managing the day-to-day operations of the Plan. Nova 401(k) Associates was the third-party administrator. John Hancock was the custodian and recordkeeper of the Plan and was responsible for custody and management of the Plan's assets and for administering all investment transactions directed by the Plan participants.

Contributions

Employees who were at least 21 years old were eligible to participate upon completion of one year of service. All eligible employees were automatically enrolled to defer 4% of their eligible compensation as pre- and/or post-tax contributions.

NOTE 1 - DESCRIPTION OF PLAN – CONTINUED

Contributions – Continued

Employees may have elected not to defer or choose a different percentage of deferral up to 90% of compensation, subject to the IRC limitations, by submitting a new enrollment form. Plan participants over age 50 may have deferred catch-up contributions, subject to the IRC limitations. Participants may have also contributed rollovers representing distributions from other qualified plans into the Plan.

As defined in the Plan, the Company made safe harbor match of the participant's pre-tax and/or Roth elective contributions, dollar for dollar, up to 4% of eligible compensation. Total matching contributions amounted to \$226,639 for the period January 1, 2024 to August 21, 2024.

The Company may have also elected to make other matching and nonelective contributions to the Plan. During the period January 1, 2024 to August 21, 2024, the Company did not make other matching and nonelective contributions to the Plan.

Participants directed the investment of their contributions and their share of the Company's contributions into various investment options offered by the Plan, which consisted of pooled separate accounts with underlying investments in mutual funds.

Vesting

Participants were 100% vested in their salary deferral contributions and in the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's other matching and nonelective contributions and earnings thereon were based on years of continuous service as follows:

Participant Accounts

Separate accounts were maintained for each participant, which were adjusted to reflect the participant's and Company's contributions, as well as the participant's share of the Plan's income and any related administrative expenses.

Notes Receivable from Participants

Participants may have borrowed from their fund accounts a minimum of \$1,000 up to a maximum limited to the lesser of: (1) \$50,000 or (2) 50% of the participant's vested account balance. All notes receivable were adequately secured by the participant's account balance, bore interest as defined by the Adoption Agreement, and generally were repaid on an installment basis through payroll deductions over a period not to exceed five years, except when borrowed funds were used to acquire a principal residence.

Payment of Benefits

Upon termination of service due to death, disability or retirement, the participant or beneficiary may have elected to receive a lump-sum payment. The Plan's normal retirement age was defined by the Plan document.

If the vested account balance of a terminated participant was \$5,000 or less, the entire balance would be paid out. For mandatory distributions in excess of \$1,000, the participant may have elected to either directly transfer the vested account balance to an Individual Retirement Account (IRA) or another qualified plan or receive the vested benefits in a lump-sum payment. If no election was made, vested benefits were transferred to a separate IRA established by the Plan.

Forfeitures

Forfeitures of the unvested balance of terminated participants' accounts were used to reduce the Company's future contributions. No forfeitures were used to reduce the Company's contributions during the period January 1, 2024 to August 21, 2024. As of August 21, 2024 and December 31, 2023, there were no forfeitures available for future use.

Administrative Expenses

All reasonable expenses related to Plan administration were paid from Plan assets, except to the extent expenses were paid by the Company.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (GAAP).

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Use of Estimates

The preparation of financial statements in conformity with GAAP required the plan administrator to make estimates and assumptions that affected the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements, and the reported amounts of additions and deductions during the reporting period. The most important of these estimates and assumptions relate to fair value measurements of the Plan's investments. These and other estimates and assumptions were based on the best available information but actual results could have been materially different from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, were exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities would have occurred in the near term, and such changes could have materially affected the amounts reported in the statements of net assets available for benefits.

Valuation of Investments

Plan assets invested in pooled separate accounts were stated at fair value, which was determined based on the fair value of the underlying mutual funds. Pooled separate accounts have the characteristics of a structure similar to a mutual fund; therefore, as clarified by Financial Accounting Standards Board (FASB) Accounting Standards Update (ASU) 2015-10, *Technical Corrections and Improvements*, its value is considered readily determinable as each account publishes a daily price at the end of each day. There were no imposed redemption or liquidation restrictions on participants, and the Plan had no further contractual obligations to further invest in these accounts. As such, investments in pooled separate accounts were classified in Level 2 of the fair value hierarchy.

Notes Receivable from Participants

Notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded when earned.

Recognition of Income

Sales and purchases were accounted for on a trade date basis, and interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

Net Change in Fair Value of Investments

Net change in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year.

Payment of Benefits

Benefit payments to participants were recorded when paid.

Recent Accounting Pronouncements

In the normal course of business, the Plan evaluated all new accounting pronouncements to determine the potential impact they could have on its financial statements. Based upon this review, the Plan did not expect any of the recently issued accounting pronouncements, which have not already been adopted by the Plan, to have a material impact on its financial statements.

Subsequent Events

The Plan evaluated for recognition or disclosure in these financial statements the subsequent events through the report issuance date and determined that no such events were identified.

NOTE 3 - INCOME TAX STATUS

The Company had adopted a non-standardized pre-approved profit sharing plan that received its latest favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the underlying pre-approved plan document was qualified under Section 401 of the IRC, and that any employer adopting this form of the plan would be considered to have a plan qualified under Section 401(a) of the IRC. Once qualified, the Plan was required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes that, except as disclosed in Note 7, the Plan operated in accordance with applicable provisions of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

NOTE 3 - INCOME TAX STATUS – CONTINUED

In accordance with GAAP, Plan management was required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position were recognized when the position was more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator had analyzed the tax positions taken by the Plan and had concluded that as of August 21, 2024, there were no uncertain positions taken or expected to be taken. As a result, the Plan has recognized no interest or penalties related to uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of August 21, 2024 and December 31, 2023, and the related investment activity reflected in the accompanying statement of changes in net assets available for benefits for the period January 1, 2024 to August 21, 2024.

The fair value hierarchy prioritized the inputs to valuation techniques used to measure fair value into three levels, with the highest priority given to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority given to unobservable inputs (Level 3). The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one level to another. In such instances, the transfer is reported at the end of the reporting period. There were no changes in the valuation methodologies used to value the Plan's assets at fair value as of August 21, 2024 and December 31, 2023, and there were no significant transfers in or out of Levels 1, 2, or 3.
