Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Art's Rental Equipment, Inc. 401(k) Retirement Savings Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. PLAN DESCRIPTION:

The following description of Art's Rental Equipment Inc. (the "Company" or "Employer") 401(k) Retirement Savings Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees who have completed one year of service, as defined, and attained 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2025, the Plan is amended to reduce the age requirement to participate in the plan to 19 years of age.

Contributions

Each participant may make voluntary pre-tax or Roth contributions to the Plan by an employee salary reduction election subject to maximum dollar limitations as defined in the Internal Revenue Code (IRC). Participants may elect to roll over distributions from other qualified plans. The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Effective January 1, 2025, the Plan is amended to increase the initial automatic enrollment deferral percentage to 6%. For participants subject to auto-enrollment, the automatic deferral percentage escalates by 1% annually until the maximum automatic deferral percentage of 10% of eligible compensation is reached.

The Plan allows the Company to make discretionary matching and non-elective contributions. In 2024, the Company made discretionary matching contributions equal to 40% of the first 10% of the participant's contributed compensation. For the year ended December 31, 2024, the Company made a \$1,000,000 discretionary non-elective profit sharing contribution to the Plan.

Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) plan earnings, and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits

Upon a participant's death, total and permanent disability, other termination of employment with the Company, or early retirement at the later of age 55 or completion of 6 years of service, the participant's account may be distributed under several options. If a terminated participant's vested interest is greater than \$1,000, the participant may choose to receive his or her benefit in a lump sum, a direct rollover to another qualified retirement account or postpone the distribution until the required beginning date, as defined. If the vested interest is \$1,000 or less, the payment is in the form of a lump sum payment, payable at termination.

In conditions of "financial hardship," a participant may apply to the plan administrator for approval to withdraw that portion of their account balance limited to the participant's elective deferred account necessary to meet the financial hardship, subject to the limitations of the Plan and the IRC.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. Participants are fully vested upon completion of six years of credited service, vesting 20% per year after two years of credited service.

Forfeitures

Forfeitures may be used to reduce plan expenses and to reduce employer contributions made by the Company. There were forfeited nonvested accounts of \$20,582 and \$16,839 at December 31, 2024 and 2023, respectively. During 2024, \$13,500 of forfeitures were used to pay Plan administrative expenses and \$35 were used to reduce employer contributions.

Notes receivable from participants

Within certain limitations and upon approval by the plan administrator, the Plan allows a participant to borrow up to the lesser of \$50,000 or 50% of the participant's vested account balance excluding the employer profit sharing money type source. The notes bear interest at rates commensurate with local prevailing rates as determined by the plan administrator over not more than a five-year term, unless the loan is utilized for the purchase of the participant's primary residence, in which case it may have up to a 30 year term. Principal and interest are paid ratably through payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Benefit payments

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The plan administrator has evaluated the impact of events that have occurred subsequent to December 31, 2024, through September 8, 2025, the date the financial statements were available to be issued, for purposes of recognition and disclosure in the financial statements.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the custodian, has certified the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Units of the common collective trust are valued at NAV as calculated by Empower Trust Company. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the common collective trust less any liabilities. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments related to the common collective trust and units are redeemable at NAV. The Morley Stable Value Fund is comprised primarily of fully benefit-responsive investment contracts, thus the Plan has an indirect investment in those investment contracts.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

5. TAX STATUS:

The Plan adopted a non-standardized pre-approved profit-sharing/money purchase 401(k) plan sponsored by Empower Retirement, LLC. The Plan document received an opinion letter dated November 14, 2022, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan document has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

Certain plan investments are managed or issued by Empower Trust Company, LLC (Empower), who is the custodian of the Plan, or affiliates of Empower. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management and advisory services are included in administrative expenses.

The Company provides certain administrative services to the Plan. These services include plan oversight and day-to-day plan administration. The Company did not charge the Plan for these services or other administrative expenses.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

9. SUBSEQUENT EVENT:

The Plan was amended effective August 1, 2025: 1) to redefine early retirement as the later of age 62 or completion of 5 years of service; 2) to allow a participant to withdraw all or a portion of his or her vested account balance prior to termination from employment upon attaining age 59 ½; 3) to change the force out limit from \$1,000 to \$7,000, and if the vested interest is \$7,000 or less, the payment is in the form of a rollover to an individual retirement account (IRA); and 4) to permit in-service withdrawals for a qualified birth or adoption of a child.
