NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following brief description of the Foodlink, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. For a more complete description of the Plan's provisions, participants should refer to the Plan document.

General

The Plan is a defined contribution plan available to all employees of Foodlink, Inc. (Foodlink) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

Foodlink is the sponsor of the Plan. The Plan Administrator is a committee appointed by the Plan Sponsor. Effective August 1, 2022, Great-West Trust Company, LLC was renamed Empower Trust Company, LLC (Empower). Empower Trust Company, LLC serves as the trustee and custodian of the Plan's assets and Empower Retirement, LLC provides recordkeeping functions for the Plan. The annuity contract described in Note 2 is issued by and certified by Empower Annuity Insurance Company (EAIC).

Eligibility

All non-union employees of Foodlink who have attained the age of 18 are eligible to participate in the Plan. Non-union employees become eligible for employer contributions after one year of service in which the employee is credited with 1,000 hours of service, provided they are actively employed on the last day of the Plan year. Union employees and non-resident aliens are not eligible to participate in the Plan. During 2024 and 2023, Foodlink did not have any union employees.

Participant Contributions

Active participants may make voluntary contributions in the form of salary reductions and any applicable rollovers from qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (the Code) under Section 401(k). Eligible participants, who attain the age of 50 by the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the Code.

Eligible participants are automatically enrolled with a deferral of 1% from the participant's compensation each payroll period unless the participant makes a contrary election.

Employer Contributions

Foodlink makes safe harbor contributions equal to 100% of participant's elective deferrals up to a maximum of 5% of the participant's compensation for participants who worked a minimum of 1,000 hours and one year of consecutive service.

Further, at its discretion, Foodlink may make employer contributions to participants of the Plan. In 2024 and 2023, Foodlink made a non-elective contribution at a rate of 2% of each participant's compensation per payroll period for participants who worked a minimum of 1,000 hours and one year of consecutive service.

1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, Foodlink's employer contribution, if any, and allocation of the Plan's earnings/losses on all contributions. Allocations of earnings/losses and administrative expenses are based on participant account balances according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their account balance, which includes voluntary contributions, Foodlink's contributions, and actual earnings/losses thereon.

Payment of Benefits

Vested funds are paid to participants upon either termination of employment, or the attainment of age 59 1/2. Benefits are paid in lump sum withdrawals or in periodic installments over a period that is not greater than or equal to the life expectancy of the participant. The plan administrator will make a mandatory distribution for participant account balances below \$5,000 following severance from employment.

Notes Receivable from Participants

Participants may borrow up to the lesser of (1) 50% of their vested account balances or (2) \$50,000 reduced by the highest loan balance during the 12-month period ending on the day before the date on which the loan was made. A participant may borrow a minimum of \$1,000. Loans are repayable through payroll deductions over not more than five years, except in the case of a loan taken for the purpose of purchasing a primary residence. All loans bear interest at the prime rate plus 1%. Defaulted loans are deemed as distributions to the extent the law allows.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with Internal Revenue Service rules relating to hardships, which are uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Investments and Income Recognition

Investments are reported at fair value, except for fully-benefit responsive fixed annuity contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully-benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments and Income Recognition (Continued)

Investment income recognized by the Plan includes earnings from investments, net gains (losses) realized from the sale of investments, and the net changes in the unrealized appreciation (depreciation) in fair value of investments.

All investments are participant directed.

Annuity Contracts

The Plan has a group fixed annuity contract through EAIC which is established in the Key Guaranteed Portfolio Fund. The contract is considered a fully benefit responsive investment contract. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by Empower at rates determined quarterly. Crediting rates ranged from 1.35% to 1.45% for 2024 and 1.15% to 1.30% for 2023.

Fair Value Measurement

Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 Inputs – Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 Inputs – Valuations are based on quote prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs – Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Mutual Funds: These are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The mutual funds held by the Plan are deemed to be actively traded.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement (Continued)

A description of where the Plan's investments fall within the fair value hierarchy is provided in Note 4. There were no changes in valuation methodologies used during 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by Foodlink and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

3. CERTIFIED INVESTMENT INFORMATION

The Plan's trustee and custodian, Empower, as well as EAIC, furnished certain financial information to the plan administrator, and certified as to its completeness and accuracy.

The Plan Administrator assesses the fair value measurements used by the insurance companies and custodians. Annually, the plan administrator, together with the insurance companies and custodians, determines if the current valuation techniques used in the fair value measurements are still appropriate.

5. PARTY-IN-INTEREST TRANSACTIONS

Empower is the trustee and custodian of the Plan's assets and Empower Retirement, LLC is the recordkeeper of the Plan's assets. As such, transactions between Empower, Empower Retirement, LLC, and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants qualify as party-in-interest transactions. The annuity contract issued by EAIC also qualifies as party-in-interest transactions.

6. PLAN TERMINATION

Although they have not expressed any intent to do so, Foodlink has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would remain 100% vested in their employer contributions.

7. INCOME TAX STATUS

The Plan adopted a prototype plan offered by Empower Retirement, LLC. The prototype plan received an IRS Opinion Letter dated November 14, 2022, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income tax has been included in the Plan's financial statements.

8. RECONCILIATION TO FORM 5500

Certain items may have been classified differently between the financial statements and Form 5500. Net assets available for benefits agreed to Form 5500 in total as of 2024 and 2023. Changes in net assets available for benefits per the financial statements agree to Form 5500 in total for the year ended 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 5, 2025, which is the date the financial statements were available to be issued.
