Report of Independent Auditors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The TCMI, Inc. 401(k) Profit Sharing Plan (the "Plan") was established on June 26, 1995 and amended and restated as of April 1, 2019, January 1, 2020, and again on May 25, 2022. The Plan covers eligible employees of TCMI, Inc. (collectively, the "Company").

The Plan, which is a defined contribution plan under the Employee Retirement Income Security Act of 1974 ("ERISA"), is administered by the trustee appointed by the Board of Directors of the Company.

Participant Eligibility

There are no service requirements for elective deferral contributions; thus, all employees, ages 21 and over, are eligible to participate upon employment.

Contributions

The Plan participants may elect to defer not less than 1% of eligible compensation and not more than 90% of eligible compensation on a pre-tax basis or post-tax basis under Section 401(k) or Section 402A, respectively, of the Internal Revenue Code (the "Code"). Pre-tax and post-tax contributions were limited to a maximum of \$23,000 for the year ended December 31, 2024, or such other limit prescribed by Section 402 of the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for the year ended December 31, 2024. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant. All contributions are made through payroll deductions and can be changed or stopped at any time. Rollover contributions from other qualified plans or annuity contracts are permitted.

Company Match, Profit Sharing and Safe Harbor Contribution

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of matched employee contributions. Each year, the Company will determine the formula for the discretionary matching contribution. For the Plan year ended December 31, 2024, the Company elected not to make a matching contribution.

The Company may also make a safe harbor non-elective contribution to the account of each eligible participant in an amount not less than 3% of the eligible participant's Plan compensation for the plan year. The Plan did not utilize the Safe Harbor for the year ended December 31, 2024.

Company Match, Profit Sharing and Safe Harbor Contribution (Continued)

The Company may also make a discretionary profit-sharing contribution in an amount as determined by the Company. In order to share in the allocation of the profit-sharing contributions, a participant is required to be employed by the company on the last day of the plan year. The Company selected "New Comparability - One Group per Participant" as the allocation method used for the profit-sharing contribution. Under this method the profit-sharing contribution shall be allocated to each group designated by the Company. There shall be one group created for each participant eligible to receive allocations and the contribution shall be allocated in a manner determined by the Company. The amount allocated to one group need not bear any relationship to amounts allocated to any other group. For the Plan years ended December 31, 2024, the Company's profit-sharing contributions amounted to \$1,038,877 (\$1,098,617 in 2023), and the amount allocated to participants after utilizing forfeitures amounted to \$1,002,419 (\$1,038,105 in 2023). As of December 31, 2024, the Company's profit-sharing contributions were outstanding and are recorded as a receivable on the statement of net assets available for benefits.

Vesting

Participants are 100% vested in the value of their cumulative contributions and earnings thereon. Vesting in the value of the Company contributions and earnings thereon is subject to years of service with 100% vesting at 3 years of service and 75% at 2 years of service. If a participant terminates his or her employment with the Company, the non-vested portion of company contributions is forfeited. Such forfeitures are used to reduce future Company contributions and plan expenses.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution (if any) and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. The expenses charged to the Plan may be charged pro rata to each participant in relation to the size of each participant's account balance or may be charged equally to each participant.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or elect partial payments over time. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Notes Receivable from Participants

Participants may borrow against their individual accounts under certain conditions. Participant loans range between a minimum of \$1,000 and a maximum of the smaller of \$50,000 or 50% of the employee's vested account balance. Participant loans carry an interest rate of prime plus 1% and must be repaid within five years or a period not to exceed ten years if such loan is to be used for the purchase of a participant's principal residence. Participants may only have two loans outstanding at any time. No allowance for credit losses has been recorded as of December 31, 2024.

Forfeited Accounts

At December 31, 2024, forfeited non-vested accounts amounted to \$36,457 (\$60,512 in 2023). These accounts will be used to reduce future employer contributions and plan expenses. Employer contributions allocated to participants during 2024 were reduced by funds from the forfeited non-vested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Plan Terminations

The Company intends to continue the Plan indefinitely; however, it may discontinue its contributions and terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all participants have a non-forfeitable right to the entire value of their accounts.

Basis of Accounting - GAAP

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with generally accepted accounting principles.

Risks and Uncertainties

The assets of the Plan are primarily financial instruments which are monetary in nature. Accordingly, interest rates have a more significant impact on the Plan's performance than do the effects of general levels of inflation. Interest rates generally do not move in the same direction or with the same magnitude as prices of goods and services as measured by the consumer price index. Investments are subject to risk conditions of the individual investment's objectives, stock market performance, interest rates, economic conditions, and world affairs. Due to the level of risk associated with the Plan's investments, it is reasonably possible that changes in the values of the Plan's investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires Plan administrators to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

3. FAIR VALUE MEASUREMENTS

ASC 820 establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded and are classified within Level 1 of the valuation hierarchy.

Money Market Funds: Valued based on the funds' reported closing net asset value ("NAV") as of the last business day of the plan year. The money market funds held by the Plan are considered to be actively traded and are classified within Level 1 of the valuation hierarchy.

Collective Investment Trust Funds: The fair value of collective investment trust (CIT) funds are based on the readily available net asset value (NAV) of the shares as reported by the fund. The CITs held by the Plan are considered to be actively traded among employee benefit plans and are classified within Level 1 of the valuation hierarchy.

3. FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INCOME TAX STATUS

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the plan is qualified under Section 401 of the Internal Revenue Code (the Code) and therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to and has chosen to rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's record keeper and Trustee are Fidelity Investments Institutional Operations Company, Inc. (FIIOC) and Fidelity Management Trust Company (FMTC), respectively. Both FIIOC and FMTC are related parties to the Plan. In addition, investment transactions with Fidelity and certain administrative expenses paid directly by the Company qualify as party-in-interest transactions.

Payment of a management fee to the Company with respect to the interests held by the Plan would be a prohibited transaction under ERISA; however, the Company does not receive a management fee with respect to shares of any Company managed-CIT that are held by the Plan.

6. INFORMATION CERTIFIED BY TRUSTEE

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the current trustee of the Plan).
