Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following description of Cedar River Contracting, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Cedar River Contracting, Inc. and its wholly owned subsidiary, K & W Electric, Inc. (the Company). The Plan is subject to the provisions of ERISA.

Eligibility: Employees may enter the Plan on the first of the month following the date they become eligible. Employees age 18 and older are immediately eligible for participation in the Plan. Participants become eligible for the employer match the first of the month following six months of service and become eligible for discretionary profit sharing employer contributions the first of the month following 12 months of service.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. Participants may elect to defer from their compensation, as defined by the Plan, not to exceed the limits of Internal Revenue Code (IRC) Section 401(k). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants are automatically enrolled at 3% of their eligible compensation unless they make an affirmative election otherwise. The Company may elect each Plan year whether to make matching contributions and determine the amount of matching contributions it wishes to contribute. Matching contributions for the year ended December 31, 2024 were 100% of the first 3% of eligible compensation. The Company may also make additional discretionary profit sharing contributions to the Plan. No discretionary contributions were made during the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of: (a) the Company's contribution and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on the participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions and any rollovers plus actual earnings thereon. Vesting in the matching and profit sharing contributions is based on a six-year graded vesting schedule. Participants vest 20% for each year of service in which they work over 1,000 hours, beginning with the second year. A participant becomes fully vested after six years of service or upon death, permanent disability or reaching normal retirement age.

Notes receivable from participants: Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. A maximum of two notes receivable outstanding are available per participant at any given time. The notes receivable are secured by the balance in the participant's account, bear interest at a rate reasonable to rate charged by commercial lenders and have a term of five to 10 years. Principal and interest are paid ratably through payroll deductions. Notes receivable are only available for a financial hardship and the amount borrowed is limited to the amount needed for the financial hardship. There were no notes receivable outstanding at December 31, 2024 and 2023.

Investment options: Upon enrollment in the Plan, a participant may direct the investment of employee and employer contributions among any or all of the investment options offered by the Plan. Deferral percentages and investment allocations may be changed at any time.

Note 1. Plan Description (Continued)

Payments of benefits: Distributions may be made after a participant's retirement, termination of employment, death, disability or approved hardship. On termination of service, if the participant's vested account balance is greater than \$7,000, participants may elect from various payment options.

If the vested balance is less than \$7,000, but greater than \$1,000, the balance will automatically roll over into an individual retirement account. For balances less than \$1,000, the participant must receive a lump-sum distribution.

Forfeitures: Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to offset future employer contributions, pay administrative expenses or be allocated to participants. Forfeitures used to pay administrative expenses totaled \$20,323 for the year ended December 31, 2024. Forfeitures available for the Plan's benefit were \$868 and \$553 as of December 31, 2024 and 2023, respectively.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Valuation of investments and income recognition: Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of benefits: Benefit payments to participants are recorded upon distribution.

Note 2. Significant Accounting Policies (Continued)

Uncertain tax positions: U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events: Management has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to a participant's account will become 100% vested.

Note 4. Information Certified or Provided by the Custodian

Note 5. Investments and Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued based on quoted market prices in the active markets in which they are traded.

Collective trust funds: Collective trust funds are valued at the net asset value (NAV) of shares held by the Plan in the collective trust fund at year-end as determined by the custodian based on the market value of its underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
