INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Murray Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Murray Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Murray Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General Information

The Murray Company 401(k) Plan is a defined contribution plan providing retirement income, disability, termination and death benefits to eligible employees. The Plan was adopted effective January 1, 1997 with a year end of December 31. The Plan is administered by Murray Plumbing and Heating Corporation (the Company). The Plan consists of a tax deferred savings program (401(k)) and a discretionary contribution profit sharing program. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended and restated effective February 18, 2022, to comply with various legislative and regulatory changes. The Company believes that the provisions under the new plan document are in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Effective May 1, 2024, the Plan has adopted Federally Declared Disaster Loans and Domestic Abuse withdrawal option as a follow-up to the 2019 Setting Every Community Up for Retirement Enhancement Act (the "SECURE Act"), the SECURE 2.0 Act of 2022 was signed into law on December 29, 2022.

Eligibility

Employees (except union employees, non-resident aliens, and leased employees) are eligible to participate in the Plan when they have completed three months of service. Participation begins on the first day of the quarter immediately following the completion of the participation requirements.

Contributions

Participants may contribute elective deferrals up to the maximum limits established annually by the Internal Revenue Service (IRS). Participants who are age 50 or older and qualify for catch-up contributions may contribute additional amounts as permitted by law. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year, the Company may elect to make a discretionary employer matching contributions allocated to eligible participants based on plan year compensation. The Company has elected to make qualified matching contributions dollar for dollar not to exceed 3% of eligible compensation.

For the year ended December 31, 2024, total matching contributions was \$1,116,913.

Participant Accounts

A participant's account is credited with the participant's contributions, employer matching contributions and an allocation of plan earnings, and charged with plan losses and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocation of additional discretionary employer contributions, if any, will be made based upon a participant's proportionate share of total compensation paid during the year to all participants in the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions plus actual earnings thereon is based on years of service according to the following schedule:

Forfeitures

Forfeitures of non-vested employer contributions are retained in the Plan and may be used to pay Plan expenses first, and to reduce future employer contributions with any remaining funds. For the year ending December 31, 2024, \$5,381 of forfeitures were used to pay Plan expenses and \$107,840 of forfeitures were used to reduce employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$5 respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance reduced by the highest previous loan balance. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at 2% above the prime rate, as defined. Loans are available with terms up to 10 years only if the purpose is to purchase a primary residence.

Effective May 1, 2024, the Plan permits loans of a Participant's Vested Account balance in the event of a federally declared disaster. For such loans, a participant may borrow up to the lesser of \$100,000 or 100% of their vested account. Loan payments for such loans may be delayed for one year. This period is disregarded in determining the loan term, including the five year maximum.

Payment of Benefits

The Plan provides for the payment of benefits to the participant or beneficiary at retirement, death, disability or termination of employment, equal to the value of the participant's vested account balance. Participants terminating their employment with the Company or attaining age 59 1/2 are entitled to withdraw all or a portion of their vested account balance. Additionally, under certain circumstances of financial hardship, participants are allowed to withdraw funds from the Plan equal to the value of their vested account balance.

If a participant's terminated employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. Effective January 1, 2024, the SECURE 2.0 Act raised the statutory limit for mandatory cash-outs to \$7,000.

Effective May 1, 2024, the Plan permits the withdrawal of a Participant's Vested Account in the event of a federally declared disaster. A Participant may receive up to \$22,000 in aggregate for each deferrably declared disaster. In addition, the Plan permits the withdrawal of a Participant's Vested Account if the participant is a victim of domestic abuse. A domestic abuse withdrawal shall not exceed an amount equal to the lesser of (i) \$10,000 in aggregate, or (ii) 50% of the Participant's Vested Account in the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that may affect the reporting amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from such estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is shown on an accrual basis from participant notes.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as

administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Most expenses related to investment management and other investment related expenses are paid by the Plan. Loan fees and some administrative fees are paid by plan participants. Administrative fees for all terminated participants are paid by the participant.

NOTE 3 - SUMMARY OF FINANCIAL DATA CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company dba Principal Trust Company (the asset custodian of the Plan).

As permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to the certified investment information.

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV which is based on the market value of its underlying investments. The Plan offers funds that are common collective trusts. These funds are collective investment trusts that contain synthetic investment contracts comprised of both underlying investment and contractual components which have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. NAV is used as an estimate of fair value, as the

reporting entity has the ability to redeem its investment at NAV as of the measurement date as collective investment trusts can be redeemed on a daily basis. NAV is a readily determinable fair value and is the basis for current transactions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

During the 2023 Plan year, the Plan entered into a group annuity contract with Principal Life Insurance Company (Principal Life) through the investment in the Principal Fixed Income Guaranteed Option investment. This group annuity contract provides an interest rate guaranteed for a set period of time by the Principal Life. It is backed by the multi-billion-dollar general account of Principal Life, which invests in corporate bonds, asset-backed securities, commercial real-estate mortgages, government bonds, and short-term cash equivalents. The guaranteed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to never be less than zero percent. The crediting rate is determined based on the earnings of the underlying assets in the entire portfolio compared to the minimum interest crediting rate, as stated in the contract, and the prevailing market conditions. The contract value of the insurance contract at December 31, 2024 and 2023, were \$3,244,481 and \$717,481, respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including partial or total plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - RELATED PARTY TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan issues loans to participants which are secured by the balances in participants' accounts. Plan participants have paid fees for loan and distribution processing. In addition, the Plan paid investment advisory fees. The Company paid certain administrative expenses of the Plan, including recordkeeping and audit fees. These transactions qualify as party in interest transactions for which a statutory exemption exists.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, affected participants will become 100% vested in their accounts.

NOTE 8 - TAX STATUS

As of February 1, 2017 the Company adopted a Volume Submitter Profit Sharing Plan (the VSPS Plan) sponsored by Principal Life Insurance Company. The Internal Revenue Service has determined and informed the Trustee by a favorable opinion letter dated June 30, 2020, that the VSPS Plan is designed in accordance with the applicable sections of the IRC. The VSPS Plan's opinion letter is being relied on by

the Plan. Although the Plan has been amended since receiving the opinion letter, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. A routine examination by the IRS on the Plan for the 2019 plan year was conducted in 2022 and closed out in 2023 with the tax returns accepted as filed. There are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 9, 2025 the date the financial statements were available to be issued and concluded that there were no other events that require recording or disclosure in the financial statements as of December 31, 2024.
