### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements***

We have performed an audit of the financial statements of Leyden Family Service and Mental Health Center Tax Sheltered Annuity Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2022 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended June 30, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion on the 2022 Financial Statements***

### ***Responsibilities of Management for the 2022 Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Leyden Family Service and Mental Health Center Tax Sheltered Annuity Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the 2022 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matters***

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

### ***Auditor's Report on the 2021 Financial Statements***

We were engaged to audit the 2021 financial statements of the Leyden Family Service and Mental Health Center Tax Sheltered Annuity Plan. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information certified by qualified institutions.

Department of Labor Rules and Regulations and generally accepted accounting principles require plan investments to be valued at fair value as of the end of the plan year. As described in Note 6, plan management did not have adequate procedures to properly value certain investments as of June 30, 2021, and therefore these investments may not have been presented in compliance with Department of Labor Rules and Regulations or in conformity with general accepted accounting principles. The effects on the 2021 financial statements and supplemental schedule of not applying adequate procedures to determine the fair value of these investments was not determined. Our disclaimer of opinion was not modified with respect to this matter.

In our report dated April 15, 2022, we indicated that because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2021 financial statements.

**Note 1. Description of Plan**

The following description of Leyden Family Service and Mental Health Center Tax Sheltered Annuity Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan, adopted on July 1, 1976, and restated on January 1, 2009, is a defined contribution 403(b) plan sponsored by Leyden Family Service and Mental Health Center (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended by subsequent legislation.

All full-time employees who have attained the age of 18 and are not part of an excluded class are eligible to participate in the Plan upon their hire date.

***Contributions***

Each year participants may contribute a percentage or fixed amount of their annual compensation, as defined in the Plan. Contributions can be made on a before-tax basis only, and participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan from other qualified plan distributions. Contributions are subject to certain limitations.

Brighthouse Life Insurance Company (Brighthouse), The Nationwide Financial Services, Inc. (Nationwide) and Zurich American Life Insurance Company (Kemper) have established annuity contracts for each participant in which subaccounts have been established, representing pooled separate accounts as investment options. Participant contributions are allocated to a variety of investments. Participants may direct the investment of their accounts among any of the designated Brighthouse, Nationwide and Kemper investment funds and may change their investment selections in these funds at their discretion.

The Company will make a discretionary contribution to participants who meet the eligibility requirements and have attained the age of 18. For 2022 and 2021, the match was 100% of elective deferral contributions up to 5% of a participant's compensation.

***Participant Accounts***

Each participant's self-directed account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings (losses) and charged with an allocation of any fees. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Notes Receivable From Participants***

A participant may borrow an amount equal to the lesser of \$50,000 or 50% of his or her vested account balance with a minimum loan of \$1,000. Loans are repaid over periods ranging from 60 months or up to 180 months if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account. The loan interest rate is set at one percent above the prime rate or insurance company rate, as defined. Loans are granted in accordance with the terms set forth in the plan document. Principal and interest is paid ratably through payroll deductions.

***Vesting***

Participants are immediately vested in their contributions and Company contributions plus actual earnings thereon.

***Payment of Benefits***

Participants may request a distribution of their available account balance. Distributions will be made upon severance of employment, disability, retirement or to meet a financial hardship. The distribution of a participant's account is payable at his/her option in either a lump sum, installment payments, the purchase of an annuity contract or a rollover into a qualified plan or IRA.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Units of pooled separate accounts are stated at an estimated fair value as provided by the issuing insurance company. Shares of registered investment companies are valued at quoted market prices. The guaranteed income funds are presented at fair value, represented by the principal balance of the investment contracts, plus accrued interest at the stated contract rate, less any payments received and contract charges by the insurance company. The interest rate is determined semiannually based on the insurance company's applicable rate schedule.

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Purchases and sales of securities are reflected on a trade-date basis. The realized gains or losses on the sale of securities are based on average cost. Income (loss) from investments is recorded as earned on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought, sold, as well as held, during the year. Dividends are recorded on the ex-dividend date.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain administrative expenses are paid by the Company on behalf of the Plan. Additionally, certain employees of the Plan provide administrative and trustee services to the Plan and are not reimbursed by

the Plan for such services. Certain investment advisor fees are netted in the depreciation in fair value of investments.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Note 3. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the overall fair value measurement

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2022 and 2021.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The fair value of participation units held by the Plan in pooled separate accounts is based on their estimated fair value, as reported by the trustees and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The fair value of pooled separate accounts that invest only in securities traded on nationally recognized securities exchanges and active dealer markets are classified with Level 2 of the fair value hierarchy (Level 2 inputs).

The fair value of the Plan's guaranteed income funds has been estimated utilizing current rates of return available for similar funds, with comparable credit risk and liquidity, as of the respective financial statement date (Level 3 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Investment Contracts With Trustees**

The Plan entered into various group annuity contracts with the trustees who maintain the contributions in a general account. The account is credited with earnings (losses) on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contracts are reported at fair value on the statements of net assets available for benefits. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with the trustees. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The average yield and crediting interest rates were 2.62% and 3.53% for the years ended June 30, 2022 and 2021, respectively.

**Note 5. Information Prepared and Certified by Trustees**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103 (a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company, FSB, Nationwide Life Insurance Company, Brighthouse Life Insurance Company, Metropolitan Life Insurance Company, and Commonwealth Annuity and Life Insurance Company (as administrator for Zurich American Life Insurance Company), qualified institutions, have certified the following information included in the accompanying financial statements and ERISA- required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2022 and 2021
- Investment income (loss) components and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2022
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of June 30, 2022

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 6. Unaudited Investments**

Investments held by Kemper in the amount of \$224,982 at June 30, 2021, were not certified. The investments and related investment income were not subjected to additional audit procedures because Kemper did not provide the required information for the Plan's independent auditors to perform such procedures.

**Note 7. Transactions With Parties-in-Interest**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are units in pooled separate accounts, registered investment companies and guaranteed income funds managed by the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$1,614 of fees to the trustees during the year ended June 30, 2022.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 9. Tax Status**

The Plan operates under an adoption agreement in connection with a volume submitter 403(b) plan sponsored by FIS Business Systems LLC. This volume submitter 403(b) plan has been filed with the appropriate agency and has obtained an opinion letter dated March 31, 2017, from the Internal Revenue Service stating that the volume submitter 403(b) plan constitutes a qualified plan under Section 403(b) of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through August 7, 2025, which is the date the financial statements were available to be issued.

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements***

We have performed an audit of the financial statements of Leyden Family Service and Mental Health Center Tax Sheltered Annuity Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2022 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended June 30, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion on the 2022 Financial Statements***

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section:

### ***Responsibilities of Management for the 2022 Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Leyden Family Service and Mental Health Center Tax Sheltered Annuity Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the 2022 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matters***

#### ***2022 Supplemental Schedules Required by ERISA***

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

### ***Auditor's Report on the 2021 Financial Statements***

We were engaged to audit the 2021 financial statements of the Leyden Family Service and Mental Health Center Tax Sheltered Annuity Plan. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information certified by qualified institutions.

Department of Labor Rules and Regulations and generally accepted accounting principles require plan investments to be valued at fair value as of the end of the plan year. As described in Note 6, plan management did not have adequate procedures to properly value certain investments as of June 30, 2021, and therefore these investments may not have been presented in compliance with Department of Labor Rules and Regulations or in conformity with general accepted accounting principles. The effects on the 2021 financial statements and supplemental schedule of not applying adequate procedures to determine the fair value of these investments was not determined. Our disclaimer of opinion was not modified with respect to this matter.

In our report dated April 15, 2022, we indicated that because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2021 financial statements.

**Note 1. Description of Plan**

The following description of Leyden Family Service and Mental Health Center Tax Sheltered Annuity Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan, adopted on July 1, 1976, and restated on January 1, 2009, is a defined contribution 403(b) plan sponsored by Leyden Family Service and Mental Health Center (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended by subsequent legislation.

All full-time employees who have attained the age of 18 and are not part of an excluded class are eligible to participate in the Plan upon their hire date.

***Contributions***

Each year participants may contribute a percentage or fixed amount of their annual compensation, as defined in the Plan. Contributions can be made on a before-tax basis only, and participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan from other qualified plan distributions. Contributions are subject to certain limitations.

Brighthouse Life Insurance Company (Brighthouse), The Nationwide Financial Services, Inc. (Nationwide) and Zurich American Life Insurance Company (Kemper) have established annuity contracts for each participant in which subaccounts have been established, representing pooled separate accounts as investment options. Participant contributions are allocated to a variety of investments. Participants may direct the investment of their accounts among any of the designated Brighthouse, Nationwide and Kemper investment funds and may change their investment selections in these funds at their discretion.

The Company will make a discretionary contribution to participants who meet the eligibility requirements and have attained the age of 18. For 2022 and 2021, the match was 100% of elective deferral contributions up to 5% of a participant's compensation.

***Participant Accounts***

Each participant's self-directed account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings (losses) and charged with an allocation of any fees. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Notes Receivable From Participants***

A participant may borrow an amount equal to the lesser of \$50,000 or 50% of his or her vested account balance with a minimum loan of \$1,000. Loans are repaid over periods ranging from 60 months or up to 180 months if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account. The loan interest rate is set at one percent above the prime rate or insurance company rate, as defined. Loans are granted in accordance with the terms set forth in the plan document. Principal and interest is paid ratably through payroll deductions.

***Vesting***

Participants are immediately vested in their contributions and Company contributions plus actual earnings thereon.

***Payment of Benefits***

Participants may request a distribution of their available account balance. Distributions will be made upon severance of employment, disability, retirement or to meet a financial hardship. The distribution of a participant's account is payable at his/her option in either a lump sum, installment payments, the purchase of an annuity contract or a rollover into a qualified plan or IRA.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Units of pooled separate accounts are stated at an estimated fair value as provided by the issuing insurance company. Shares of registered investment companies are valued at quoted market prices. The guaranteed income funds are presented at fair value, represented by the principal balance of the investment contracts, plus accrued interest at the stated contract rate, less any payments received and contract charges by the insurance company. The interest rate is determined semiannually based on the insurance company's applicable rate schedule.

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Purchases and sales of securities are reflected on a trade-date basis. The realized gains or losses on the sale of securities are based on average cost. Income (loss) from investments is recorded as earned on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought, sold, as well as held, during the year. Dividends are recorded on the ex-dividend date.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain administrative expenses are paid by the Company on behalf of the Plan. Additionally, certain employees of the Plan provide administrative and trustee services to the Plan and are not reimbursed by

the Plan for such services. Certain investment advisor fees are netted in the depreciation in fair value of investments.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Note 3. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the overall fair value measurement

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2022 and 2021.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The fair value of participation units held by the Plan in pooled separate accounts is based on their estimated fair value, as reported by the trustees and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The fair value of pooled separate accounts that invest only in securities traded on nationally recognized securities exchanges and active dealer markets are classified with Level 2 of the fair value hierarchy (Level 2 inputs).

The fair value of the Plan's guaranteed income funds has been estimated utilizing current rates of return available for similar funds, with comparable credit risk and liquidity, as of the respective financial statement date (Level 3 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Investment Contracts With Trustees**

The Plan entered into various group annuity contracts with the trustees who maintain the contributions in a general account. The account is credited with earnings (losses) on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contracts are reported at fair value on the statements of net assets available for benefits. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with the trustees. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The average yield and crediting interest rates were 2.62% and 3.53% for the years ended June 30, 2022 and 2021, respectively.

**Note 5. Information Prepared and Certified by Trustees**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103 (a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company, FSB, Nationwide Life Insurance Company, Brighthouse Life Insurance Company, Metropolitan Life Insurance Company, and Commonwealth Annuity and Life Insurance Company (as administrator for Zurich American Life Insurance Company), qualified institutions, have certified the following information included in the accompanying financial statements and ERISA- required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2022 and 2021
- Investment income (loss) components and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2022
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of June 30, 2022

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 6. Unaudited Investments**

Investments held by Kemper in the amount of \$224,982 at June 30, 2021, were not certified. The investments and related investment income were not subjected to additional audit procedures because Kemper did not provide the required information for the Plan's independent auditors to perform such procedures.

**Note 7. Transactions With Parties-in-Interest**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are units in pooled separate accounts, registered investment companies and guaranteed income funds managed by the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$1,614 of fees to the trustees during the year ended June 30, 2022.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 9. Tax Status**

The Plan operates under an adoption agreement in connection with a volume submitter 403(b) plan sponsored by FIS Business Systems LLC. This volume submitter 403(b) plan has been filed with the appropriate agency and has obtained an opinion letter dated March 31, 2017, from the Internal Revenue Service stating that the volume submitter 403(b) plan constitutes a qualified plan under Section 403(b) of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through August 7, 2025, which is the date the financial statements were available to be issued.
