Notes to the Financial Statements

A. Description of the Plan

The following brief description of the Allergy & Clinical Holdings, LLC 401(k) Plan Retirement Plan (plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The plan is a defined contribution plan covering all employees of Allergy & Clinical Holdings, LLC 401(k) Plan who have completed six months of service and are age 18 or older. Employees may begin participating in the plan once the eligibility requirements have been met and the entry date has been reached. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Eligible participants may elect to defer the maximum amount allowed by law. In addition, participants age 50 and older as of the end of the plan year are permitted to make elective catch-up contributions. Participants may also contribute rollovers representing distributions from a former employer's qualified retirement plan.

The employer will contribute an amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation.

The employer may also make a discretionary nonelective contribution. The grouping method will be used for allocating the nonelective contribution, where each participant constitutes a separate classification.

Participant's accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their elective deferrals, employer safe harbor contributions, and rollover contributions, if any, plus actual earnings thereon. The following vesting schedule applies to the employer nonelective contributions:

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Financial hardship withdrawals are also permitted as defined by the plan.

Notes receivable from participants

New loans are permitted according to the plan's adoption agreement. Loans will be treated as participant directed investments and bear interest at rates that range from 5.78% to 9.50%. Participants may borrow from their accounts a minimum of \$1,000 and may only have one loan outstanding at any time.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,178 and \$2,585, respectively. These funds will be used to reduce future employer contributions. No forfeitures were used during 2024.

B. Summary of Significant Accounting and Reporting Policies

Basis of accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See Note C for a discussion of fair value measurements.

B. Summary of Significant Accounting and Reporting Policies – Continued

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Operating expenses

Certain administrative expenses of maintaining the plan are paid by the company. Contract administrative fees are paid by the plan.

Subsequent events

The plan has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

C. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate account: Valued at the net asset value (NAV) of the underlying investments.

Fixed account: General account determined by the daily crediting of interest which is subject to minimum contractual guarantees.

D. Related Party and Party-in-Interest Transactions

During 2024, the plan investments were mutual funds managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is a custodian as defined by the plan and, therefore, a parties-in-interest with respect to the plan. These transactions are covered by an exemption from the “prohibited” transaction provisions of ERISA and the IRC.

E. Plan Termination

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

F. Tax Status

On June 30, 2020, the IRS stated that the prototype adopted by the plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The plan has not received a determination letter specific to the plan itself; however, the plan administrator and the plan’s tax counsel believe that the plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan’s financial statements. Although the plan has been amended since receiving the determination letter, the plan administrator and the plan’s tax counsel believe that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. Custodial Certification

The plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Voya Retirement Insurance and Annuity Company and was not subjected to any auditing procedures performed by the independent public accountants:

- a.* Total investments as shown in the accompanying statements of net assets available for benefits of \$16,969,172 as of December 31, 2024, and \$14,504,381 as of December 31, 2023.
- b.* Net investment income as shown in the accompanying statement of changes in net assets available for benefits of \$2,013,647 for the year ended December 31, 2024.
- c.* All investment-related information in the accompanying supplemental Schedule H, Line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024.

I. Delinquent Contributions

Certain participant contributions in 2021 were paid after the timeframe required by the Department of Labor. The Company remitted these contributions during the year. The Company determined the lost earnings for the late remittances and made the required lost earnings deposits to the plan in 2022. Additionally, the Company will file the necessary Form 5330 and pay the excise tax generated from the late remittances.

J. Excess Contributions Payable

At December 31, 2024, and 2023, liabilities of \$0 and \$875, respectively, are recorded for amounts refundable by the plan to participants for contributions made in excess of amounts allowed by the IRS.
