#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the New Vision Home Care Services, LLC Retirement Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

## ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the New Vision Home Care Services, LLC Retirement Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting***

As discussed in Note 1 to the financial statements, management of New Vision Home Care Services, LLC, the New Vision Home Care Services, LLC Retirement Plan and Trust's sponsor, approved a plan of liquidation on February 28, 2022, and management determined liquidation is imminent. As a result, the New Vision Home Care Service, LLC Retirement Plan and Trust's basis of accounting is the liquidation basis of accounting used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are

presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal

control-related matters that we identified during the audit.

NOTE 1 Description of Plan

The following description of the New Vision Home Care Services, LLC Retirement Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan commenced on January 1, 2019 and is a profit sharing plan covering all employees of New Vision Home Care Services, LLC (the Company), except for those identified in the Plan agreement, who are employed or have been employed during an allocation period as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants direct the investment of their account. The Plan Trustee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan is utilized as a component of the Company's wage parity compliance program to meet the requirements of the New York State Home Care Worker Wage Parity Law or Section 3614-c of the New York state Public Health Law (Wage Parity Law). The Wage Parity Law covers all employees of the Company who perform Medicaid-reimbursed work within New York City and the counties of Nassau, Suffolk and Westchester. Total compensation per the Wage Parity Law means all wages and other direct compensation paid to or provided on behalf of an employee including, but not limited to, wages, health, education or pension benefits, supplements in lieu of benefits and compensated time off, except that it does not include employer taxes or employer portion of payments for statutory benefits, including but not limited to FICA, disability insurance, unemployment insurance and workers' compensation (Component(s)). The company utilizes, at their discretion, a matrix of the components listed above in the Company's wage parity program. This Plan represents one of those components.

Plan termination

Effective February 28, 2022 the Company elected, pursuant to Article 11 of the Plan, to freeze and terminate said Plan as of that date subject to the Company's reserved right to terminate the Plan at any time and approved a plan of liquidation and determined liquidation was imminent. Final distributions will be determined based on all participants being 100% vested and will be made as soon as possible after the termination date of February 28, 2022. Participants may elect a distribution option from the following (1) taking a direct taxable distribution, (2) rolling over to a tax deferred IRA, or (3) rolling over and converting to a Roth IRA. The net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide Benefits attributable to employee contributions, taking into account those paid out before termination.

It was decided that the Company will enact a de minimis Plan account balance policy of \$75. Under such policy any Participant account balance equal to or less than \$75 shall be forfeited as of the Plan's termination date and transferred into the Plan's forfeiture account. Such that the proceeds of these forfeited balances shall be used to pay Plan administrative expenses, in accordance with Article 3.4(b) of the Plan. The adoption of such policy has been put in place since the withdrawal fee of \$75 would effectively negate any net proceeds a participant would receive from the Plan.

As a result of the termination and imminent liquidation, the Plan is using the liquidation basis of accounting in presenting the 2024 and 2023 financial statements. Income and expense, except for audit fees, expected to be earned and incurred during liquidation have not been accrued due to there not being a reasonable basis for their estimation. The Plan invests in various investment securities and the mix of the Plan's portfolio is likely to change as the liquidation progresses and therefore there is not a reasonable basis to estimate changes in fair value of the investment portfolio through the date that liquidation is expected to be complete.

Contributions

Prior to freezing and terminating the Plan, the Company had the option of making employer discretionary contributions (Employer Contributions) to the Plan. Employer contributions were allocated using the grouping method. Under this method, participants are assigned to a group which will share in the contribution (if any) that the Company makes for that group. Compensation is determined based on Form W-2 wages, excluding any wages received as post year end compensation. The Company did not make employer contributions for the year ended December 31, 2024. Effective February 28, 2022 the Plan was frozen (see Note 1 Plan Termination).

Participant accounts

Each participant's account was credited with the participant's rollover contributions (if any), and employer contributions (if any), and an allocation of plan earnings (losses) and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account balance.

Vesting

Participants are immediately vested in their rollover contributions and employer contributions, plus actual earnings thereon.

Payment of benefits

Withdrawals are allowed at any time in the form of a lump sum payment or rollover to another qualified plan. Withdrawals paid directly to participants are subject to withholding taxes as defined in the Plan agreement.

Forfeited accounts

As of December 31, 2024 and 2023, there are no forfeitures for the Plan as all participants are immediately fully vested in all contributions. Effective February 28, 2022 the Plan adopted a de minimis Plan account balance policy where any Participant account balance equal to or less than \$75 will be forfeited since the withdrawal fee of \$75 would negate any proceeds a participant would receive (See Note 1).

SECURE Act 2.0

On December 29, 2022, President Biden signed the Consolidated Appropriations Act (CAA) of 2023, which included the SECURE 2.0 Act of 2022 (“Secure 2.0”), into law. SECURE 2.0 builds on the SECURE Act of 2019 and implemented a number of changes regarding retirement plans and plan sponsors. The plan document has been amended for provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to ensure compliance with the applicable provisions effective after December 31, 2024.

**NOTE 2**    Summary of significant accounting policies

Basis of accounting

The Plan was terminated effective February 28, 2022, therefore the 2024 and 2023 financial statements of the Plan are prepared on the liquidation basis.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income - loss recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s trustee determines the Plan’s valuation policies utilizing information provided by the investment advisers and recordkeeper. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid from Plan assets will be shared by all participants. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the payment of benefits to participants are charged directly to the participant's account and are included in administrative expenses if such payments were made during the Plan year. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3** Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• Quoted prices for similar assets or liabilities in active markets;</li><li>• Quoted prices for identical or similar assets or liabilities in inactive markets</li><li>• Inputs other than quoted prices that are observable for the asset or liability</li><li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies ("mutual funds") are valued at the daily closing price as reported by the fund. They are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price and are deemed to be actively traded.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December, 31, 2024, there were no transfers of investments into or out of Level 3. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

**NOTE 4** Related party and party in interest transactions

Certain Plan investments are managed by Nationwide Trust Company. Nationwide Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. The aforementioned custodian provided certain administrative services to the Plan pursuant to a service agreement between the Company and the custodian and the custodian's respective agents. The custodian received revenue from mutual fund service providers for services the custodian provided to the funds. This revenue was used to offset certain amounts owed to the custodian for its administrative services to the Plan.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 5**    Termination of Plan

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective February 28, 2022, the Company elected to freeze and terminate the Plan (see Note 1).

**NOTE 6**    Tax status

The Plan operates under a volume submitter profit-sharing plan with a cash or deferral arrangement, which received an advisory letter dated March 31, 2014 from the Internal Revenue Service (“IRS”) indicating this volume submitter plan was an acceptable plan under applicable sections of the Internal Revenue Code (“IRC”) for use of employers for the benefit of their employees. An employer who adopts this plan will be considered to have a plan qualified under Code Section (a), providing all the terms of the Plan are followed and the eligibility requirements and contribution or benefit provisions are not more favorable to officers, owners or highly compensated employees than for other employees. The Plan does not have its own determination letter. Although the Plan has been amended since receiving the advisory letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7**    Information certified by the custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, the custodian.

**NOTE 8**    Risks and uncertainties
