Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule, Schedule H, line 4i – schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## ***NOTE 1 – DESCRIPTION OF THE PLAN:***

The following description of the Basin Disposal Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

*General* – The Plan is a defined contribution plan, covering all eligible employees of Basin Disposal Inc. (the Company). The Plan administrator intends the Plan to be a safe harbor plan. In a safe harbor plan, if certain requirements are met, the Plan will be deemed to automatically pass certain Internal Revenue Service (IRS) required nondiscrimination testing. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all subsequent statutory revisions thereto. The Board of Trustees (Board) is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings, with the assistance of an outside investment advisor firm. The Board also monitors investment performance.

*Eligibility* – Employees who have attained the age of 21 and have completed one year of service with at least 1,000 hours per year, are eligible to participate in the Plan, unless they are covered by a collective bargaining agreement, are leased employees, or are non-resident aliens with no source income within the United States. Plan entry occurs on January 1 and July 1 immediately following the completion of the eligibility requirements.

*Contributions* – The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage or an amount, limited by Plan provisions, of their compensation contributed to the Plan and may stop an election to contribute at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions and may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

The Plan provides traditional automatic enrollment. The initial amount of the automatic enrollment, as a percentage of pay, is 2%. This amount increases 1% on the first day of each plan year up to a maximum of 6%. These elective deferrals are designated as pre-tax. Participants may modify, start, or stop elective deferrals or voluntary contribution elections each pay period. They may also stop an election to contribute at any time.

The Company makes a safe harbor non-elective contribution to the Plan in the amount of 3% of participants' compensation. The Company may also elect to make an additional discretionary matching contribution, in an amount and allocation formula as determined by the Company, at its sole discretion. The total amount of discretionary matching contributions allocated to a participant in any plan year will not exceed 4% of compensation. For the years ended December 31, 2024 and 2023, the Company made a discretionary matching contribution in the amount of 50% of employee deferrals, up to 2% of eligible compensation. The Company may also elect to make a profit-sharing contribution to eligible participants. Profit-sharing contributions are allocated in an amount designated by the Company to eligible participant accounts after the end of the plan year. For the years ended December 31, 2024 and 2023, there were no profit-sharing contributions.

## ***NOTE 1 – DESCRIPTION OF THE PLAN (continued):***

*Participant accounts* – Each participant’s account is credited with the participant’s contributions, the Company’s matching and profit-sharing contributions, and an allocation of the Plan’s earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their salary deferral contributions, rollover contributions, and qualified safe harbor matching contributions, plus actual earnings thereon. Vesting in discretionary additional Company matching and profit-sharing contribution portions of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. An employee earns a year of service for vesting purposes upon completing 1,000 actual working hours during the Plan year.

*Notes receivable from participants* – Loans to participants are not permitted by the Plan.

*Benefit payments* – Participants can take a distribution of their vested account balances immediately after their employment terminates, upon reaching age 65 or normal retirement age, or when called to active military duty for at least 180 days. Participants can take a distribution of their rollover contribution balances at any time. The availability of a distribution option will depend on the amount of the participant’s vested balance.

*Forfeited accounts* – At the Company’s discretion, forfeited non-vested account funds may be used to restore forfeitures, pay Plan expenses, or reduce Company contributions. Forfeited non-vested accounts totaled \$11,162 and \$6,441 at December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, \$18,683 and \$8,831, respectively, were used from the forfeiture account to pay administrative fees.

## ***NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:***

*Basis of accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting.

*Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued):**

*Investment valuation and income recognition* – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board determines the Plan’s valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Contributions* – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

*Payment of benefits* – Benefits are recorded when paid.

*Expenses* – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid directly by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation of fair value of investments. The Plan may charge all participants for the expenses of operating the Plan in the following manner: all trust and custodial fees and fees associated with the administration of the Plan may be deducted pro-rata from participants’ accounts.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE:**

**NOTE 4 – FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. These are considered observable inputs.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"> <li>• quoted prices for similar assets or liabilities in active markets;</li> <li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li> <li>• inputs other than quoted prices that are observable for the asset or liability;</li> <li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li> </ul> If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023:

*Mutual funds (Level 1):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value common collective trust (net asset value):* A stable value fund is a form of common collective trust fund which is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value.

**NOTE 5 – RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

***NOTE 6 – PLAN TERMINATION:***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

***NOTE 7 – PLAN TAX STATUS:***

The Plan was developed through a volume submitter template. The IRS has determined and informed the submitter by a letter dated March 31, 2014, that the Plan's template and the related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***NOTE 8 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS:***

Certain Plan investments are shares of mutual funds managed by investment management companies, including Matrix Trust Company. Matrix Trust Company is a custodian as defined by the Plan, and Randall & Hurley, Inc., is the recordkeeper for the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Certain fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. As discussed in Note 2, fees paid directly by the Company related to the Plan's operations are not included in these financial statements.
