### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Meridian Title Corporation Employee's Savings and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. #### Note 1. Description of Plan

The following description of the Meridian Title Corporation Employee's Savings and Profit Sharing Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Meridian Title Corporation (the Company or Employer) who have completed six months of service, are age 21 or older, and who are not members of a collective bargaining unit or a resident of Puerto Rico until the date of February 21, 2024, at which time the service requirement to become eligible for employee contributions to the Plan changed to one month service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In February 2024, the Plan switched third party administrators from TransAmerica Retirement Solutions, LLC (TransAmerica) to Empower Trust Company, LLC (Empower). Empower now acts as the trustee of the Plan. With the change, all assets of the Plan were transferred from TransAmerica to Empower.

**Contributions:** Under the terms of the Plan agreement, participants may contribute on a pre-tax or post-tax basis limited to the maximum amount established by the applicable sections of the Internal Revenue Code (IRC). The Plan includes an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant makes an affirmative election otherwise. Additionally, participants who have attained age 50 prior to the end of the plan year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of, Section 414(v) of the IRC. Participants may also contribute in the form of direct rollover amounts representing distributions from other qualified retirement plans. The Company may contribute a discretionary matching contribution equal to a percentage of each participant's salary reduction. The Company may also make an additional discretionary contribution in the amount the Company may deem advisable. For 2024, the Company contributed discretionary matching contributions of approximately \$137,000 at a rate of 25% of the first 6% deferred by participants. Contributions are subject to certain limitations. For 2024, the Company did not make additional discretionary contributions.

**Participant accounts:** Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, and b) Plan earnings, and is charged with the participant's withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of credited service. A participant is 100% vested after three years of credited service.

**Retirement, death and disability:** A participant, or beneficiary, is entitled to 100% of his or her account balance upon retirement, death or disability regardless of years of service.

**Payment of benefits:** On termination of service, the attainment of age 59½, death, or retirement due to disability, a participant may elect to receive a lump-sum amount equal to the value of his or her vested interest in the account. In addition, participants may make withdrawals from their account upon determination that a financial hardship, as defined by the Plan, has been incurred.

**Investment options:** Each participant may direct contributions into any of the investment options available under the Plan.

**Notes receivable from participants:** The Plan provides that participants can borrow funds against their account balance limited to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account, bear interest at prevailing interest rates, and cannot exceed five years unless the loan is for the purchase of a principal residence. Principal and interest are paid through payroll deductions.

**Forfeitures:** Forfeitures of account balances of terminated participants attributable to Company contributions are used to reduce Employer contributions. Forfeited nonvested accounts totaled approximately \$49,000 and \$1,000 at December 31, 2024 and 2023, respectively. During 2024, The Plan did not use any forfeitures to reduce employer matching contributions or administrative expenses.

**Plan termination:** Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants will become 100% vested in their accounts.

#### Note 2. Summary of Significant Accounting Policies

The principles and policies which significantly affect the determination of net assets available for benefits and results of operations are summarized below.

**Basis of accounting:** The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and uncertainties:** The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Market risks include risks associated with ongoing global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

**Payment of benefits:** Benefits are recorded when paid.

**Notes receivable from participants:** Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No material allowance for credit losses was deemed necessary as of December 31, 2024 or 2023, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

**Administrative and investment management expenses:** Loan origination fees associated with notes receivable from participants, the Plan's recordkeeping fees, and investment advisory fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company and excluded from these financial statements.

**Subsequent events:** Plan Management has evaluated subsequent events for recognition and disclosure through September 9, 2025, which is the date the financial statements were available to be issued.

#### Note 3. Information Certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively Empower) and Reliance Trust Company (Reliance)

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies:** Valued at the closing price reported on the active market on which the individual securities are traded.

**Common collective trust:** Valued at the net asset value (NAV), as practical expedient, of the units held by the Plan at year-end. The value is supported by the information reported by the investment advisor using the audited financial statements of the fund. The NAV, as provided by the trustees, is used as a practical expedient for estimating fair value.

**Interest bearing deposit with insurance company:** Valued at the net asset value (NAV), as practical expedient, of the units held by the Plan at year-end. The value is supported by the information reported by the investment advisor using the audited financial statements of the fund. The NAV, as provided by the trustees, is used as a practical expedient for estimating fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or to out of Level 3 investments.

#### **Note 5. Income Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service dated November 14, 2022, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated in, compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Parties in interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Investment management and plan administrative fees paid by the Plan to the recordkeeper and investment manager qualify as party-in-interest transactions. During 2024, recordkeeping fees of approximately \$19,000 and \$53,000 were paid to TransAmerica and Empower, respectively.

#### **Note 7. Delinquent Contributions**

Due to a change in third party administrators and the related blackout period, the Employer inadvertently failed to deposit approximately \$72,000 of participant contributions and loan repayments within the required timeframe as stated by the DOL during the year ended December 31, 2024. The DOL considers late deposits to be prohibited transactions. The Employer expects to remit lost earnings to the Plan and potential excise taxes on the lost earnings from its assets and not the Plan's assets.
