Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Russell Regional Hospital 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note A - Description of Plan

The following description of the Russell Regional Hospital 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering employees of West Central Kansas Association, Inc. d/b/a Russell Regional Hospital (the Employer) who are age 21 or older. Employees may make voluntary contributions upon attaining age 21. To receive employer matching contributions, employees must have completed one year of service (as defined in the Plan). The Plan was established with an effective date of January 1, 1998, with a restatement effective date of January 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

The Employer has elected to make matching 401(k) contributions to the Plan equal to 50 percent of the participant's elective deferral up to 4 percent.

3. Participant accounts

Each participant's account is credited with the participant's deferral, an allocation of the Employer's contribution, and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

4. Vesting

For portions of account balances attributable to Employer contributions, the Plan provides for vesting of 100 percent after 3 years of service. Portions of account balances attributable to employee deferrals are 100 percent vested and nonforfeitable at all times.

5. Investment options

Upon enrollment in the Plan, a participant may direct their account balances be invested in one or any combination of investment options offered by the Plan and may change the allocation daily. The Plan does not have any nonparticipant-directed investments.

6. Payment of benefits

At any time after termination of employment, a participant may elect to withdraw in a lump sum the value of their account attributable to employee contributions as well as the nonforfeitable value of their account attributable to employer contributions. Upon reaching retirement age, a participant may also elect to receive the value of their account as a joint and survivor, or a single life annuity, or as a series of equal payments over a fixed period of time.

7. Forfeitures

Forfeited nonvested accounts as of December 31, 2024 and 2023, were \$1,291 and \$0, respectively. Forfeitures in the amount of \$8,132 were used to reduce employer contributions and forfeitures in the amount of \$667 were used to pay Plan expenses in 2024.

8. Participant investment rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Note B - Summary of Accounting Policies

A summary of significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

1. Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

2. Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. Investment valuation and income recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note E for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Net appreciation (depreciation) in fair value of investments

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments which consists of the realized gain or losses and the unrealized appreciation (depreciation) on those investments.

5. Payment of benefits

Benefits are recorded when paid.

6. Expenses

Certain expenses of maintaining the Plan are paid by the Employer and, therefore, are excluded from these financial statements. Certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Other investment management fees are paid directly by the Plan for participants who elect to have their accounts managed.

7. Date of management's review and subsequent events

The Plan has evaluated subsequent events through the date of the Independent Auditor's Report which is the date the financial statements were available to be issued.

Note C - Party-in-Interest Transactions

Plan investments are managed by American United Life Insurance Company (AUL) or Variable Annuity Life Insurance Company (AIG Retirement Services), the plan custodians. AUL's fees for the investment management services for the year ended December 31, 2024, were \$40,874, \$1,319 of which was paid directly by the Plan. AIG Retirement Services' fees for the investment management services for the year ended December 31, 2024, were \$1,213, all of which was paid directly by the Plan.

Future Capital provides investment management services and are paid directly by the Plan for participants who elect their services. Fees for the investment management services were \$11,216 for the year ended December 31, 2024.

Note D - Deposit with Insurance Companies

The Plan's investments include group annuity contracts with AUL and AIG Retirement Services that totaled \$582,549 and \$641,525 at December 31, 2024 and 2023, respectively. The contracts maintain the contributions in their general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity date.

These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL and AIG Retirement Services, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note E - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs include:
 - Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specified contractual term, level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts

Valued at the NAV of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the account less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note F - Income Tax Status

The Plan, restated on January 1, 2009, July 1, 2014, and January 1, 2015, was adopted based on a prototype plan under which the Internal Revenue Service determination letter was issued. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note H - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their account.

Note I - Reportable Transactions Under ERISA

The Plan had no loans or fixed income obligations in default at December 31, 2024. The Plan had no leases at December 31, 2024. All plan assets are in an investment contract with two insurance companies.
