Independent Auditor's Report

To the Plan Administrator of
KPC Healthcare, Inc. Profit Sharing Plan:

Opinion

We have audited the financial statements of KPC Healthcare, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets in liquidation available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets in liquidation available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets in liquidation available for benefits of KPC Healthcare, Inc. Profit Sharing Plan as of August 31, 2024 and 2023, and the changes in its net assets in liquidation available for benefits for the year ended August 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of KPC Healthcare, Inc. Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about KPC Healthcare, Inc. Profit Sharing Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of KPC Healthcare, Inc. Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about KPC Healthcare, Inc. Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Plan sold all KPC Healthcare, Inc. common stock to a third party and made the decision to terminate the Plan. As a result, KPC Healthcare, Inc. Profit Sharing Plan used the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to this matter.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year), as of August 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. 1. Description of Plan

The following description of KPC Healthcare, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

KPC Healthcare Holdings, Inc. and Subsidiaries (the "Company" or "KPC"), established the Plan effective as of April 1, 2015. The Plan operated as a leveraged employee stock ownership plan ("ESOP") and was designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code ("IRC") of 1986, as amended, and was subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan hired an independent trustee to act on behalf of the Plan participants.

In December 2021, the Plan, which had previously operated as a leveraged ESOP, was amended to freeze new participation in the Plan and effectively terminate the Plan, convert the Plan document to a profit-sharing Plan under section 401(a) of the IRC, update benefit payment provisions of the Plan, and change the name of the Plan from the KPC Healthcare, Inc. Employee Stock Ownership Plan to the KPC Healthcare, Inc. Profit Sharing Plan. Upon the date of the decision to terminate the Plan, all participants became fully vested. The Trust will be maintained until all the participant accounts have been distributed in accordance with the Plan document and in compliance with applicable laws and regulations.

The Plan is administered by the ESOP Committee ("Committee"), which is appointed by the Company's Board of Directors to administer the Plan and to give instructions to the Trustee. Currently, all members of the Board of Directors serve on the Committee.

Eligibility

Employees of the Company were generally eligible to participate in the Plan upon attainment of age twenty-one and the completion of one year of service. One year of service is defined as a 12-month period in which an employee is credited with 1,000 hours of employment. The one year of service eligibility requirement was waived in the initial Plan year. Participants who did not have at least 1,000 hours of service during such plan year or were not employed on the last working day of the Plan year were generally not eligible for an allocation of the Company contribution for such year. In December 2021, the Plan was frozen to new participants.

Participant Accounts

Each participant's account is credited with an allocation of the Plan's earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in earnings credited to his or her account.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants with vested account balances not in excess of \$5,000 will receive a single lump sum payment as soon as administratively practicable following the end of the Plan year in which the participant separated from service. For participants with vested account balances in excess of \$1,000 but not in excess of \$5,000, and the participant does not make an election, the amount will be rolled over into an Individual Retirement Account ("IRA") selected by the Committee on behalf of the participant. For participants with vested account balances in excess of \$5,000, distributions may be in the form of cash and/or Company stock in a single lump sum or installment payments, as defined in the Plan agreement. For participants whose termination of service is due to death, disability, or retirement, payment of benefits shall commence within one year following the Plan year in which the participant terminates employment. For participants whose termination of service is due to other reasons, unless the participant elects to defer, payment of vested benefits shall commence within one year after the end of the fifth Plan year following the Plan year in which the participant terminates employment. There were no distributions for the year ended August 31, 2024.

In December 2021, the Plan was amended to permit only lump sum cash payments to participants of the Plan, and to allow for distribution of up to 75% of each participant's account balance as soon as administratively feasible, with the remainder of the participant's balance to be paid upon receipt of a favorable Internal Revenue Service determination letter related to the termination of the Plan.

Administrative Expenses

As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or the Company. The Company has historically paid certain operating expenses of the Plan; however, the Company has no obligation to continue to pay such operating expenses of the Plan. There were no administrative expenses paid by the Plan during the year ended August 31, 2024.

2. Summary of Accounting Policies

Basis of Presentation

The financial statements have been prepared in compliance with the Department of Labor Rules and Regulations for reporting and disclosure under ERISA.

Basis of Accounting

The financial statements of the Plan are prepared on the in-liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP")

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Interest is recorded on the accrual basis.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

The Plan's management evaluated events that occurred after August 31, 2024 through August 29, 2025, the date the financial statements were available to be issued.

3. Related-Party and Party-in-Interest Transactions

The trustee of the Plan holds interest bearing cash on behalf of the Plan which qualifies as a party-in-interest transaction under ERISA.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

4. Tax Status

The IRS has determined and informed the Company by a letter dated November 28, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets in liquidation available for benefits. As of August 31, 2024 and 2023, all investments were held in a single interest-bearing account.
