INDEPENDENT AUDITOR'S REPORT

To the Retirement Committee of
PDI Technologies 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PDI Technologies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024 and supplemental schedule H, line 4a - schedule of delinquent participant contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the PDI Technologies 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of PDI Technologies and all participating employers (the “Company”), except leased, union, interns, and nonresident alien employees with no U.S. income or with all income exempt from U.S. income tax.

Employees are eligible to participate in the Plan immediately upon completion of three months of service. Years of service while an employee of specific entities identified in the Plan document, are taken into account in determining a participant’s eligibility, discretionary matching employer contributions, and vesting.

Contributions

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan up to 90% of their eligible compensation, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company automatically enrolls newly eligible employees at a pre-tax salary deferral contribution of 4% of eligible compensation unless the employee affirmatively elects otherwise. Rollover contributions are allowed subject to conditions set forth in the Plan.

The Company may make a discretionary matching employer contribution to eligible participants on a plan year basis. For 2024, the Company made a discretionary matching employer contribution of 100% of a participant’s salary deferrals up to: 3% of eligible compensation, if the participant had less than seven years of service, 3.5% of eligible compensation, if the participant had between seven to fourteen years of service, or 4% of eligible compensation if the participant had more than fourteen years of service.

The Plan is participant directed, and participants may change their contribution rates at the beginning of each payroll period and investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants’ account balances, the number of participants in the Plan, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balance in the Plan or \$50,000. Interest rates on notes are stated at the prime rate plus 1% as determined at the date of the loan. Notes are repaid in level installments through payroll deductions for periods ranging up to five years, or longer if the note is for the purchase of a principal residence. Notes are secured by the participant's vested account to the extent of the principal amount of the note plus accrued interest. A participant may only have one note outstanding at a time.

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. A participant is immediately vested upon retirement, death, or disability. Effective January 1, 2024, the Plan was amended to change the discretionary matching employer contribution vesting schedule from a five-year graded schedule to immediately 100% vested. All participants in the Plan that had not terminated as of January 1, 2024, became 100% vested in their discretionary matching employer contributions. Prior to January 1, 2024, vesting in the discretionary matching employer contribution portion of their accounts plus earnings thereon was based on years of service (one year is equivalent to 1,000 hours of service in a calendar year). Participants became vested in Company contributions at 40% after two years of service and vested at 20% per year thereafter. Participants were 100% vested after five years of service.

Payment of Benefits

Upon a participant's termination, death, disability, or retirement, the vested funds in the participant's account are eligible to be distributed in a lump-sum payment. Normal retirement age under the Plan is 65. The Plan allows for in-service withdrawals at the age of 59½ and hardship withdrawals, subject to certain conditions set forth in the Plan document. Unless otherwise elected, distribution on account of the death of a participant will be made no later than the end of the fifth calendar year of the participant's death, for all beneficiaries. Effective October 7, 2024, the Plan now allows the automatic rollover of vested account balances of terminated participants that are \$7,000 or less following the participant's termination date. Previously, vested account balances of terminated participants that were \$5,000 or less were cashed out.

Forfeited Accounts

Forfeitures of nonvested accounts may be used to restore forfeitures, reduce Company contributions, or to pay Plan expenses. The forfeitures balance at December 31, 2024 and 2023 was \$147,352 and \$222,279, respectively. Forfeitures of \$224,141 were used to reduce Company contributions and \$144 were used to pay Plan expenses during the year ended December 31, 2024.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would receive benefits based on their account balances accumulated to the date of termination of the Plan.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the trustee and third party administrator. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from Plan participants and the Company discretionary matching employer contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments measured using the NAV practical expedient are described below:

Collective Investment Fund: Valued at NAV based on the contractual terms of the underlying unit value reported by the trust company based on the fair value of the underlying investments less liabilities. The NAV is used as a practical expedient to estimate fair value. The fund is designed to provide preservation of capital, liquidity, and current income. The fund invests primarily in synthetic guaranteed investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is subject to a 12-month notice provision for the Federated Hermes Capital Preservation fund, if redemption is initiated. The Plan has no unfunded commitments and no contractual obligations to further invest in the fund.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 4 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in mutual funds managed by entities related to Fidelity, the trustee as defined by the Plan, and, therefore, qualify as a party in interest. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 6 - TAX STATUS

The Plan has adopted a pre-approved plan document with an entity related to Fidelity, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - DELINQUENT CONTRIBUTIONS

During 2024 and 2023, there were unintentional delays by the Company in submitting participant contributions to the Plan in the amount of \$2,935 and \$7,836, respectively. The Company compensated the affected participants for lost earnings on \$671 of these delinquent contributions in 2024 and intends to compensate the affected participants for lost earnings on the remaining \$10,100 of these delinquent contributions in 2025.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PDI Technologies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the PDI Technologies 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of PDI Technologies and all participating employers (the “Company”), except leased, union, interns, and nonresident alien employees with no U.S. income or with all income exempt from U.S. income tax.

Employees are eligible to participate in the Plan immediately upon completion of three months of service. Years of service while an employee of specific entities identified in the Plan document, are taken into account in determining a participant’s eligibility, discretionary matching employer contributions, and vesting.

Contributions

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan up to 90% of their eligible compensation, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company automatically enrolls newly eligible employees at a pre-tax salary deferral contribution of 4% of eligible compensation unless the employee affirmatively elects otherwise. Rollover contributions are allowed subject to conditions set forth in the Plan.

The Company may make a discretionary matching employer contribution to eligible participants on a plan year basis. For 2024, the Company made a discretionary matching employer contribution of 100% of a participant’s salary deferrals up to: 3% of eligible compensation, if the participant had less than seven years of service, 3.5% of eligible compensation, if the participant had between seven to fourteen years of service, or 4% of eligible compensation if the participant had more than fourteen years of service.

The Plan is participant directed, and participants may change their contribution rates at the beginning of each payroll period and investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants’ account balances, the number of participants in the Plan, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balance in the Plan or \$50,000. Interest rates on notes are stated at the prime rate plus 1% as determined at the date of the loan. Notes are repaid in level installments through payroll deductions for periods ranging up to five years, or longer if the note is for the purchase of a principal residence. Notes are secured by the participant's vested account to the extent of the principal amount of the note plus accrued interest. A participant may only have one note outstanding at a time.

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. A participant is immediately vested upon retirement, death, or disability. Effective January 1, 2024, the Plan was amended to change the discretionary matching employer contribution vesting schedule from a five-year graded schedule to immediately 100% vested. All participants in the Plan that had not terminated as of January 1, 2024, became 100% vested in their discretionary matching employer contributions. Prior to January 1, 2024, vesting in the discretionary matching employer contribution portion of their accounts plus earnings thereon was based on years of service (one year is equivalent to 1,000 hours of service in a calendar year). Participants became vested in Company contributions at 40% after two years of service and vested at 20% per year thereafter. Participants were 100% vested after five years of service.

Payment of Benefits

Upon a participant's termination, death, disability, or retirement, the vested funds in the participant's account are eligible to be distributed in a lump-sum payment. Normal retirement age under the Plan is 65. The Plan allows for in-service withdrawals at the age of 59½ and hardship withdrawals, subject to certain conditions set forth in the Plan document. Unless otherwise elected, distribution on account of the death of a participant will be made no later than the end of the fifth calendar year of the participant's death, for all beneficiaries. Effective October 7, 2024, the Plan now allows the automatic rollover of vested account balances of terminated participants that are \$7,000 or less following the participant's termination date. Previously, vested account balances of terminated participants that were \$5,000 or less were cashed out.

Forfeited Accounts

Forfeitures of nonvested accounts may be used to restore forfeitures, reduce Company contributions, or to pay Plan expenses. The forfeitures balance at December 31, 2024 and 2023 was \$147,352 and \$222,279, respectively. Forfeitures of \$224,141 were used to reduce Company contributions and \$144 were used to pay Plan expenses during the year ended December 31, 2024.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would receive benefits based on their account balances accumulated to the date of termination of the Plan.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the trustee and third party administrator. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from Plan participants and the Company discretionary matching employer contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments measured using the NAV practical expedient are described below:

Collective Investment Fund: Valued at NAV based on the contractual terms of the underlying unit value reported by the trust company based on the fair value of the underlying investments less liabilities. The NAV is used as a practical expedient to estimate fair value. The fund is designed to provide preservation of capital, liquidity, and current income. The fund invests primarily in synthetic guaranteed investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is subject to a 12-month notice provision for the Federated Hermes Capital Preservation fund, if redemption is initiated. The Plan has no unfunded commitments and no contractual obligations to further invest in the fund.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 4 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in mutual funds managed by entities related to Fidelity, the trustee as defined by the Plan, and, therefore, qualify as a party in interest. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 6 - TAX STATUS

The Plan has adopted a pre-approved plan document with an entity related to Fidelity, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - DELINQUENT CONTRIBUTIONS

During 2024 and 2023, there were unintentional delays by the Company in submitting participant contributions to the Plan in the amount of \$2,935 and \$7,836, respectively. The Company compensated the affected participants for lost earnings on \$671 of these delinquent contributions in 2024 and intends to compensate the affected participants for lost earnings on the remaining \$10,100 of these delinquent contributions in 2025.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

INDEPENDENT AUDITOR'S REPORT

To the Retirement Committee of
PDI Technologies 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PDI Technologies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024 and supplemental schedule H, line 4a - schedule of delinquent participant contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the PDI Technologies 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of PDI Technologies and all participating employers (the “Company”), except leased, union, interns, and nonresident alien employees with no U.S. income or with all income exempt from U.S. income tax.

Employees are eligible to participate in the Plan immediately upon completion of three months of service. Years of service while an employee of specific entities identified in the Plan document, are taken into account in determining a participant’s eligibility, discretionary matching employer contributions, and vesting.

Contributions

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan up to 90% of their eligible compensation, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company automatically enrolls newly eligible employees at a pre-tax salary deferral contribution of 4% of eligible compensation unless the employee affirmatively elects otherwise. Rollover contributions are allowed subject to conditions set forth in the Plan.

The Company may make a discretionary matching employer contribution to eligible participants on a plan year basis. For 2024, the Company made a discretionary matching employer contribution of 100% of a participant’s salary deferrals up to: 3% of eligible compensation, if the participant had less than seven years of service, 3.5% of eligible compensation, if the participant had between seven to fourteen years of service, or 4% of eligible compensation if the participant had more than fourteen years of service.

The Plan is participant directed, and participants may change their contribution rates at the beginning of each payroll period and investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants’ account balances, the number of participants in the Plan, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balance in the Plan or \$50,000. Interest rates on notes are stated at the prime rate plus 1% as determined at the date of the loan. Notes are repaid in level installments through payroll deductions for periods ranging up to five years, or longer if the note is for the purchase of a principal residence. Notes are secured by the participant's vested account to the extent of the principal amount of the note plus accrued interest. A participant may only have one note outstanding at a time.

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. A participant is immediately vested upon retirement, death, or disability. Effective January 1, 2024, the Plan was amended to change the discretionary matching employer contribution vesting schedule from a five-year graded schedule to immediately 100% vested. All participants in the Plan that had not terminated as of January 1, 2024, became 100% vested in their discretionary matching employer contributions. Prior to January 1, 2024, vesting in the discretionary matching employer contribution portion of their accounts plus earnings thereon was based on years of service (one year is equivalent to 1,000 hours of service in a calendar year). Participants became vested in Company contributions at 40% after two years of service and vested at 20% per year thereafter. Participants were 100% vested after five years of service.

Payment of Benefits

Upon a participant's termination, death, disability, or retirement, the vested funds in the participant's account are eligible to be distributed in a lump-sum payment. Normal retirement age under the Plan is 65. The Plan allows for in-service withdrawals at the age of 59½ and hardship withdrawals, subject to certain conditions set forth in the Plan document. Unless otherwise elected, distribution on account of the death of a participant will be made no later than the end of the fifth calendar year of the participant's death, for all beneficiaries. Effective October 7, 2024, the Plan now allows the automatic rollover of vested account balances of terminated participants that are \$7,000 or less following the participant's termination date. Previously, vested account balances of terminated participants that were \$5,000 or less were cashed out.

Forfeited Accounts

Forfeitures of nonvested accounts may be used to restore forfeitures, reduce Company contributions, or to pay Plan expenses. The forfeitures balance at December 31, 2024 and 2023 was \$147,352 and \$222,279, respectively. Forfeitures of \$224,141 were used to reduce Company contributions and \$144 were used to pay Plan expenses during the year ended December 31, 2024.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would receive benefits based on their account balances accumulated to the date of termination of the Plan.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the trustee and third party administrator. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from Plan participants and the Company discretionary matching employer contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments measured using the NAV practical expedient are described below:

Collective Investment Fund: Valued at NAV based on the contractual terms of the underlying unit value reported by the trust company based on the fair value of the underlying investments less liabilities. The NAV is used as a practical expedient to estimate fair value. The fund is designed to provide preservation of capital, liquidity, and current income. The fund invests primarily in synthetic guaranteed investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is subject to a 12-month notice provision for the Federated Hermes Capital Preservation fund, if redemption is initiated. The Plan has no unfunded commitments and no contractual obligations to further invest in the fund.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 4 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in mutual funds managed by entities related to Fidelity, the trustee as defined by the Plan, and, therefore, qualify as a party in interest. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 6 - TAX STATUS

The Plan has adopted a pre-approved plan document with an entity related to Fidelity, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - DELINQUENT CONTRIBUTIONS

During 2024 and 2023, there were unintentional delays by the Company in submitting participant contributions to the Plan in the amount of \$2,935 and \$7,836, respectively. The Company compensated the affected participants for lost earnings on \$671 of these delinquent contributions in 2024 and intends to compensate the affected participants for lost earnings on the remaining \$10,100 of these delinquent contributions in 2025.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.
