We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

RETIREMENT PLAN**

**NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

---

**1. DESCRIPTION OF THE PLAN**

The following description of the Villager Construction, Inc. Prevailing Wage Rate and 401(K) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General -

The Plan is a defined contribution plan covering all eligible employees of Villager Construction, Inc. (the "Company"). Employees are eligible to participate in the Plan immediately upon hire and completion of one hour of service. Employees of the Company that are not eligible to contribute to the Plan are as follows: an employee covered by a collective bargaining agreement that does not provide for participation in the Plan, leased employees, an individual not reported on the payroll records of the Company as a common law employee, and employees that became an employee as a result of a Code Section 410(b)(6)(C) transaction. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Administration -

The Company is the Plan administrator, and its President currently serves as the Plan's trustee. All Plan assets are held in trust and managed by Principal Life Insurance Company, Principal Global Investors Trust Company and Principal Trust Company (the "Custodians" or "Principals"). Administrative expenses are paid by the Company, except for administrative expenses related to personal retirement accounts, which are deducted from the related participants' accounts.

Contributions -

Participants can contribute up to 92% of their compensation, subject to the maximum dollar amount permissible under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make matching contributions to the Plan on a discretionary basis. For 2024 and 2023, participants are eligible for the match immediately upon hire and completion of 1 hour of service. If eligibility is reached during 2024, the Plan may make a 98% match on up to 6% of an employee's elective deferral for the Plan year. If eligibility is reached during 2023, the Plan may make a 50% match on up to 6% of an employee's elective deferral for the Plan year. The Company made a matching contribution of \$619,190 and \$285,875 during 2024 and 2023, respectively.

## 1. DESCRIPTION OF THE PLAN (Continued)

### Contributions (Continued) -

Prevailing wage rate contributions are made for each participant who is working on a project covered by a prevailing rate schedule. The amount should be equal to the fringe benefit pension rate determined for such participants multiplied by each hour of service performed. These contributions totaled \$350,812 and \$509,719 during the years ended December 31, 2024 and 2023, respectively.

### Participant Accounts -

Participants' accounts are credited with their contributions and allocations of (a) the Company's contribution and (b) the Plan's earnings. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting -

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years of service, and vests 20% per year until they are 100% vested after six years of credited service or upon death, disability, or reaching the age of early retirement. Prevailing wage rate contributions are fully vested upon contribution into the Plan.

### Investment Options -

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options as indicated by the Plan sponsor, which provide diversified investment allocations. Participants may change their investment options electronically at any time during the year.

### Payment of Benefits -

The value of a participant's account that is comprised of 401(K) elective deferral contributions is available to be paid immediately. Participant account balances that are comprised of employer contributions that are vested are available to be paid six months after termination of employment, unless retirement age, death or disability occur prior to the six-month waiting period ends. A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested balance in his or her account, or annual or more frequent installments over a specified period.

### Hardship Withdrawals -

Hardship withdrawals from the Plan are permitted from fully vested accounts.

### Forfeitures -

Any forfeitures arising under the Plan are applied against future employer contributions to the Plan or employer administrative expenses related to the Plan. Prevailing wage rate contributions are non-forfeitable. At December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$798 and \$0, respectively. Forfeitures totaled \$10,666 and \$2,763 during 2024 and 2023, respectively, and were used to reduce employer contributions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting -

The financial statements of the Plan are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States ("GAAP").

### Investment Valuation and Income Recognition -

The Plan's investments are stated at fair value based upon quoted market prices, as determined by the Custodians of the Plan's assets. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

The change in fair value of investments and realized gains (losses) are reflected in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

### Contribution Receivable -

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### Benefit Payments -

Benefit payments are recorded when paid.

### Fair Value of Financial Instruments -

Accounting principles generally accepted in the United States of America establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

All of the Plan's investments are valued utilizing level 1 inputs.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the level 2 input must be observable for substantially the full term of the asset or liability.

The Plan does not have any investments that are valued utilizing level 2 inputs.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value of Financial Instruments (Continued) -

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan does not have any investments that are valued utilizing level 3 inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Pooled separate accounts* - Valued at the net asset value ("NAV") of the underlying shares held by the Plan at year-end.

*Common collective trust funds* - Valued at the net asset value ("NAV") of the underlying shares held by the Plan at year-end.

*Mutual funds* - Stated at fair value based on quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Excess Contributions Due to Participants -

The amount that highly compensated participants can contribute to the Plan is limited by the amount contributed by non-highly compensated participants. Excess contributions due to participants represent amounts contributed in excess of those limits. These amounts are required to be returned to those participants within two and one-half months of the end of the applicable plan year. Excess contributions due to participants are included in Plan liabilities on the statement of net assets available for benefits. As of December 31, 2024 and 2023, there were no excess contributions due to participants.

### Income Taxes -

The Plan sponsor is responsible for determining whether a tax position of the Plan is more likely than not to be sustained upon examination by the applicable taxing authority, based on the technical merits of the position. As of December 31, 2024 and 2023, the Plan has not recorded any provisions for accrued interest and penalties related to uncertain tax positions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Estimates -

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates. Significant estimates within these financial statements include the fair value measurements of Plan assets.

### Risks and Uncertainties -

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Events Occurring After Reporting Date -

The Plan has evaluated events and transactions that occurred between December 31, 2024 and August 26, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

## 3. FAIR VALUE MEASUREMENTS

#### **4. CERTIFIED INVESTMENT INFORMATION**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodians have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes as of December 31, 2024, as shown on Schedule I.

#### **5. TAX STATUS**

The IRS has determined and informed the Plan sponsor by a letter dated August 19, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

#### **6. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their account balances.

#### **7. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held in pooled separate accounts and common collective trust funds managed by the Custodians. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services and other administrative services amounted to \$49,502 and \$40,036 for the years ended December 31, 2024 and 2023, respectively.

## 8. RESTATEMENT

During 2025, the Company decided to update the company's discretionary match contribution from 75% to 98% match on up to 6% of an employee's elective deferral for the Plan year ended December 31, 2024. An adjustment to the 2024 financial statements was made to increase the employer contributions receivable and employer contributions, thereby increasing net assets of the Plan in the amount of \$145,320 for the year ended December 31, 2024 as shown below:
