### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Stephenson National Bank & Trust Employee's Retirement Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Stephenson National Bank & Trust Employee's Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

## Note 1 - Description of Plan

The following brief description of The Stephenson National Bank & Trust (Company) Employee's Retirement Savings Plan (Plan) is provided for general purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

### General

The Plan is a safe harbor 401(k) defined contribution plan using a qualified automatic contribution arrangement (QACA) covering substantially all full-time employees of the Company, upon hire, who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company.

### Contributions

Each year, participants may contribute between 1% and 100% of pre-tax annual compensation as defined in the Plan not to exceed the maximum amount allowable by the Internal Revenue Code. Participants may also elect to make Roth deferral contributions. Participants who have attained age 50 before the end of the calendar year, are eligible to make catch-up contributions to the Plan for that year. Participants may also contribute amounts representing distributions from other qualified plans and certain IRAs (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic deferral feature, and accordingly, the plan sponsor will automatically withhold 10% of newly hired participants' compensation and contribute that amount to the Plan as a pre-tax 401(k) deferral unless the participants elect not to defer or enter into a salary reduction agreement with an alternative percentage of withholding.

In addition, employees who are age 21 or older and have completed one month of service are eligible to receive certain Company contributions as well. The Company has a discretionary matching contribution that amounts to 25% of the first 6% of base compensation that a participant contributes to the Plan and is paid bi-weekly. An additional annual discretionary profit sharing contribution may be made at the option of the board of directors for those participants who are employed on the last day of the Plan year. The discretionary employer match and profit sharing contributions were \$443,872 and \$494,607 for the years ended December 31, 2024 and 2023, respectively. All Company contributions are invested directly into the same investment options as directed by the participants. Contributions are subject to certain IRS limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company contributions, as applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and individual accounts are also charged directly for loan processing fees. Allocations are based on participant compensation or account balance, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their voluntary and rollover contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service for their accounts that contain employer discretionary matching and profit sharing contributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, except in the case of a home loan in which the maximum repayment period is ten years. The loans are secured by the balance in the participant's account and new loans bear interest at a rate of prime plus 2%. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of Benefits**

Prior to termination of employment, participants may elect to receive an in-service distribution from their accounts which are 100% vested and are subject to possible administrative limitations and other restrictions. In addition, hardship distributions are also available from pre-tax deferral and Roth deferral accounts, excluding earnings, if certain conditions are satisfied.

On termination of service due to death, disability, or retirement, a participant (or beneficiary in the case of death) may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or delay the distribution until age 73, if the account exceeds \$5,000. For termination of services for other reasons, a participant will receive the value of the vested interest in his or her account as a lump sum distribution. Participant balances that are less than \$1,000 are required to be paid via a lump sum distribution.

**Forfeited Accounts**

The Plan provides that upon a participant's termination, the participant's non-vested interest in their account is forfeited when the participant receives a distribution of the entire vested interest. Forfeitures are used to reduce the Company's discretionary profit sharing contribution, nonelective contributions and plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,369 and \$2,526, respectively. There were reductions in the Company's matching contributions from forfeited non-vested accounts of \$2,526 and \$2,616 for the years ended December 31, 2024 and 2023, respectively.

**Note 2 - Summary of Significant Accounting Policies**

This summary of significant accounting policies of The Stephenson National Bank & Trust Employee's Retirement Savings Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to generally accepted accounting principles.

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's pension committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document and the loan policy. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Participant loan fees charged by the service provider are charged directly to the individual participant's accounts and are included in administrative expenses. Investment related expenses, such as brokerage commissions, and third party service provider fees are included in net appreciation of the fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data correlation or other means,
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Pooled separate account contracts with an insurance company are valued at the net asset value (NAV) readily determinable fair value since it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily, which is why the custodian values these as level 2 investments.

**Note 4 - Guaranteed Investment Contract**

The Plan holds a fully benefit-responsive guaranteed investment contract with VOYA Retirement Insurance and Annuity Company totaling \$684,271 and \$1,833,112 at December 31, 2024 and 2023. VOYA maintains the contributions in a general account. The account is credited with earnings of the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VOYA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**Note 5 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**Note 6 - Related Party and Party-in-Interest Transactions**

Certain Plan investments are shares of funds and investment contracts managed by VOYA Retirement Insurance and Annuity Company. VOYA Retirement Insurance and Annuity Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to VOYA Retirement Insurance and Annuity Company, and other administrative services amounted to \$4,400 and \$15,892 for the years ended December 31, 2024 and 2023, respectively, and are included under administrative expenses on the statements of changes in net assets available for benefits. Certain employees and officers of the plan sponsor, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

VOYA Retirement Insurance and Annuity Company provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and VOYA Retirement Insurance and Annuity Company. VOYA Retirement Insurance and Annuity Company receives revenue from fund service providers for services VOYA Retirement Insurance and Annuity Company provides to the funds. This revenue is used to offset certain amounts owed to VOYA Retirement Insurance and Annuity Company for its administrative services to the Plan.

If the revenue received by VOYA Retirement Insurance and Annuity Company from such fund service providers exceeds the amount owed under the MSA, VOYA Retirement Insurance and Annuity Company remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or plan sponsor may make a payment to VOYA Retirement Insurance and Annuity Company for administrative expenses not covered by revenue sharing.

**Note 7 - Information Certified by the Plan's Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by VOYA Retirement Insurance and Annuity Company.

**Note 8 - Income Taxes**

The Company restated the Plan, effective January 1, 2022, and adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement that received a favorable determination letter from the Internal Revenue Service on June 30, 2020 which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code Section 401(a) and, therefore, the related trust is tax-exempt. The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9 - Risks and Uncertainties**

The Plan invests in various investment securities through pooled separate accounts and a fully benefit-responsive investment contract. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
