## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Columbia Eye Clinic, P.A. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor’s Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental Schedule H, Part IV, line 4i – Schedule of Assets (Held at End of Year) at December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such

information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1. Description of the Plan:**

The following description of the Columbia Eye Clinic, P.A. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan covering substantially all employees of Columbia Eye Clinic, P.A. and Columbia Eye Surgery Center, Inc. (collectively, the “Company”). The current Plan document and related provisions were adopted by the Company’s Board of Directors and became effective January 1, 1997. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective January 1, 2002, the Plan was amended to incorporate certain provisions of the General Agreement of Tariffs and Trade, the Uniform Services Employment and Reemployment Rights Act, the Small Business Job Protection Act, the Taxpayer Relief Act of 1997, the Internal Revenue Restructuring and Reform Act of 1998, the Community Renewal Tax Relief Act of 2000, and the Economic Growth and Tax Relief Reconciliation Act of 2001.

The Plan is considered to be a “safe harbor 401(k) plan.” As a result, for Plan years beginning on and after January 1, 2003, a nonelective contribution equal to 3% of compensation for the Plan year will be made for each participant starting on the first payroll date following initial employment.

**Contributions** – Employees are eligible to make salary reduction contributions to the Plan on the earlier of the first day of the Plan year or the first day of the seventh month of the Plan year. The Plan year begins on January 1st and ends on December 31st. Plan participants may elect to make cash contributions to the Plan in amounts up to 50% of eligible compensation. Deferred cash contributions are not subject to income taxation until distributed to participants. No participant, however, may make deferred cash contributions in excess of amounts determined by the Secretary of the Treasury. The Company matches 50% of the participating employee’s contributions up to 6% of their gross earnings. Participants may choose to invest contributions in one or more money market funds or mutual funds, which invest in domestic or international equity securities or debt instruments. Income generated from the investments is reinvested in the participants’ accounts.

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution, rollover contributions and allocations of (a) the Company’s matching and safe harbor contributions and (b) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participant contributions and safe harbor contributions made by the employer are fully vested and nonforfeitable at all times. Employer nonelective contributions are fully vested after three years from the date of initial employment and are forfeitable if a participant terminates employment before the end of three years of service. Forfeited employer contributions reduce future employer contributions.

**Payment of Benefits** – Benefits are recorded when paid. Subject to certain conditions, a participant may make withdrawals from his or her vested account balance in the Plan while employed. Upon termination of employment for any reason other than retirement (including disability or death), the total value of the account is distributed to the participant or the participant’s beneficiary. In the case of retirement, the participant may choose from one of the Plan’s distribution alternatives.

**Forfeitures** – At December 31, 2024 and 2023, forfeited non-vested accounts were approximately \$100 and \$4,000, respectively. Forfeitures by non-vested participants are used to reduce future Company contributions. During 2024 and 2023, \$25,688 and \$20,000 forfeited non-vested accounts were used to reduce Company contributions, respectively.

In the event that participants do not deposit distribution checks received upon termination within 180 days, the checks are redeposited into the Plan’s forfeiture account. Approximately \$12,000 and \$0 of uncashed checks were deposited, and approximately \$3,000 and \$0 of uncashed checks were reissued during 2024 and 2023, respectively.

**Notes Receivable from Participants** – A participant may borrow from the Plan, subject to the approval of the Plan administrator, up to the lesser of \$50,000 or 50% of the participant’s vested amount in the Plan. The loans are secured by the balance in the participant’s account and principal and interest is paid ratably through payroll deductions. Current interest rates on loans are between 4.25% – 9.5%. Interest income is recorded on an accrual basis.

**Funding** – The Company’s policy is to fund the Company’s match of participant deferrals within the Department of Labor required timeframes.

### Note 2. Summary of Significant Accounting Policies

**Basis of Accounting** – The accompanying financial statements have been prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of Estimates** – The preparation of the Plan’s financial statements in conformity with GAAP requires that the Plan administrator make estimates and use assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates. The Plan administrator is not aware of any condition or event that is likely to materially affect its estimates in the near-term. The most significant estimate impacting the financial statements is the fair value of investments.

**Investment Valuation and Income Recognition** – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

**Notes Receivable from Participants** – The notes receivable are measured at their unpaid principal balance and are considered delinquent and written off as a deemed distribution when payment is 90 days past due. The Plan does not charge late fees on delinquent accounts.

No allowance for loss on notes receivable from participants is provided based on the loans being secured by the participants' balance, as stated previously.

**Payment of Benefits** – Benefits are recorded when paid.

**Administrative Expenses** – Certain administrative costs of the Plan, including accounting fees, are paid by the Company and, as such, are not an expense of the Plan.

### Note 3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividends, and interest on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- investment information included in the schedule H, part IV, line 4i – schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 4. Fair Value Measurements

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated by \$1,737,954.

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

*Money market funds:* Valued at quoted market rate.

*Mutual funds:* Mutual funds represent investments with various investment managers. The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission.

These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5. Related Party and Party-In-Interest Transactions**

Certain Plan investments (money market funds and shares of mutual funds) are managed by the Trustee and therefore qualify these transactions as party-in-interest transactions. We note that additional fees to the investment custodian are netted against investment returns. Fees paid by the Plan for the investment management services amounted to \$9,260 for the year ended December 31, 2024.

### **Note 6. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### **Note 7. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### **Note 8. Tax Status**

The Internal Revenue Service has determined and informed the Company by letter dated July 16, 1986, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **Note 9. Subsequent Events**

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of December 31, 2024, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through September 2, 2025, the date these financial statements were available to be issued, and there were no events that required disclosure in these financial statements.
