### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of ZRT Laboratory 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the ZRT Laboratory 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of ZRT Laboratory, LLC (the Company), who meet the eligibility requirements, with the exception of leased employees and nonresident aliens. Employees are eligible to participate in the Plan after completing one month of service and attaining 18 years of age. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, (ERISA).

**Contributions** - Contributions consist of employee elective deferrals, safe harbor nonelective employer contributions, employer matching contributions and discretionary employer nonelective contributions. Employee elective deferrals and employer contributions are recorded in the year in which the employee contributions are withheld from compensation. Employees may voluntarily contribute up to 100% of their compensation, limited to \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants ages 50 and older may elect to make additional catch-up contributions of \$7,500 annually. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company makes safe harbor nonelective employer contributions in an amount equal to 3% of all eligible employees' compensation, as well as employer matching contributions of 100% of the participant's deferral contributions up to a maximum of 3% of the participant's eligible compensation. There were no discretionary employer nonelective contributions made in 2024 or 2023. In addition, contributions are subject to other limits under the IRC.

**Participant Accounts** - A separate account is maintained for each participant, which is credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings and administrative expenses. Allocation of Plan earnings and administrative expenses is based upon participant account balances. Allocation of safe harbor nonelective employer contributions, employer matching contributions and discretionary employer nonelective contributions is based on a percentage of each employee's elective deferral. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions and safe harbor nonelective employer contributions plus actual earnings thereon. Participants are vested in employer matching contributions and discretionary employer nonelective contributions plus actual earnings thereon after three years of credited service. Participants vest immediately in all contributions plus actual earnings when they reach normal retirement age or in the event of the participant's death or permanent disability.

**Payment of Benefits** - Upon termination of service due to death, disability, retirement or for other reasons, a participant may be paid as a lump sum amount equal to the participant's vested account balance or as a partial withdrawal, provided the minimum withdrawal is \$1,000 or more. The Plan provides for hardship distributions which are available only for the purpose of meeting immediate and heavy financial needs. Account balances that are under \$7,000 may be automatically rolled over to an IRA at the discretion of the Company. An employee who has attained age 59½ may elect an in-service payment withdrawal of any portion of his or her vested account balance.

**Expenses** - Certain administrative expenses may be paid by the Company. Expenses not paid by the Company are deducted from participants' accounts. In addition, certain expenses of plan administration, including computer services, professional fees, office supplies, and payroll expenses of administrative and clerical personnel, are provided by the Company without charge to the Plan. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

**Forfeitures** - Forfeitures may be used to pay administrative expenses of the Plan or to reduce discretionary employer matching contributions or discretionary employer nonelective contributions. Forfeited accounts were \$8,181 and \$6 at December 31, 2024 and 2023, respectively. Forfeitures of \$5,651 and \$7,299 were used to reduce employer contributions in the year ended December 31, 2024 and 2023, respectively.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for benefit-responsive investment contracts, which are carried at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Subsequent Events** - The Plan's management has performed an evaluation of subsequent events through September 9, 2025, which is the date these financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC No. 820 are described as follows:

#### **Basis of Fair Value Measurement**

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate account ("PSA")*: The Plan holds a group annuity contract issued by Standard Insurance Company. The contract allows the Plan to participate in a pooled separate account, which holds underlying investments. The PSA invests in a portfolio of securities. The PSA is valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities). While the majority of the PSA's underlying asset value is based on quoted prices, the net asset value ("NAV") of the pooled separate account is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices and is used as a practical expedient to estimate fair value. The PSA held by the Plan provide for daily redemptions by the Plan at reported NAV. The Plan is permitted to redeem investment units at NAV on the measurement date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 4 – GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE COMPANY**

The Plan has entered into a traditional fully benefit-responsive, group annuity contract with Standard Insurance Company (“Issuer”). The Issuer maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of a contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the Issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Contract value is the relevant measurement attributable for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by the Issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The Plan’s ability to receive amounts due is dependent on the Issuer’s ability to meet its financial obligations. The Issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the Issuer. Such events include, but are not limited to layoffs, Plan termination, business closings, re-organizations, liquidations and the failure of the Plan to qualify under Section 401(a) or Section 401(k) of the IRC. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the Issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an unsecured violations of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment of the agreement without the consent of the Issuer.

The group annuity contract does not permit the Issuer to terminate the agreement prior to the scheduled maturity date. The average yield was 3.03% for the years ended December 31, 2024 and 2023, respectively. On a quarterly basis, Standard Insurance Company declares a crediting rate for financial activity in the coming quarter.

#### **NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan makes loans to participants up to the lesser of 50% of their vested account balance or \$50,000 subject to a \$500 minimum. Loans are payable within five years through semi-monthly payroll deductions unless the loan is used to acquire a primary residence. Interest is charged based on a reasonable rate of interest as determined by the plan administrator. As of December 31, 2024, the rate of interest on outstanding loans ranged from 3.25% to 8.50%, maturing through June 2033. Loans are secured by the vested account balance of the participant.

#### **NOTE 6 – INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule, Schedule H, Line 4i – Schedule of Assets Held (At End of Year), that was certified by the custodian of the Plan, Standard Insurance Company, and furnished to the Plan administrator. The Plan administrator has obtained certification from the custodian that such information is complete and accurate as of and for the year ended December 31, 2024 and 2023 as follows:

#### **NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include shares of a pooled separate account and group annuity contract that are managed by Standard Insurance Company. Standard Insurance Company is the custodian of the Plan; therefore, these transactions are party-in-interest transactions. Fees for investment management services for the pooled separate account and group annuity contract managed by an affiliate of Standard Insurance Company are charged by the custodian, or an affiliate of the custodian, at rates ranging from 0.19% to 0.44%, which totaled \$54,996 and \$63,310, for the years ended December 31, 2024 and 2023, respectively, and are netted against Plan earnings. Fees paid by the Plan for administrative services were \$2,630 and \$2,482 for the year ended December 31, 2024 and 2023, respectively.

#### **NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants become 100% vested in their accounts.

#### **NOTE 9 – TAX STATUS**

The Plan document is a Non-Standardized Pre-Approved Profit-Sharing Plan sponsored by Standard Retirement Plan Services, Inc. and obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the opinion letter was issued, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (“IRS”). The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **NOTE 10 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits. There were two investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023. See the Supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.
