We have performed audits of the financial statements of Katten Muchin Rosenman LLP Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Katten Muchin Rosenman LLP Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan maintained for the benefit of eligible employees (as defined), and partners, and employees of affiliated entities (as defined) (collectively, participants). The Plan was established effective January 1, 1987, and conforms to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions and Vesting

The Plan provides for the following contributions:

1. Integrated Contributions Account – Base contributions and excess contributions made by Katten Muchin Rosenman LLP (the Firm or Plan Sponsor) or affiliated entities in amounts determined by the Executive Office of the Firm, subject to the maximum allowed Internal Revenue Service (IRS) compensation for each Plan year and are limited to the maximum amounts deductible for income tax purposes. The Integrated Contribution cannot be less than 7.5% of each eligible participant's compensation for Plan year 2024.

Employer contributions are allocated as of the last day of the Plan year to eligible participants accounts on the basis of compensation, subject to certain limitations.

2. Profit Sharing Contributions Account – Profit Sharing contributions by the Firm or affiliated entities are equal to 7.5% of each eligible participant's compensation for Plan year 2024 (as determined by the Executive Office of the Firm), subject to the maximum allowed IRS compensation for each Plan year, and are limited to the maximum amount deductible for income tax purposes.

Employer contributions are allocated as of the last day of the Plan year to eligible participants accounts on the basis of compensation, subject to certain limitations.

3. Pretax Contributions and Pretax Catch-up Contributions Account - Contributions made at the direction of the participants (in amounts between 1% and 50% of compensation) and which amounts are deducted from the participant's direct compensation and excluded from the participant's reportable wages or taxable income. Participants are automatically enrolled to defer 6% of compensation by the 60th day after the employee first becomes an Eligible Employee. There is an automatic increase each April 1 of 1% of compensation, until the participant's annual deferral percentage reaches 15%.

4. Rollover Contributions Account - Contributions made by participants from amounts received from any other qualified plan, subject to the provisions of applicable tax law.

5. Roth Contributions and Roth Catch-up Contributions Account - Contributions made at the direction of the participants (in amounts between 1% and 50% of compensation) and which amounts are deducted from the participant's direct compensation after taxes have been withheld from compensation.

6. Special Contributions Account - Contributions made by the Firm, if necessary, on behalf of non-highly compensated participants for Plan qualification purposes. No such contributions were made for 2024.

For 2024, the aggregate annual amount of pretax and/or Roth contributions is limited to \$23,000, plus catch-up contributions, which is limited to \$7,500.

Participants may direct their account balances to any of the investment options offered by the Plan. Participants are vested immediately in their contributions, employer contributions and actual earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (1) the employer's contributions and (2) Plan earnings (losses). Investment income (loss), including appreciation or depreciation in the fair value of investments, is allocated to the Plan and accounts of active participants and terminated participants (who had undistributed account balances) as of each valuation date.

Benefit Payments

Benefits are generally payable to participants or their beneficiaries upon death, retirement, termination of employment or by determination that a financial hardship, as defined (for pretax contributions as well as Roth contributions), has been incurred. Active participants that have attained age 59½ may elect to withdraw any portion of their accounts.

At December 31, 2024 and 2023, there were no participants that had unfulfilled requests for payments of benefits.

Plan Administration

The Plan has appointed the Qualified Plan Administration and Investment Committee (the QPAIC) to administer the Plan pursuant to the terms and conditions of the Plan. Partners or employees of the Plan Sponsor serve as members of the QPAIC. No such partners or employees received compensation from the Plan for performing such services.

Notes Receivable from Participants

Participants may borrow from their accounts a maximum of 50% of the value of their accounts or \$50,000 reduced by the highest outstanding balance of any loans previously made by the Plan during the one-year period ending on the day before the origination of the loan, whichever is less. The maximum repayment period for any loan is five years. The loans are collateralized by the balance in the participant's account and bear a rate of interest that is determined by the Plan Administrator based on prevailing market conditions and is fixed over the life of the loan. This rate is 1% above prime as published in *The Wall Street Journal* at the time of loan request. Principal and interest are paid ratably through payroll deductions. Participants may have only two loans outstanding at a time.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value as determined by the trustee of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative processing fees (i.e., loans and benefit payments) are paid from the participants' accounts. Other administrative expenses are paid either by the Plan or the Plan Sponsor.

NOTE C - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board has issued guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for similar assets or liabilities in active markets that the Plan has ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs; however, the determination of what constitutes observable data requires judgment by the Plan's management. Plan management considers observable data to be market data that is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by multiple independent sources that are actively involved in the relevant market. The categorization of an investment within the fair value hierarchy is based on the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts - Valued at the NAV provided by the administrator of the fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV's unit price is quoted on a private market that is not active. Investments may be redeemed daily and there are no restrictions or unfunded commitments. These investments file as a direct filing entities.

Cash and cash equivalents (Self-directed accounts) - Recorded at cost, which approximates fair value.

Government, municipal and corporate bonds (Self-directed accounts) - Valued at the closing price reported in the market in which the individual securities are traded.

Common and preferred stock (Self-directed accounts) - Valued at the closing price reported on the active market on which the individual securities are traded.

Unit investment trusts (Self-directed accounts) - Valued at the closing price reported on the active market on which they are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Firm reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the assets of the Plan would be distributed in accordance with priorities established by Section 4044 of ERISA.

NOTE F - PARTY-IN-INTEREST AND NON-EXEMPT TRANSACTIONS

There are some investments in the self-directed investment accounts that are managed by Charles Schwab Trust Company N.A. (Schwab), the trustee; therefore, transactions in these investments are considered party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

NOTE G - TAX STATUS

The IRS has determined and informed the Firm by a letter dated October 14, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE I - SUBSEQUENT EVENTS
